### 1. DESCRIPTION OF PLAN:

The following description of the Forbo Siegling, LLC Retirement Plan and Trust ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of Forbo Siegling, LLC ("the Company") who meet the age and service requirements of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Company. Great-West Life & Annuity Insurance Company (d/b/a Empower Retirement) ("Custodian") serves as the custodian of the Plan.

#### **Contributions**

The Company makes periodic discretionary contributions. No minimum contribution is required. Participants' contributions are not permitted, except for rollover contributions representing distributions from other qualified plans.

#### **Investment Options**

Participants direct the investment of the contributions allocated to their accounts into various investment options offered by the Plan.

#### **Participant Accounts**

Each participant's account is credited with an allocation of the Company's contribution and Plan earnings, and is charged with an allocation of administrative and fund expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are always 100 percent vested in the rollover portion of their account. Vesting in the Company's contribution account is based on years of service. A participant is 100 percent vested after six years of credited service.

### 1. DESCRIPTION OF PLAN: (Continued)

#### Notes Receivable from Participants

Under the terms of the Plan, participants may borrow from their account up to fifty percent of their vested balance with a minimum of \$1,000 and a maximum of \$50,000. The loans are secured by the balance in the participant's account and bear interest rates commensurate with local prevailing rates as determined by the plan administrator. The rates range from 4.25 percent to 9.50 percent on loans outstanding at December 31, 2023, and mature through 2028. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

Benefits are paid upon retirement, death, disability, or termination of employment. On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in the account or installments, which may not exceed life expectancy.

#### Forfeited Accounts

Forfeitures of the non-vested portion of terminated participants' accounts may be used to pay the administrative costs of the Plan. Any remaining forfeitures are added to the employer's contribution and allocated to eligible participants. At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$59,443 and \$17,308, respectively. Forfeitures of \$17,404 and \$18,245 were allocated as additional employer contributions in plan years ending December 31, 2023 and 2022, respectively.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value except for fully benefit responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Contributions**

Employer contributions are recorded in the period in which they are approved by the Company.

**Payment of Benefits**

Benefits are recorded when paid.

#### Expenses

Certain expenses relating to maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees relating to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

#### Subsequent Events

The Company has evaluated events from December 31, 2023 through April 14, 2025, which is the date that the financial statements were available to be issued.

### 3. INFORMATION CERTIFIED BY CUSTODIAN: (Unaudited)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Custodian, Great-West Life & Annuity Insurance Company, as complete and accurate except for comparing such information certified by the Custodian, Great-West Life & Annuity Insurance Company, to information included in the Plan's financial statements and supplemental schedule.

### 4. FAIR VALUE MEASUREMENTS:

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements.) The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. GROUP ANNUITY CONTRACT WITH NATIONAL INSURANCE COMPANY:

In 2008, the Plan entered into a fully benefit-responsive investment contract with Great-West Life & Annuity Insurance Company. Great-West Life & Annuity Insurance Company maintains the contributions in a general account. The Key Guaranteed Portfolio Fund (the Group Annuity Contract) is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The contract is included in the financial statements at contract value as reported by Great-West. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The guaranteed rate provision covers the range of insurance expenses that are netted to create the crediting rate. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. The crediting rate is reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on third party issuer's ability to meet financial obligations. The issuer's ability to meet contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include 1) amendments to the plan documents (including complete or partial plan terminations or mergers) 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the plan sponsor or other plan sponsor events (like divestitures or spin-offs) that cause a significant withdrawal from the Plan or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. At December 31, 2023 and 2022, the trustee of the fund did not believe that the occurrence of any fair value event, which would limit the fund's ability to transact at contract value with participants, is probable of occurring.

The guaranteed investment contract does not permit the bank to terminate the agreement prior to the scheduled maturity date.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value.

**6. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**7. PARTY-IN-INTEREST TRANSACTIONS:**

The Custodian, Great-West Life & Annuity Insurance Company (GWLAIC), provides various mutual funds and a group annuity contract as investments options. Participants are directly charged by GWLAIC for recordkeeping services such as loan and distribution processing and other asset-based management commission fees. Recordkeeping fees directly paid by participants reported by GWLAIC were \$2,650 and \$2,513 for the years ending December 31, 2023 and 2022, respectively. Additional recordkeeping fees paid to GWLAIC on the Sch C of the Form 5500 were \$3500 and \$1900 for the years ending December 31, 2023 and 2022, respectively. Contract administrative fees of \$3,600 and \$3,800 were reported by Creative Plan Designs, LTD for the years ending December 31, 2023 and 2022, respectively which were part of each participant's distribution or new loan payment. Investment broker/advisors are paid indirectly by the funds themselves. GWLAIC reported that these brokers were paid \$26,347 (Massachusetts Mutual Life Insurance Company) and \$28,404 (Massachusetts Mutual Life Insurance Company) for the years then ending December 31, 2023 and 2022, respectively. These indirect broker fees are netted in the earnings of the investment income as required by generally accepted accounting principles.

**8. PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

### 9. INCOME TAX STATUS:

The Plan was restated July 1, 2022 the CCH Incorporated DBA FTWilliam.com Non-Standardized Pre-Approved Profit Sharing Plan with CODA and obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore, believe the Plan is qualified, and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service and the North Carolina Department of Revenue. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
