Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

Notes to Financial Statements

July 01, 2024

1. Description of the Plan

The following description of the ColCal Colorado, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan available to eligible employees of ColCal Colorado, Inc. (the Employer) who had twelve months of eligible service in which they completed 1,000 hours and were age 21 or older. Effective July 1, 2024, the Employer elected to merge the Plan into the Insight Retirement Pooled Employer Plan (PEP). The Plan transferred its net assets to the PEP administered by Standard Retirement Services, Inc., the Pooled Plan Provider, and ceased operations. The accompanying financial statements are for the six-month period ended July 1, 2024. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer was responsible for the administration of the Plan and entrusted the maintenance of records and the day-to-day administration to TAG Resources (TAG) who processed transactions through Transamerica Financial Life Insurance Company (Transamerica), the custodian.

Contributions

Each year, participants could contribute up to 90% of their pre-tax annual compensation, as defined in the Plan. In addition, participants who had attained the age of 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. Participants could change the investment options previously elected at any time.

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate. Automatically enrolled participants had their deferral rate set at 4% of eligible compensation, increasing after one year to 5%, after two years to 6% and after three years to 8%.

The Employer made QACA safe harbor matching contributions to the Plan equal to 100% of the employee's elective deferral up to 4% of compensation. The Employer could also make discretionary nonelective and qualified nonelective contributions to the Plan. During 2024, the Employer did not make any discretionary contributions. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

1. Description of the Plan (continued)

Participant Accounts

Each participant's account was credited with the participant's contributions, the Employer's QACA safe harbor matching contributions, discretionary nonelective and qualified nonelective contributions and Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their voluntary contributions and discretionary qualified nonelective contributions plus actual earnings on these contributions. Vesting in the Employer's QACA safe harbor matching contribution portion of their accounts plus related earnings thereon was based on years of vesting service in which the participants complete 1,000 hours of service, as follows:

Payment of Benefits

On termination of service due to death, disability or early retirement, a participant could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants electing to receive benefits after the normal retirement age could choose either a lump-sum amount or annual installments. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution or roll over their account into another individual retirement account. The Plan permitted in-service and hardship withdrawals under certain conditions.

Forfeitures

Forfeitures were created when participants terminate employment before becoming entitled to their full benefits under the Plan and were considered nonparticipant-directed investments. Forfeitures could be used to pay administrative expenses and to reduce future Employer contributions. During 2024, employer contributions were reduced by \$3,136, from forfeited non-vested accounts. As of July 1, 2024 and December 31, 2023, forfeited non-vested accounts held in the stable value advantage account total \$-0- and \$8,353, respectively.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for its benefit-responsive investment contract, which is valued at contract value (Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for a discussion of fair value measurements.

2. Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Purchases and sales of securities were recorded on a trade date basis. Interest income was recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the period.

Contributions

Contributions from Plan participants and the QACA safe harbor matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Benefits Paid to Participants

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through April 29, 2025, the date the financials were available to be issued.

3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements, including investments held as of July 1, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest income from stable value advantage account and transfer to Insight Retirement Pooled Employer Plan for the period ended July 1, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan can access.
- Level 2 Inputs to the methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
 If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy for assets and liabilities is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of July 1, 2024 and December 31, 2023.

Pooled separate accounts: Valued at the net asset value (NAV) which equals the number of shares of the respective underlying fund, multiplied by the closing NAV per share quoted by that fund. The NAV is used as a practical expedient to estimate fair value.

5. Group Annuity Contract

The Plan invested in a fully benefit-responsive investment contract with Transamerica totaling \$8,552 as of December 31, 2023. Transamerica maintained the contributions in a general unallocated account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The effective rate of interest was established every January 1 and July 1 and was based on the daily balance, at a rate that was the daily equivalent of the effective annual rate of interest applicable for the six-month period. There was no guaranteed minimum or maximum interest rate under this contract, no unfunded commitments, and redemption frequency and notice period could occur daily.

The contract met the fully benefit-responsive investment criteria and therefore was reported at contract value. Contract value was the relevant measurement for fully benefit-responsive investment contracts, because it was the amount received by participants if they initiated permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

6. Related Party Transactions and Party-in-Interest Transactions

Plan investments were in accounts of Transamerica; therefore, these transactions qualified as party-in-interest transactions. Participant contributions were also considered to be party-in-interest transactions. Employer contributions were considered to be both party-in-interest and related party transactions.

7. Tax Status

The Plan adopted non-standardized pre-approved profit sharing plan which had received an opinion letter dated August 17, 2021, from the IRS which stated the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe the Plan was designed and was operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invested in various investment securities, which were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could occur in the near term, and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.
