Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of **Hartford Affiliated Employers Retirement Savings Plan FBO Gold Cross EMS, Inc.**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 18, 2023 and December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the period ended May 18, 2023 and for the year ended December 31, 2022, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

(1) Description of Plan

The following description of the Hartford Affiliated Employers Retirement Savings Plan FBO Gold Cross EMS, Inc.(the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Gold Cross EMS, Inc. (the Company). The Plan was established on December 1, 2011, the Company elected to participate in the Hartford Affiliated Employers Retirement Savings Plan, a “multiple employer” plan as described in Section 413(c) of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employees are eligible for participation once they have completed 30 days of service and have attained 21 years of age. Employees meeting these criteria are eligible for participation as of the next election date. Election dates are on a semi-yearly basis of the Plan year coinciding with or next following the date in which the Plan’s eligibility requirements are satisfied.

During 2022, the Company elected to participant in a multi-employer plan sponsored by Retirement Plan Services. Effective May 18, 2023, all participant accounts were transferred to Retirement Plan Services.

Contributions

Each year, participants may contribute pre-tax deferrals as a percent of annual compensation as defined in the Plan to the maximum allowed by the Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as permitted by law. Participants have the option to make Roth contributions to their accounts. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan does not include an auto-enrollment provision. Eligible employees must enroll if they wish to participate in the Plan. The Company does make safe harbor contributions to the Plan. The Company may, in its sole discretion, make a matching contribution on behalf of the participants in an amount determined by the Company. For the period of January 1, 2023 through May 18, 2023 and the year ended December 31, 2022, the Company did provide a matching contribution. The Sponsor may make discretionary matching contributions and qualified non-elective contributions to the Plan. Such a contribution, if made, will be allocated to each participant eligible in pro rata shares. The Sponsor did not make a discretionary contribution to the Plan for the period ended May 18, 2023 and the year ended December 31, 2022.

(1) Description of Plan (Continued)

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, the Company's contributions and qualified rollover contributions adjusted for gains and losses based on the investment performance of a participant's account, less any withdrawals, distributions, and allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, qualified non-elective contributions, and rollover contributions, plus actual earnings thereon. Vesting in the Sponsor's discretionary and matching contributions plus actual earnings thereon is based on years of continuous service. Participants become 100% vested in the Sponsor's discretionary and matching contributions upon reaching five years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. A participant may have only one outstanding loan at any time. Loan terms generally may not exceed five years. However, if the loan is used for the purchase of the principal residence of the participant, the Plan administrator may permit a longer repayment term. The loan interest rate will be determined by the Plan administrator in a nondiscriminatory manner. Scheduled principal and interest payments are to be made by payroll deduction.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reason, a participant or beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his/her account. A participant who is still employed by the Company and has attained age 59½ may make an election to withdraw all or a portion of his or her entire account balance. No such withdrawal shall be made more than twice during any calendar year.

Hardship Withdrawals

In the event funds are needed because of extreme financial hardship, as defined by the law, the participant may be allowed to make a withdrawal from his/her vested account balance from eligible accounts, as defined by the Plan. In accordance with the Internal Revenue Code (IRC), benefits withdrawn prior to age 59½ may be subject to additional taxes.

Forfeited Accounts

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits from employer contributions. These forfeited amounts will be held in a fixed account fund and may be used to reduce employer contributions or to pay administrative expenses. As of May 18, 2023, December 31, 2022 and 2021, forfeited nonvested amounts totaled \$-0-, \$5,714, and \$5,542, respectively. There were no forfeitures used to reduce employer contributions or pay plan expenses in 2023 and 2022.

(1) Description of Plan (Continued)

Investment Options and Investments

Participants direct the investment of all contributions into various investment options offered by the Plan. Participants may change their investment options at any time. As of December 31, 2022, the Plan offered diversified investments consisting of pooled separate accounts as investment options for participants.

(2) Summary of Significant Accounting Policies

The accounting policies of the Plan are maintained in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the *Accounting Standards Codification (ASC)* and related Accounting Standards Updates (ASUs). The following describes the more significant of those policies:

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee, and recordkeeper. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period and year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred.

No allowance for credit losses has been recorded as of December 31, 2021. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

(2) Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation in fair value of investments.

(3) Information Prepared and Certified by the Trustee (Unaudited)

Empower Retirement, the trustee of the Plan, as of May 18, 2023 and December 31, 2022, has certified the completeness and accuracy of the following data included in the accompanying financial statements.

- Investments, at fair value and notes receivable from participants as shown in the statement of net assets available for benefits as of May 18, 2023 and December 31, 2022.
- Net appreciation (depreciation) in fair value of investments, interest and dividend income, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period ended May 18, 2023 and year ended December 31, 2022.

Mass Mutual Life Insurance Company (Mass Mutual), the custodian of the Plan as of December 31, 2021, has certified to the completeness and accuracy of the following data included in the accompanying financial statements.

- Investments, at fair value and notes receivable from participants as shown in the statement of net assets available for benefits as of December 31, 2021.
- Net appreciation (depreciation) in fair value of investments, interest and dividend income, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2021.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

(4) Fair Value Measurements

The FASB issued a statement that defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 18, 2023 and December 31, 2022 and 2021.

Pooled Separate Accounts: Valued at fair value based on the net asset value (NAV) of the underlying assets. The value per share is equal to the number of shares of the respective underlying fund multiplied by the closing NAV per share quoted by that fund. The underlying funds consist primarily of mutual funds, exchange traded funds, and collective investment trusts. These investments were valued using net asset value (NAV) as a practical expedient.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(4) Fair Value Measurements (Continued)

The following table summarizes investments for which the fair value is measured using the NAV per unit practical expedient as of May 18, 2023 and December 31, 2022, and 2021. There are no participant redemption restrictions for these investments.

(5) Income Tax Status

The IRS has determined and informed the Plan prototype sponsor by a letter dated October 18, 2013, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (the “IRC”). The Plan Administrator has chosen to rely on the determination letter issued to the Plan prototype sponsor. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax and therefore, the Plan and related trust continue to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and concluded that, as of May 18, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Related-Party and Party-in-Interest Transactions

Certain Plan assets are investment options offered through the Plan trustee or affiliates; therefore, these transactions qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempted from the prohibition of party-in-interest transactions under ERISA. Administrative expenses on the statement of changes in net assets available for benefits include amounts paid by the Plan to the trustee, its affiliates and investment advisors for administrative services.

(7) Plan Termination

The Plan assets were transferred in May 2023 to a Multi-Employer Plan and the Plan was effectively terminated on May 18, 2023.

(8) Prohibited Transactions

During 2022 and 2023, the Plan sponsor failed to deposit \$74,677 and \$28,410 of participant deferrals within the required time frame as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions.

Prior to 2022, the Plan sponsor failed to deposit \$195,017 participant deferrals from prior years within the required time frame as stated by the DOL.

The Plan Sponsor has remitted the participant deferrals to the Plan and is in the process of correcting the contributions for the calculated lost earnings.

(9) Subsequent Events

Management has evaluated events subsequent to May 18, 2023 through April 30, 2024, the date these financial statements were available to be issued.



