Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have audited the accompanying financial statements of The Horton Group, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of November 20, 2024 (in Liquidation) and December 31, 2023 (Ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to November 20, 2024 (in Liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of November 20, 2024 (in Liquidation) and December 31, 2023 (Ongoing), and for the period from January 1, 2024 to November 20, 2024 (in Liquidation), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter

As discussed in Note 1 to the financial statements, the governing body of the Plan approved a Plan liquidation effective July 31, 2024, and management determined liquidation as imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Note 1—Description of the Plan

The following description of The Horton Group, Inc. (the “Company”) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all employees of the Company except union employees, leased employees, seasonal employees, interns, and consultants. Eligible employees may enter the Plan on a monthly basis after completing two months of service and attaining 19 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security act of 1974 (“ERISA”).

Effective July 31, 2024, the Company approved a plan of termination, and management determined that liquidation was imminent. Contributions to the Plan ceased effective July 31, 2024, and no new employees are eligible to participate in the Plan after July 31, 2024. Final distributions were based on all participants being 100% vested. The investments held by the Plan were to be liquidated and distributed to participants. As a result, the Plan changed its basis of accounting from the going concern basis used in the presentation of the 2023 financial statements to the liquidation basis used in presentation of the 2024 financial statements. All participant accounts were distributed by November 20, 2024.

Administration – The Company has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

Contributions – Each year, participants could contribute a percentage of pretax annual compensation, as defined in the Plan agreement. Participants had the option of contributing a percentage of their taxable compensation as a Roth or after-tax voluntary contribution. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions were subject to certain limitations as outlined in the Internal Revenue Code (“IRC”).

The Company may have made matching contributions on behalf of all active and terminated participants who made a pretax or Roth contribution to the Plan during the year, regardless of the amount of service the participant completed during the Plan year. The matching contribution is equal to 50% of a participant's deferral limited to 8% of eligible compensation, not to exceed \$4,000. The Company may also have made discretionary profit sharing contributions on behalf of participants who are employed on the last day of the Plan year. For the period from January 1, 2024 to November 20, 2024, the Company made matching contributions totaling \$772,494 and no profit sharing contributions.

Participant Accounts – Individual accounts were maintained for each Plan participant. Each participant's account was credited with the participant's contributions and allocations of the Company's contributions and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account.

Vesting – Participants were vested immediately in their contributions as well as the Company's matching and profit sharing contributions plus actual earnings thereon.

Investment Options – Upon enrollment in the Plan, participants may have directed the investment of their accounts into various investment options offered by the Plan. They could change their investment options among those investments provided at any time during the Plan year.

Note 1—Description of the Plan (continued)

Notes Receivable from Participants – Participants were permitted to borrow from their individual fund balances. Participant loans could be for any purpose, classified as either a general purpose or residential purpose loan (as defined in the Plan agreement), and were limited to the lesser of \$50,000 or 50% of the vested portion of the participant's account balance. The loan interest rate was set at 1% above the prime rate, as defined. For the period from January 1, 2024 to November 20, 2024, interest rates ranged from 4.25% to 9.50%. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may have elected to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments in accordance with the Plan agreement. For termination of service due to other reasons, a participant may have received the value of the vested interest in his or her account as a lump sum distribution. In-service and hardship withdrawals were also allowed as defined in the Plan agreement.

Note 2—Summary of significant accounting policies

Basis of Presentation – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). As discussed in Note 1, the Plan changed its basis of accounting from going concern basis used in the presentation of the 2023 financial statements to liquidation basis used in presentation of the 2024 financial statements.

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments were reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment Management Fees and Operating Expenses – Investment management fees and operating expenses charged to the Plan for certain investments were deducted from income earned on a daily basis and were not separately reflected. Consequently, management fees and operating expenses were reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were charged directly to the borrowing participant's account and were included in administrative expenses when incurred. No allowance for credit losses has been recorded as of November 20, 2024 and December 31, 2023. If a participant ceased to make loan repayments and the Plan administrator deemed the loan to be in default, the participant loan balance was reduced, and a benefit payment based was recorded.

Payment of Benefits – Benefits were recorded when paid. There were no benefit payments requested and not yet disbursed at November 20, 2024 and December 31, 2023.

Administrative Expenses – Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses.

Note 3—Information certified by the qualified institutions (unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, Newport Trust Company (as of December 31, 2023, and for the period from January 1, 2024 to April 23, 2024) and Fidelity Management Trust Company ("Fidelity MTC") (as of November 20, 2024, and for the period from April 24, 2024 to November 20, 2024), qualified institutions, have certified that the following information included in the financial statements is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of November 20, 2024 and December 31, 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the period from January 1, 2024 to November 20, 2024.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to the certified investment information, except for comparing such information to the related information included in the financial statements.

Note 4—Fair value measurements

U.S. GAAP provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4—Fair value measurements (continued)

The following are descriptions of the valuation methodologies used for investments measured at fair value, including the general classification of such investments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at November 20, 2024 and December 31, 2023.

Money Market and Mutual Funds – Valued at the daily closing price as reported by the fund. The money market and mutual funds held by the Plan were open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their net asset value and to transact at that price. The money market and mutual funds held by the Plan were deemed to be actively traded and are therefore classified within Level 1 of the valuation hierarchy.

Self-Directed Brokerage Accounts – Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices and therefore classified within Level 1 of the fair value hierarchy.

The preceding methods described may have produced a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5—Related party transactions and party-in-interest transactions

Certain administrative services were provided by the Company at no cost to the Plan and certain administrative costs incurred by the Plan were paid by the Company. The Plan entered into various service agreements with parties-in-interest. The Plan invested in a money market fund managed by Fidelity MTC, a trustee of the Plan. Notes receivable from participants and related activity also qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6—Plan termination

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

As noted in Note 1, effective July 31, 2024, the Company approved a plan of termination, and management determined that liquidation was imminent. Final distributions were based on all participants being 100% vested.

Note 7—Income tax status

The Internal Revenue Service (“IRS”) ruled on June 30, 2020, that the pre-approved plan of FMR LLC, the document sponsor of which the Plan is based, is designed in accordance with applicable sections of the IRC. The Plan administrator believes the Plan was designed, and was operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified and the related trust was tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 20, 2024 and December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Subsequent events

The Plan has evaluated all subsequent events through April 25, 2025, which is the date these financial statements were available to be issued and has determined there are no subsequent events that require disclosure.
