**NOTE 1 – DESCRIPTION OF PLAN**

Sabinal Administrative Services, LLC 401(k) Plan (the Plan) is a defined contribution 401(k) profit sharing plan adopted by Sabinal Administrative Services, LLC, (the Company), originally effective August 1, 2016. The Plan was amended and restated effective October 1, 2023. The Company maintains the Plan for the benefit of certain employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is administered by the Company.

The following description of the Plan provides only general information. Participants should refer to the legal plan document and trust agreement for a more complete description of the Plan's provisions.

Eligibility: Eligible employees can participate in the Plan when they have attained age 18. Employees may enter the Plan on the first day of the month coinciding with or next following the date they satisfy the age requirement.

Contributions: Participants may elect to reduce their compensation by a specific percentage or dollar amount and contribute to the Plan on a pre-tax basis as an elective deferral contribution (up to 100% of compensation), not to exceed the dollar limit set by law. The Plan also allows for elective deferral contributions to be made as Roth contributions. Participants who are age 50 or over may defer an additional amount, called a catch-up contribution. Participants may elect to start, increase, or reduce their elections to contribute to the Plan as soon as administratively feasible. Participants may suspend their elections at any time.

The Plan is a safe harbor 401(k) plan. In order to maintain safe harbor status, the Company will make a safe harbor matching contribution equal to 100% of the participants' salary deferrals that do not exceed 6% of their compensation. For 2024, the Company made safe harbor matching contributions totaling \$1,037,776.

Participants are also permitted to roll over amounts from other qualified plans, tax sheltered annuity plans, governmental 457 plans, and traditional individual retirement accounts (IRAs) as rollover contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions and (b) Plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Investment Options: Participants direct the investment of their entire interest in the Plan into various investment securities. The Plan currently offers mutual funds, and a collective trust fund as investment options for participants. Participants may redirect the investment of future contributions or reallocate or transfer existing balances among available investment securities at any time.

Vesting: Participants are always 100% vested in their elective deferral contributions, including Roth and catch-up contributions, rollover contributions and safe harbor contributions, plus actual Plan earnings thereon.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

**NOTE 1 – DESCRIPTION OF PLAN (Continued)**

Payment of Benefits: Upon termination of service before normal retirement age, a participant may elect to receive a single lump-sum payment in cash equal to the value of the participant's vested account balance, or to rollover the distribution directly to another qualified plan under section 401 of the Internal Revenue Code (IRC). If a participant's vested account balance does not exceed \$1,000 upon termination of employment, it will be automatically distributed regardless of whether a participant consents to receive it. Upon normal retirement, disability, or death, the participant or beneficiary is entitled to receive the amount credited to their account. Benefits may be paid to the participant in a single lump-sum payment in cash or a direct rollover to another qualified plan. If the participant or their beneficiary is required to take minimum distributions, benefits may be paid in a series of payments as required by the IRC.

Participants may take in-service distributions while still employed with the Company if they are age 59½ or older at the time of the distribution. If a participant has a financial hardship due to immediate and heavy financial need, they may also withdraw from their vested account.

Forfeited Accounts: If a participant's employment with the Company terminates, they receive a distribution of the entire vested portion of their account and they will forfeit the non-vested portion of the account. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, all participants become 100% vested. The Company will arrange for distributions upon Plan termination as soon as administratively feasible.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation.

Subsequent Events: The Plan has evaluated subsequent events through April 29, 2025, the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks resulting from global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)**

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

**NOTE 3 – CERTIFIED INVESTMENTS**

Certain information related to investments from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, and interest and dividends from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and Fidelity Management Trust Company.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1*: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2*: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3*: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust Funds: The fair values of participation units held in collective trusts are based on the NAVs per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported NAVs per share, with no advance notice requirement.

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values (NAV) reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption process that are determined by the fund's net NAV per share.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under the Department of Labor’s regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain plan investments are managed by the trustee and affiliates also reflect party-in-interest transactions.

**NOTE 6 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.
