### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements*

We have performed an audit of the financial statements of Renaissance Behavioral Health Systems, Inc. and Mental Health Resource Center, Inc. Tax Deferred Annuity Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by Variable Annuity Life Insurance Company, the trustee of the Plan, that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from Variable Annuity Life Insurance Company as of and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### *Opinion on the 2024 Financial Statements*

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section

- the amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion on the 2024 Financial Statements***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of Renaissance Behavioral Health Systems, Inc. and Mental Health Resource Center, Inc. Tax Deferred Annuity Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the 2024 Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. **1. Description of Plan**

The following description of the Renaissance Behavioral Health Systems, Inc. and Mental Health Resource Center, Inc. ("Company") Tax Deferred Annuity Savings Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all full-time employees of the Company who have completed at least one year of service with a minimum of 1,000 hours and are age twenty-one or older. The Company's management serves as administrator and the Plan's trustee is Variable Annuity Life Insurance Company (the "Trustee"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions**

Each year, participants may contribute up to 50% of pretax annual compensation, as defined in the Plan, but participants cannot exceed the maximum limits set by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefits or contributions plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and two general interest funds as investment options for participants.

Each year, the Company has the option to make a discretionary contribution that will be allocated to all eligible participants of the Plan. Participants must be actively employed on the last day of the Plan year in order to share in this contribution.

The Company makes matching contributions equal to 100% of the first 2% of eligible pay of a qualifying participant.

**Participant Account**

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The notes are secured by the balance in the participant's account and bear interest at rates at 1.00% to 4.0% currently, which are commensurate

with local prevailing rates. Principal and interest is paid ratably through monthly payroll deductions over a period not to exceed five years. Loans attached to a principal residence may have terms up to ten years.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or various annuity benefit options, as defined by the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

A participant must be 59 ½ to receive retirement distributions.

**Forfeited Accounts**

At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$90,515 and \$163,949, respectively. Forfeitures are being held in VALIC Guaranteed Interest Fixed Account Plus investment. The funds will be used to reduce future employer contributions or cover reasonable Plan expenses.

**Administrative Expenses**

Administrative fees, such as administrative service fees, and investment management fees are paid by the Plan, as allowed by the Plan document. All other expenses are paid by the Company. The Company also provides to the Plan certain accounting services for which no allocation of costs have been made to the Plan.

**2. Summary of Significant Accounting Policies**

**Date of Management's Review**

Subsequent events were evaluated through April 24, 2025, which is the date the financial statements were available to be issued.

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make significant estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Loans due from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan. Interest income from participant loans is recorded when it is earned.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Income Taxes**

The Plan is a qualified plan as described in Section 401(a) of the Internal Revenue Code and is therefore exempt from federal and state income taxes. Income generated by activities that would be considered unrelated to the Plan's purpose would be subject to tax, which, if incurred, would be recognized as current expense. No such tax has been recognized as of June 30, 2024.

The federal annual returns of the Plan for June 30, 2022 through June 30, 2024 are subject to examination by the IRS, generally three years after they were filed.

#### **4. Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain investments are measured at fair value using Net Asset Value (NAV) per share practical expedient and have not been categorized in a fair value hierarchy. The fair value amounts presented in the tables are intended to permit the reconciliation of the fair value hierarchy to the amounts presented in the Statement of Changes in Net Assets Available for Benefits.

The Plan used the NAV to determine the fair value of mutual funds, which (a) do not have a readily determinable fair value and (b) prepare their financial statements consistent with measurement principles of an investment company or have attributes of an investment company.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

#### Level 3 Fair Value Measurements

The Plan provides an investment option to invest in general account funds held with Corebridge Financial. The guaranteed interest accounts are not actively traded and significant other observable inputs are not available. Variable Annuity Life Insurance Company guarantees the principal and interest of the investment. Rates of interest are established periodically by Variable Annuity Life Insurance Company. The general account fund is presented in the financial statements at fair value.

#### **5. Related Party Transactions**

Certain Plan investments are shares of mutual funds managed by Variable Annuity Life Insurance Company. Variable Annuity Life Insurance Company is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The value of these mutual funds was \$6,540,013 and \$7,593,396 at June 30, 2024 and 2023, respectively. Fees paid by the Plan to Variable Annuity Life Insurance Company for investment management services in 2024 were \$14,822. The party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

The Company provided certain accounting, administrative, and investment management services to the Plan for which no fees are charged. Any other administrative fees will be paid by the Company on behalf of the Plan.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**7. Information Certified by the Plan's Trustee**

The investments included in the statements of net assets available for benefits as of June 30, 2024 and 2023, and the net appreciation in fair value of investments, interest and dividends included in the statement of changes in net assets available for benefits for the year ended June 30, 2024 have been derived from information certified as complete and accurate by Variable Annuity Life Insurance Company, trustee of the Plan, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**9. Contingencies**

ERISA requires that the Plan maintain continuous coverage under a fidelity bond, equal to the lesser of 10% of the funds handled or \$500,000. The Plan had sufficient coverage in place during the year, thus fulfilling ERISA's requirement.

**10. Year End Withdrawals**

There were no participants who left the Plan at June 30, 2024 that had requested distributions from their account balance.
