NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED JULY 31, 2024 AND 2023

NOTE A - DESCRIPTION OF PLAN

The following brief description of the IKG USA, LLC 401(k) Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC). The Plan was established on August 1, 2020, and covers all employees of IKG USA, LLC (the “Company”). Employees are eligible to participate in the Plan upon hire and are automatically enrolled in the Plan to contribute 3% of compensation on a pre-tax basis unless they affirmatively elect otherwise. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 100% of their compensation on a pre-tax or after-tax (Roth) basis, subject to the limits of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe harbor matching contribution each pay period equal to 100% of participant contributions up to 3% of compensation plus 50% of participant contributions from 3% of compensation up to 5% of compensation. For the Plan participants that are union members, the Company makes an additional matching contribution based on the collective bargaining agreement. The additional union matching contribution is equal to 50% of participant contributions up to 6% of compensation. The additional union matching contribution is calculated on a calendar year-end basis and is funded no later than March 31st of the subsequent year. The union participants must be actively employed on the date of payment to receive the additional union matching contribution. Participants direct the investment of their employer contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, employer contributions, and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions, their safe harbor matching contributions, the additional union matching contributions, if any, plus actual investment earnings thereon.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by any outstanding balance or by the highest outstanding balance in the past 12 months, or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Participants, or their beneficiaries, may receive the vested portion of their Plan account through distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Hardship distributions are permitted by the Plan. A participant may also request an in-service withdrawal from their vested account balance if the participant has attained age 59 ½. Benefit payments may be made in the form of a lump sum distribution, rollover contribution to another Plan, partial payment, annuity, or installments. Participants who terminate employment with a balance of less than \$5,000, but more than \$1,000, may receive an automatic rollover of their vested account balance into an individual retirement account. Participants who terminate employment with a vested account balance of less than \$1,000 may receive an automatic lump sum distribution of their balance.

Forfeited Accounts

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees or adjustments, if any. The Plan permits the use of forfeitures to pay Plan administrative expenses or to offset employer contributions. Due to the vesting provisions of the Plan, there was no forfeiture balance as of July 31, 2024 and 2023, and no forfeitures were used during the years ended July 31, 2024 and 2023.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review

Subsequent events were evaluated through April 22, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTES TO FINANCIAL STATEMENTS

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive group annuity contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of July 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees for recordkeeping services, trustee services, third-party administration, and investment management are included in administrative expenses and are allocated to participants based on a pro rata formula. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses.

NOTE C - CERTIFIED INFORMATION

Plan assets are held and managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust Company). The following information included in the accompanying financial statements and supplemental schedule of assets (held at end of year) was obtained from data that has been prepared and certified to as complete and accurate by Principal Trust Company.

NOTE D - FAIR VALUE MEASUREMENTS

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) establishes framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or by other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at the net asset value ("NAV") of units held by the Plan at year end. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments.

NOTE E – GROUP ANNUITY CONTRACT

The Plan invests in the Principal Fixed Income Guaranteed Option. The Principal Fixed Income Guaranteed Option is a group annuity contract entered into with Principal Life Insurance Company. Principal Life Insurance Company maintains the contributions in a separate investment account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The crediting rate is currently reset on a semiannual basis and will never be less than the guaranteed minimum interest rate of 1% or more than 3%. The average crediting rate was 1.62% and 1.70% for the years ended July 31, 2024 and 2023, respectively. The investment contract does not permit the insurance company to terminate the contract prior to the scheduled maturity date.

NOTE E – GROUP ANNUITY CONTRACT (CONTINUED)

The contract with Principal Life Insurance Company meets the fully benefit-responsive investment contract criteria, and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount that would be received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE F – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Principal Trust Company, and its affiliate Principal Life Insurance Company, provide trustee and recordkeeping services to the Plan, and therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees paid to Principal Trust Company and Principal Life Insurance Company have been included in administrative expenses.

The Plan's investments are managed by Morningstar Investment Management LLC and Wilshire Advisors LLC, and therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees paid to Morningstar Investment Management LLC and Wilshire Advisors LLC have been included in administrative expenses.

Notes receivable from participants and related interest income are also considered party-in-interest transactions, which are exempt from the prohibited transaction rules.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE H - TAX STATUS

The Company has adopted a non-standardized pre-approved plan document. The IRS has opined and informed the pre-approved plan provider by a letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of July 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market rate, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J – DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended July 31, 2024, the Company inadvertently failed to remit participant contributions within the required timeframe as stated by the Department of Labor (DOL). The Company identified three late remittances during the year ended July 31, 2024 totaling \$20,788 including loan repayments. The DOL considers late remittances to be prohibited transactions. The Plan Sponsor is in the process of correcting the late remittances.

NOTE K – RECONCILIATION OF THE FINANCIAL STATEMENTS TO THE FORM 5500
