## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator of the

### **Opinion**

We have audited the accompanying financial statements of Anderson Regional Medical Center Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Anderson Regional Medical Center Retirement Savings Plan as of September 30, 2024 and 2023, and changes in its net assets available for benefits for the year ended September 30, 2024 in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. **1. PLAN DESCRIPTION**

The Anderson Regional Medical Center Retirement Savings Plan (the Plan) adopted the provisions of the FIS Business Systems LLC Volume Submitter Profit Sharing Plan (FIS) effective January 1, 2022. Prior to that date, the Plan had adopted the provisions of the Sungard Business Systems LLC Volume Submitter Profit Sharing Plan (Sungard) effective January 1, 2015.

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*General* - The Plan, effective November 2, 1971, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Substantially all employees, at least 21 years of age, of Anderson Infirmity Benevolent Association – A Non-Profit Mississippi Corporation – d/b/a Anderson Regional Medical Center (the Employer), who make elective deferrals to the Anderson Regional Medical Center 403(b) Plan (the 403(b) Plan), become eligible to receive a matching contribution after completing one year of service with at least 1,000 hours. To receive an allocation of the Employer's contribution, the participant must work 1,000 hours during the Plan year.

*Contributions* – Matching contributions to the Plan are funded by the Employer on a yearly discretionary uniform percentage of each Participants' elective deferrals in the 403(b) Plan. The Plan does not provide for participant contributions, other than rollover contributions which are allowed at the discretion of the Employer. Based on Internal Revenue Service (IRS) limits, the amount of compensation that can be taken into account when determining employee and employer contributions is limited to \$330,000 in 2023. Participants must be actively employed on the last day of the Plan year and meet 1,000 hour annual service requirement to receive an Employer matching contribution for the Plan year.

**1. PLAN DESCRIPTION, Continued**

Investment Options - Participants direct the investment of the contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the Employer's matching contributions, plus the earnings thereon (including net realized and unrealized gains and losses) and charged with an allocation of administrative fees. Record keeping and administrative fees are determined monthly and allocated to all participants with a balance. Additional fees are allocated to a participant's account based on specific services initiated by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants become 20% vested in their accounts after completing 1,000 hours of service. Participants vest additional 20% per year if employed on the last day of the Plan year.

Forfeitures – Amounts forfeited by participants through termination of services before full vesting are used to reduce Employer contributions to the Plan. At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$10,689 and \$49,912, respectively. Also, in 2024, Employer contributions were reduced by \$50,768 from forfeited nonvested accounts.

Payment of Benefits – Upon termination of employment with the Employer, whether due to death, disability, retirement, or other means of termination, the participant's account balance will be available for distribution. There are various methods by which benefits may be distributed from the Plan. The method depends on the participant's marital status, elections made, and the benefit amount.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting* - The accompanying financial statements of the Plan are prepared using the accrual method of accounting.

*Investments* - The Plan's investments, other than fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive investment contracts are reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Mutual fund dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits* - Benefits are recorded when paid.

*Plan Expenses* - Certain expenses associated with maintaining the Plan are paid by the Employer and are not included on the statement of changes in assets available for benefits. However, investment advisory fees and fees associated with the administration of the Plan are paid by the Plan's participants.

*Use of Estimates* - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Employer to make estimates and assumptions for the Plan that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Subsequent Events* – Plan management has evaluated subsequent events through February 3, 2025, the date the financial statements were available to be issued.

**3. MASTER TRUST**

A portion of the Plan’s investments are in the Master Trust, which was established for the investment of assets of the Plan and another sponsored retirement plan of the Employer. Each retirement plan has an undivided interest in the Master Trust assets held at Charles Schwab Bank.

The value of the Plan’s interest in the Master Trust is based on its contributions, including transfers from other Plan investment options, allocated investment income less actual distributions and allocated administrative fees. The Master Trust began receiving assets in December 2014.

As of September 30, 2024, the Plan had approximately a 49% interest in the Master Trust. The assets available for benefits of the Master Trust are summarized as follows:

**4. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) No. 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

*Level 1*                      Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

*Level 2*                      Inputs to the valuation methodology include:

- quoted market prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

*Level 3*                      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**4. FAIR VALUE MEASUREMENTS, Continued**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024, and 2023:

*Mutual and money market funds* – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. RELATED PARTY TRANSACTIONS**

During the year ended September 30, 2024, certain Plan investments were shares of mutual funds managed by Charles Schwab, custodian of the Plan, and, therefore, these transactions qualify as exempt party-in-interest transactions. No administrative expenses were paid to Charles Schwab by the Plan during the year ended September 30, 2024.

**6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as changes in interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's accompanying financial statements and supplemental schedule.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right to discontinue its contributions and terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants become fully vested and the assets of the Plan, after payment of expenses, become distributable to the participants.

**8. INCOME TAX STATUS**

The Plan is intended to comply with the applicable requirements of Section 401(a) of the Internal Revenue Code of 1986, as amended (IRC). The FIS Business Systems LLC obtained their latest determination letters dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan has been amended since receiving their determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Employer has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. SHARED MISSION AGREEMENT AND MEMBER SUBSTITUTION**

Anderson Regional Medical Center (the Employer) entered into a Shared Mission Agreement dated October 18, 2023 (the “Agreement”) with Baptist Memorial Health Care (“Baptist”), a large not-for-profit health system headquartered in Memphis, Tennessee. The Agreement provides that the Employer will restate its certificate of incorporation and bylaws in a manner that results in Baptist or an affiliate of Baptist becoming the sole member of the Employer. The Baptist Board of Directors will have the ultimate fiduciary duties and governing role for the management and oversight of the combined health system. In the Agreement, the Employer agreed to adopt the Mission Statement of Baptist. Within the Agreement, the parties agree to exchange financial statements and other transactional details such as, but not limited to, tax matters, litigation, compliance with relevant laws, and listings of real or intellectual property. As a result of the affiliation, the Employer will have an opportunity to expand its service area to include several additional counties beyond those in which it currently operates. The Employer expects the affiliation to allow it to provide more comprehensive health care services within this expanded service area to meet the needs of the community it serves. The member substitution transaction became effective January 1, 2024, and the employee benefit plans are expected to merge January 1, 2025. As a result, the Plan has been frozen on September 30, 2024. This means that all contributions to the Plan will cease and no employees will enter the Plan after this date. All amounts in participants’ accounts, plus earnings and losses after the freeze date, will become fully vested and will be held until participants are entitled to benefits under the Plan.
