Opinion

NOTES TO FINANCIAL STATEMENTS

1. PLAN DESCRIPTION

The following description of the Anderson Regional Medical Center 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan, effective December 31, 2007, is a defined contribution plan with participant deferral options under Section 403(b) of the Internal Revenue Code. Substantially all employees of Anderson Infirmity Benevolent Association – A Non-Profit Mississippi Corporation – d/b/a Anderson Regional Medical Center (the Employer) become eligible to make salary reduction contributions upon the date their employment begins. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participating employees may make pre-tax or after-tax salary deferrals up to the maximum allowable by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to regulatory limitations. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer does not contribute to the Plan.

Participant Accounts - Each participant's account is credited with the participant's contributions, plus the earnings thereon and charged with an allocation of administrative expenses. Record keeping and administrative fees are determined monthly and allocated to all participants with a balance. Additional fees are allocated to a participant's account based on specific services initiated by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. PLAN DESCRIPTION, Continued

Investment Options - Participants direct the investment of the contributions into various investment options offered by the Plan.

Vesting - Participants are immediately 100 percent vested in their elective deferral contributions plus earnings thereon.

Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are collateralized by the balance in the participant's account and bear a fixed rate of interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

Adequate collateral can be met with the use of up to 50 percent of the vested portion of a participant's account balance to the extent that this balance can be used to satisfy the participant's outstanding loan balance. Participant loans are reported as a note receivable in the Statements of Net Assets Available for Benefits with related loan interest reported in the Statement of Changes in Net Assets. The loan interest rate for participant loans is fixed at the time of issuance and determined by the terms of the plan document. The loan repayments for participant loans are reinvested based on the participant's investment elections in place at the time of repayment.

Payment of Benefits - Upon termination of employment with the Employer, whether due to death, disability, retirement, or other means of termination, the participant's account balance will be available for distribution. The balance of a participant's account will be available for distribution prior to termination of employment with the Employer in the following circumstances: (1) in the event of hardship; or (2) after the participant reaches the age of

59-1/2. There are various methods by which benefits may be distributed from the Plan. The method depends on the participant's marital status, elections made, and the benefit amount.

2. **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investments - Investments, other than fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive investment contracts are reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Mutual fund dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, Continued

Plan Expenses - Certain expenses associated with maintaining the Plan are paid by the Employer and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Recordkeeping, investment advisory fees, loan maintenance fees and loan setup fees associated with the administration of the Plan are paid by the Plan's participants.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Employer to make estimates and assumptions for the Plan that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants - Outstanding participant loans are considered assets of the Plan and are recorded at amortized cost. Repayments of principal and interest are credited to the borrowing participant's account using his or her current investment election.

Subsequent Events - Plan management has evaluated subsequent events through February 3, 2025, the date the financial statements were available to be issued.

3. MASTER TRUST

A portion of the Plan's investments are in the Master Trust, which was established for the investment of assets of the Plan and another sponsored retirement plan of the Employer. Each retirement plan has an undivided interest in the Master Trust assets held at Charles Schwab Bank. The value of the Plan's interest in the Master Trust is based on its contributions, including transfers from other Plan investment options, allocated investment income less actual distributions and allocated administrative fees. The Master Trust began receiving assets in December 2014.

4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) No. 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted market prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024, and 2023:

Mutual and money market funds - valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INVESTMENT CONTRACTS

The Plan invests in fully benefit-responsive investment contracts. The Plan had investment contracts with Talcott Resolution Life Insurance Company (Talcott) at September 30, 2024 and 2023. Talcott maintains the contributions in a general account. The accounts are credited

with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contracts. Contract value, as reported to the Plan by Talcott, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at September 30, 2024 and 2023, was \$1,123,988 and \$1,108,021, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 4 percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletions of equity wash provisions, (3) bankruptcy of the Employer or other Employer events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. RELATED-PARTY TRANSACTIONS

During the year ended September 30, 2024, certain Plan investments were shares of mutual funds and investment contracts. Charles Schwab Bank and Talcott Resolution Life Insurance Company are the custodians of the Plan's assets as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions. No administrative expenses were paid to Charles Schwab Bank or Talcott Resolution Life Insurance Company by the Plan during the year ended September 30, 2024.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as changes in interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan at any time, subject to the provisions of ERISA.

9. INCOME TAX STATUS

The Plan adopted a volume submitter 403(b) plan which received an IRS advisory letter dated March 31, 2017, stating the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan Administrator believes that the Plan is designed and

is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the Employer to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. SHARED MISSION AGREEMENT AND MEMBER SUBSTITUTION

Anderson Regional Medical Center (the Employer) entered into a Shared Mission Agreement dated October 18, 2023 (the "Agreement") with Baptist Memorial Health Care ("Baptist"), a large not-for-profit health system headquartered in Memphis, Tennessee. The Agreement provides that the Employer will restate its certificate of incorporation and bylaws in a manner that results in Baptist or an affiliate of Baptist becoming the sole member of the Employer. The Baptist Board of Directors will have the ultimate fiduciary duties and governing role for the management and oversight of the combined health system. In the Agreement, the Employer agreed to adopt the Mission Statement of Baptist. Within the Agreement, the parties agree to exchange financial statements and other transactional details such as, but not limited to, tax matters, litigation, compliance with relevant laws, and listings of real or intellectual property. As a result of the affiliation, the Employer will have an opportunity to expand its service area to include several additional counties beyond those in which it currently operates. The Employer expects the affiliation to allow it to provide more comprehensive health care services within this expanded service area to meet the needs of the community it serves. The member substitution transaction became effective January 1, 2024. As a result, the Plan has been frozen on September 30, 2024. This means that all

contributions to the Plan will cease and no employees will enter the Plan after this date. No new loans will be permitted. All amounts in participants' accounts, plus earnings and losses after the freeze date, will become fully vested and will be held until participants are entitled to benefits under the Plan.
