Independent Auditor's Report

To the Plan Administrator of the Simoniz USA, Inc. 401(k) Profit Sharing Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Simoniz USA, Inc. 401(k) Profit Sharing Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

A. PLAN DESCRIPTION:

The following description of the Simoniz USA, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for more detailed information.

General

The Plan is a defined contribution plan sponsored by Simoniz USA, Inc. (the "Company"), covering all employees of the Company and related adopting employers who have attained age 18 and have completed 6 months of service. Adopting employers are WET, Inc., Car Wash Services, Inc., Splash & Dash, Epic Industries, Harvard Chemical Research, Inc. and Kemko AMA. All prior service with these adopting employers is recognized for eligibility and vesting. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions

Participants may contribute up to 100% of their gross compensation, as defined by the Plan, on a pre-tax or Roth basis, subject to Internal Revenue Code ("IRC") limitations. Highly compensated participants may contribute up to 7%. Participants who are at least age 50 may make an additional "catch-up" contribution subject to IRC limitations. Participants may also contribute funds from another qualified retirement plan ("rollover contributions"), subject to certain requirements. Newly hired employees are automatically enrolled at a contribution rate of 5% of plan compensation, unless they opt out.

Participant contributions may be matched by the Company at a percentage of the participants' contributions, as determined by the Company. For the year ended September 30, 2024, the Company matched 75% of each participant's deferral contributions up to 5% of the participant's compensation. Participants who are employed on the last day of the plan year must complete 1,000 hours of service in order to share in the matching contributions. Participants not employed on the last day of the plan year must have a year of service in order to receive the matching contributions. The Company may also make a discretionary profit sharing contribution. Participants must complete a year of service and be employed on the last day of the plan year to be eligible to receive discretionary profit sharing contributions. The Company did not make a discretionary profit sharing contribution for the year ended September 30, 2024.

Participant Accounts

Each participant's account is credited or charged with contributions, investment income, and administrative expenses. Investment income, including realized and unrealized gains and losses, and expenses are allocated to participants' accounts based on each participant's account balance within each fund. Participants determine the percentage in which contributions are to be invested in each fund. Participants may change their investment options as set forth in the plan document. The benefit to which a participant is entitled is equal to the value of the participant's vested interest in their account.

Vesting

Participants are fully vested in that portion of their account which represents their contributions and the income earned thereon. Participants become 100% vested in the Company's contributions and earnings thereon upon death, total and permanent disability, or attainment of normal retirement age. Participant's interest in the Company's matching and discretionary profit sharing contributions and earnings thereon vests according to the following schedule:

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of a participant's account represents a forfeiture, as defined by the Plan. If a forfeiting participant is re-employed and fulfills certain requirements, as set forth in the Plan, the participant's account will be restored. Forfeitures from the matching contribution will be used to reduce company contributions to the Plan, and remaining forfeitures from the discretionary contributions will be allocated to participants. Forfeitures may also be used to pay expenses. \$36,133 of forfeitures were used during 2024 to reduce the company matching contributions for the plan year ended September 30, 2023 which were funded during plan year ended September 30, 2024. Unallocated forfeitures were \$24,912 and \$34,890 at September 30, 2024 and 2023, respectively.

Unallocated Assets

The Plan holds assets in a fee recapture account which receives deposits as a result of a revenue sharing agreement with Voya Retirement Insurance and Annuity Company. During the plan year, deposits to the account totaled \$24,369, which is included in net appreciation (depreciation) in fair value of investments in the statement of changes in net assets available for benefits. Funds in the account are used to pay qualified plan expenses or may be allocated to participants. During the plan year, \$19,530 was used to pay plan expenses and \$10,389 was allocated to participants. Unallocated assets were \$18,862 and \$24,064 at September 30, 2024 and 2023, respectively.

Distribution of Benefits

Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Distributions under the Plan may be made in lump sums.

A participant may also request a withdrawal upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship", as defined in the plan document. A participant may also take a distribution from their rollover account if they are permitted to take a distribution from the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. Loans bear interest at Prime plus 1%. All loans must be repaid within five years unless the proceeds are used to acquire a principal residence, in which case a longer repayment period is allowed. No more than one loan may be outstanding at any time. Principal and interest is generally paid ratably through payroll deductions each pay period.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of September 30, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Plan Expenses

Participant transaction fees, investment expenses, and certain annual administrative fees incurred by the Plan are paid by the participants. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Any remaining fees not paid from plan assets are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Payment of Benefits

Benefits are recorded when paid.

C. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used by the Plan. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Pooled separate accounts - Valued at the net asset value of units of a pooled separate account. The net asset value, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Pooled separate accounts can be redeemed daily, have daily redemption notice periods, and have no unfunded commitments. Investment strategies for the pooled separate accounts, by major investment class, are as follows:

- (a) Large cap value/blend pooled separate accounts invest primarily in stocks of larger U.S. companies employing an investment style of growth.
- (b) Bond pooled separate accounts invest in fixed income securities that have been determined to be appropriate for its investment goal.
- (c) Large cap growth pooled separate accounts invest primarily in stocks of larger U.S. companies employing an investment style of growth.
- (d) Target date pooled separate accounts invest in a combination of assets such as aggressive stocks, international stocks, large-company stocks, government bonds, foreign bonds or money markets.
- (e) Small/mid/specialty pooled separate accounts invest primarily in stocks of small-and medium-sized companies.

- (f) Global/international pooled separate accounts can have an investment style of foreign large value, foreign large blend, foreign large growth, foreign small/mid value or foreign small/mid growth. These funds invest in stocks of companies outside of the United States. Global funds have an investment style of world stock. These funds invest in stocks of companies in the United States and developed countries outside of the United States. Emerging markets funds invest in securities of developing countries and demonstrate the greatest volatility of performance due to the unstable nature of their economies, political structures and currencies.
- (g) The money market pooled separate account seeks to provide high current return, consistent with preservation of capital and liquidity and maintenance of a stable \$1.00 net asset value per share, through investment in high-quality money market instruments.

D. INVESTMENT CONTRACTS WITH INSURANCE COMPANY:

The Plan holds two traditional investment contracts issued by Voya Retirement Insurance and Annuity Company (“the contract issuer”). Effective May 19, 2017, the Voya Fixed Account (“existing fixed account”) held by the Plan was frozen to any new deposits or transfers. After that date, all future deposits and transfers were directed to the Voya Fixed Account A (“new fixed account”). The new fixed account has a lower guaranteed minimum interest rate. Restrictions are the same for both accounts. Effective May 22, 2023, the "Fixed Account A" was transferred to "Fixed Account 4450" when the plan moved to the enhanced Voya platform.

Both contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

With traditional investment contracts, the Plan owns only the contract itself. These contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3 percent for the existing fixed account and may not be less than 1 percent for the new fixed account. The existing fixed account interest rates are reviewed on an annual basis for resetting and the new fixed account interest rates are reviewed on a quarterly basis for resetting. The contracts do not have a maturity date.

Full surrenders from the Fixed Accounts can be paid by Voya in equal principal payments, with interest, over a period not to exceed 60 months, or a single payment adjusted by a market value adjustment. The market value adjustment is calculated considering the fixed account standard credited rate and the rate of a 7-year US Treasury bond derived from US Treasury bond rates found in the Citigroup Bond Market Roundup and a percentage of the Fixed Accounts surrender value to which the market value adjustment applies. These contracts are not subject to a surrender charge.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would also limit the ability of the Plan to transact at contract value with the participants.

E. TAX STATUS:

The Plan has adopted a pre-approved plan document of Pension Consultants, Inc. Pension Consultants, Inc. received a favorable opinion letter dated May 26, 2021 in which the Internal Revenue Service ("IRS") stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. CERTIFIED INVESTMENTS:

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at September 30, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, and interest for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the custodian of the Plan.

G. PARTIES-IN-INTEREST:

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and the management of investments held by the custodian are considered party-in-interest transactions.

H. PLAN TERMINATION:

Although the Plan was established with the intention that it will continue indefinitely, the Company retains the right to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

I. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

J. SUBSEQUENT EVENTS:

The Company has evaluated subsequent events through April 24, 2025, the date these financial statements were available for issuance.
