## **INDEPENDENT AUDITORS' REPORT**

To the Board of Directors  
Westview Nursing Care & Rehabilitation Center, Inc. Savings & Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audits of the financial statements of Westview Nursing Care & Rehabilitation Center, Inc. Savings & Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of September 30, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Westview Nursing Care & Rehabilitation Center, Inc. **1. DESCRIPTION OF PLAN**

The following description of the Westview Nursing Care & Rehabilitation Center, Inc. Savings & Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General –**

The Plan is a defined contribution plan covering substantially all employees of Westview Nursing Care & Rehabilitation Center, Inc. (the Company) as defined in the Plan agreement, who have at least 1 year of service and have reached the age of 21. Nonresident aliens, lease employees and residents of Puerto Rico are excluded from participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management and the plan administrator are responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

**Contributions –**

Each year, participants may contribute to the Plan a percentage of their eligible compensation, on a pre-tax or after-tax Roth basis, up to the maximum amount allowed by the Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. With the approval of the plan administrator, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe harbor matching contribution in an amount equal to 100% of the amount of the participant's elective deferrals that do not exceed 5% of the participant's compensation. For the years ended September 30, 2024 and 2023, safe harbor contributions totaled \$264,603 and \$240,891, respectively.

The Company may also make an additional matching contribution, which is determined each year by the Company on a discretionary basis. For the years ended September 30, 2024 and 2023, there were no additional discretionary matching contributions to the Plan. The Company may also make discretionary nonelective contributions to the Plan, which is also determined each year by the Company on a discretionary basis. Nonelective contributions are allocated to participants in the same ratio as each participant's compensation bears to the total compensation of all participants. For the years ended September 30, 2024 and 2023, there were no discretionary nonelective contributions made to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts –**

Each participant's account is credited with the participant's contribution, the Company's safe harbor matching contribution, an allocation of the Company's discretionary matching and nonelective contributions, if any, and actual earnings thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting –**

Participants are immediately vested in their contributions, rollover contributions and safe harbor matching contributions, plus earnings thereon. Vesting in the Company's discretionary matching and nonelective contributions portion of their accounts is based on years of continuous service, as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
1 year	0%
2 years	25%
3 years	50%
4 years	75%
5 years or more	100%

**Notes Receivable from Participants –**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are required to be repaid within five years unless the loan is to be used for the purchase of a primary residence in which case the note may be repaid within a period of no more than ten years. Participants may have two outstanding loans at a time. The loans are secured by the balance in the participant's account and bear interest at the prime rate. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits –**

Upon termination of service, retirement, disability or death, a participant may receive a lump sum, partial, or installment payments in an amount equal to the value of the participant's vested interest in their account either in a distribution or a rollover. A participant may withdraw from their rollover account at any time. A participant may also request an in-service withdrawal upon attainment of age 59 ½. If a participant's account balance is greater than \$1,000 but equal to or less than \$5,000, the plan administrator can automatically rollover their entire vested account balance into a traditional individual retirement account (IRA). If a participant's account balance is \$1,000 or less, the plan administrator can distribute the entire balance in a lump sum amount.

Hardship withdrawals are available from a participant's pre-tax or Roth elective deferral account, in order to meet a participant's immediate and heavy financial need, as defined in the Plan document.

**Forfeitures –**

Forfeitures are used to pay Plan expenses or offset future Company contributions to the Plan. At September 30, 2024 and 2023, the Plan had available forfeitures totaling \$4,635 and \$4,532, respectively. At September 30, 2024 and 2023, unallocated forfeitures totaled \$7,884 and \$7,724, respectively. For the years ended September 30, 2024 and 2023, no forfeiture or unallocated amounts were used to pay Plan expenses or offset Company contributions to the Plan.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting –**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates –**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition –**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants –**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 and 2023. Delinquent notes receivable from participants, if applicable, are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits –**

Benefits are recorded when paid.

**Administrative Expenses –**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Recently Adopted Accounting Pronouncement –**

In June 2016, the Financial Accounting Standards Board issued Accounting Standards Update (ASU) 2016- 13, *Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments*, as subsequently amended by additional ASUs. The ASU requires the allowance for credit losses to be estimated based on an incurred loss model, which considers historical and forecasted conditions. Financial assets held by the Plan that are subject to the guidance in FASB ASC 326 were contributions receivable.

On October 1, 2023, the Plan adopted the new accounting standard and all of the related amendments using the modified retrospective method. The impact of the adoption was not considered material to the Plan’s financial statements.

**Date of Management’s Review –**

The Plan has evaluated subsequent events through April 28, 2025, the date the financial statements were available to be issued.

**3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The 3 levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Mutual funds:*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan holds a fully benefit-responsive investment contract with Standard Insurance Company (Standard). Amounts allocated to the investment are held in the insurance company's general account, and there are no segregated or identifiable assets ascribed to the Plan's investment. Net deposits and interest credited become liabilities against Standard on the Plan's behalf. The crediting interest rate is set by Standard but may not be less than 1% annually. During the year ended September 30, 2024 and 2023, the crediting interest rate was 2.05% and 1.71%. The crediting rate is declared in advance and is reset quarterly. Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions. Contract value is guaranteed by the full faith and credit of Standard.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measure attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported by Standard, represents contributions made under the contract, less participant withdrawals and administrative expenses, plus interest credited. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**4. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (Continued)**

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The Company may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or Standard are probable of occurring.

**5. INFORMATION PREPARED AND CERTIFIED BY PLAN'S TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at September 30, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

**6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**7. TAX STATUS**

The Plan has adopted a prototype non-standardized profit-sharing plan and relies on the prototype plan's opinion letter from the IRS dated June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter. However, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all Company contributions.

**9. PROHIBITED TRANSACTIONS**

Under U.S. Department of Labor Regulation Section 2510.3-102, Plan related salary deferrals and loan repayments withheld from employees' paychecks must be deposited into the Plan as soon as reasonably possible, but in no event later than the fifteenth business day of the month following the Company's withholding. When this regulation is not satisfied, the Company has engaged in a prohibited transaction.

During the years ended September 30, 2024 and 2023, the Company engaged in prohibited transactions by remitting certain deposits to the Plan after the required reporting period. The Company is in the process of taking corrective action related to these prohibition transactions.

**10. PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by affiliates of Reliance Trust Company, the trustee of the Plan, which qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.
