**Note 1. Description of Plan**

The following description of the Tech-Marine Business, Inc. Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

***General***

The Plan was formed on July 1, 2008, as an employee stock ownership plan (ESOP) covering all eligible employees of Tech-Marine Business, Inc. (Company). The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended, (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by the Board of Trustees, as appointed by the Company’s Board of Directors, who hold and invest the Trust assets. The Plan’s third-party record-keeper and ERISA compliance service provider is Blue Ridge ESOP Associates.

The Plan purchased certain Company common shares (see Note 4) and holds the stock in a trust established under the Plan.

***Eligibility***

Employees of the Company are generally eligible to participate in the Plan after one year of service provided, they worked at least 1,000 hours during the plan year and have attained 21 years of age. Participants who do not have at least 1,000 hours of service during the plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year. Employees who are of retirement age (64 years) are eligible for allocation regardless of their employment status during the Plan year.

***Contributions***

Each year, the Company may make a discretionary cash or stock contribution determined annually by the Company’s board of directors. Participants are not permitted to make contributions to the Plan. Contributions are subject to certain limitations.

***Participant Accounts***

Each participant’s account reflects their portion of the Company’s contributions and allocations of shares of Company stock, income or loss from Plan investments, and forfeitures, and charged with benefit payments and an allocation of administrative expenses. Allocations are based on compensation, account balances or Company stock shares, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

The Plan’s vesting provisions were amended effective January 1, 2022. As a result of the amendment, participants who were hired prior to January 1, 2022, and were still employed on January 1, 2022, will become fully vested in their third year of service with partial vesting in their second year. Participants who were hired on or after January 1, 2022, become fully vested in their third year of service without partial vesting.

Participants become 100% vested upon retirement, death or disability.

***Payment of Benefits***

At a participant's retirement, disability, or death, distribution of his or her vested account balance begins no later than the end of the plan year following the event. At a participant's termination for any other reason, distribution of his or her vested account balance begins no later than the end of the plan year following the year in which the participant incurs a five-year break in service. If the participant's balance is less than \$10,000, a distribution is made as soon as administratively feasible. Distributions of \$5,000 or more are paid in annual installments over a five-year period. Each installment is the participant's vested balance of cash, noncompany investments, and the current fair market value of Company stock at the end of the plan year prior to the date of payment divided by the remaining number of installments. Distributions are paid in cash.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations. During 2024, the Company did not repurchase any shares from participants as no shares were distributed.

***Forfeitures***

Forfeited nonvested accounts are reallocated to eligible participants based on compensation. During 2024, \$1,277 of cash and approximately 160 shares with a fair value of \$15,285 were reallocated to eligible participants. There were no unallocated forfeitures at December 31, 2024 or 2023.

***Voting Rights***

Each participant is entitled to direct the voting of any voting shares of Company Stock allocated to their account with respect to any vote required for the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all the assets of a trade or business. In accordance with instructions from the plan administrators, the trustee will vote any unallocated shares held by the trust as well as any allocated shares for which a participant has failed to give timely voting direction.

***Put Option***

Under Federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%.

Effective January 1, 2024, participants who are at least age 55 and with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Participants who elect to diversify receive a cash distribution. As of December 31, 2024, 12 participants were eligible to diversify their account balance.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

### ***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates and assumptions.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's losses on investments bought and sold as well as held during the year.

### ***Payment of Benefits***

Benefits are recorded upon distribution.

### ***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

### ***Subsequent Events***

The Plan has evaluated subsequent events through April 25, 2025, the date the financial statements were available to be issued.

## **Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

**Common Stock**

The fair value of the Company's common stock is determined by an annual independent appraisal. This appraisal was based on a combination of the market and income valuation methods. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities.

**Interest-Bearing Cash**

Valued daily as its closing cash balance as reported by the trustee.

**Note 5. Plan Termination**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, the trustee will be directed to pay all liabilities and expenses of the trust fund.

**Note 6. Tax Status**

The Internal Revenue Service (the "IRS") has determined and informed the Company by letter dated September 26, 2013, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions.

**Note 7. Risks and Uncertainties**

The Plan invests in the Company's common stock. There are certain business risks with the industry in which the Company operates; therefore, it is at least reasonably possible that changes in the fair value of the Company's common stock may occur in the near term and that such changes could materially affect participant's account balances, and the amounts reported in the Statement of Net Assets Available for Benefits.

**Note 8. Terminated Participants**

Amounts allocated to terminated participants with vested balances in the Plan, and which were still included in net assets available for benefits at December 31, 2024 and 2023, were \$4,357,013 and \$4,330,881, respectively.
