INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Thomas Jefferson Classical Academy 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Thomas Jefferson Classical Academy 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Notes C and H to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Thomas Jefferson Classical Academy 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Thomas Jefferson Classical Academy 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Note A-Description of Plan

The following description of Thomas Jefferson Classical Academy (School) 401 (k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the School who are age twenty-one or older. The Plan is administered by the School. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The School is the Plan’s sponsor and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Eligibility

Employees of the School age 21 and older are eligible to participate in the plan upon hire. Part-time employees age 21 and older are eligible after 1,000 hours of service.

Contributions

Participant contributions - Each year, participants may elect to make 401(k) voluntary contributions up to the maximum allowable under the Internal Revenue Code of pretax annual compensation through voluntary payroll deductions. Participant contributions made with tax-deferred dollars are excluded from the participant’s current wages for federal income tax purposes. No federal income tax is paid on the tax-deferred contributions and growth thereon until the participant makes a withdrawal from the Plan. A participant can elect to contribute 1% to 100% of eligible compensation.

Participants may also choose to make contributions on an after-tax basis to a Roth 401(k) option. Contributions and earnings for the Roth option are not subject to taxation at the time of distribution, as long as the distribution is a “qualified distribution” made no earlier than five years after the first Roth contribution to the plan. A qualified distribution is a distribution after separation of service and due to death, disability or after age 59 ½.

Participants who have attained age 50 before the end of the Plan year are eligible to make voluntary catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Annual contributions for each participant are subject to the participation and discrimination standards of Internal Revenue Code Section 401 (k). Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer matching contributions – The School matches 100% of employee contributions up to 6% of eligible compensation.

Contributions are subject to certain statutory limitations.

Participant Rollover Contributions – The Plan allows rollover contributions from eligible retirement plans if it meets all of the IRC requirements for rollover treatment.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the School's matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All funds are participant directed.

Investment Options

Upon enrollment in the Plan, a participant may elect the manner in which their account is invested. Participants may change their investments at any time.

Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Participants are also immediately 100% in all matching contributions made by the School to the plan.

Participant Loans/Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest rates at 1% above prime. Loan terms range from one to five years or up to fifteen years for the purchase of a principal residence. Principal and interest is paid ratably through monthly payroll deductions. Only one loan is allowed at a time. As of June 30, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.50% with various maturities through June 2029.

On May 6, 2023 the Plan adopted amendments related to loans as allowed by the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The loan maximum is increased to \$100,000 or 100% of the vested account balance. Payments may be deferred up to one year at the request of the employee. As of June 30, 2024 no loans were taken in accordance with these amendments.

Distributions/Payment of Benefits

Participants or their beneficiaries may receive distributions of their account balances upon the earlier of reaching age 59-1/2, disability, death or termination of service, as defined in the Plan. The Plan Administrator may permit a participant who experiences a qualified financial hardship, as defined, to receive a distribution of a portion of the participant's account balance. On termination of service the participant can withdraw their funds after a thirty-day waiting period or they can waive the thirty-day waiting period and receive the distribution immediately. Participants may delay receipt of benefits until retirement. Distributions from the plan may be made in a one lump-sum payment, substantially equal installments, and as required to meet the required minimum distribution regulations.

Forfeited Accounts

Employees are 100% vested and therefore there are no forfeitures related to termination of employment.

As of June 30, 2024, there is no amount shown as forfeitures to reduce related to overpayment of matching contributions. These forfeitures will be used in the subsequent year to reduce School matching contributions. The forfeitures were \$0 at June 30, 2024 and \$0 at June 30, 2023.

Note B – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

The net appreciation (depreciation) in the fair value of investments presented in the statement of changes in net assets available for benefits consists of the realized gains (losses) and the unrealized appreciation (depreciation) on those investments. The net appreciation (depreciation) in fair value of investments is presented net of investment manager fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date as a part of Net appreciation (depreciation). Net appreciation (depreciation) includes the plan’s gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Interest income in the accompanying financial statements is related to notes receivable from participants. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. As of June 30, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule. Schedule H, Line 4i-Schedule of assets (held at year end).

Excess Contributions Payable/Prepaid Contributions

Amounts payable to participants totaling \$1,646 at June 30, 2024 and \$59 at June 30, 2023 for contributions made in error are recorded as accounts payable, with either a corresponding reduction contributions or refunded to participants in the subsequent year .

Payments of Benefits

Benefits are recorded when paid.

Contributions

Participant and employer contributions are transferred to the trustee or accrued in the period during which participant payroll deductions are made.

Expenses

Certain expenses of maintaining the Plan are paid by the School and are therefore excluded from these financial statements. Administrative expenses, including but not limited to, recordkeeping expenses, trustee fees, and transactional costs may be paid by the plan, at the election of the Plan Administrator. Expenses paid by the plan for the year ended June 30, 2024 were \$38,065. Investment related expenses such as brokerage fees, transfer taxes, and investment fees were \$26,840. Fees for the administration of notes receivable from participants, if any, are included in administrative expenses and charged directly to the participant's account.

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through April 20, 2025 which is the date the financial statements were available to be issued.

The market increases in the first quarter of the subsequent year however in the second and third quarters the markets declined. Because the values of the Plan's individual investments have and will fluctuate in response to changing market conditions, the amount of gains or losses that will be recognized in subsequent periods, if any, cannot be determined at this time.

Note C-Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of level 2 or 3 inputs for the periods presented.

Level 1 Fair Value Measurements

Fair value measurements that reflect unadjusted, quoted prices in active markets for identical assets and liabilities that the accounts have the ability to access at the measurement date.

Level 2 Fair Value Measurements

Inputs other than quoted prices in active markets for identical assets that are observable either directly or indirectly for substantially the full term of the asset, quoted prices for identical or similar assets in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.

Level 3 Fair Value Measurements

Fair value measurements using significant non market observable inputs. The Plan did not have any Level 3 inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. John Hancock plan management has determined that the assets are Level 1 based on information provided by John Hancock

Shares of registered investment company funds (mutual funds) are valued at net asset value (NAV) of shares held by the Plan and are valued at the closing price reported on the active market on which the individual securities are traded.

The Plan believes its valuation methods are appropriate and consistent with other market participants.

Note D – Related Party and Party In Interest Transactions

Plan investments are shares of mutual funds managed by John Hancock, the trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA. The Plan Sponsor also paid certain administrative expenses of the Plan that are not reflected in these financial statements of the Plan. Amounts paid to John Hancock for Administrative Fees were \$35,515 for June 30, 2024.

Note E- Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA.

Note F – Tax Status

The Internal Revenue Service (IRS) has determined and informed the School by a letter dated February 1, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan's administrator and management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate uncertain tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note G – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note H – Trustee Certification

The information summarized in Note C as well the following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by John Hancock the current trustee under the Plan and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustees related to the following assets and asset activity is either complete and accurate or complete and accurate to the best of their knowledge. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and supplemental schedule related to the following assets.
