Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Ballad Health 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

NOTE A--DESCRIPTION OF THE PLAN

The following description of the Ballad Health 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan was established as a result of a merger between Mountain States Health Alliance and Wellmont Health System to form Ballad Health. The Board of Directors of Ballad Health adopted a resolution whereby the Wellmont Health System 401(k) Retirement Savings Plan was merged into the BRMMC 401(k) Retirement Plan effective as of close of business on June 30, 2018. The BRMMC 401(k) Retirement Plan was redesigned and restated the Ballad Health 401(k) Plan on July 1, 2018.

On June 25, 2021, the Board of Directors of Ballad Health approved a resolution whereby the NCH 401(k) Retirement Plan was merged into the Ballad Health 401(k) Plan. As such, all of the assets of the NCH 401(k) Retirement Plan became assets of the Ballad Health 401(k) Plan effective as of June 30, 2021.

Employees of Ballad Health (Ballad) who are 18 years of age or older are eligible to participate in the Plan upon date of hire. Collectively bargained employees, non-resident aliens, leased employees, PRN employees, and Registry employees are not eligible to participate in the Plan.

Contributions: Participants may elect to contribute to the Plan, through payroll deductions, in amounts not to exceed annual contribution limits set forth by the Internal Revenue Service. Participants who have attained age 50 before the end of the calendar year are eligible to make additional catch-up contributions. Participants may also contribute amounts representing rollovers from other qualified plans.

For participants who have completed 1,000 hours of service and are employed on the last day of the Plan year, Ballad may contribute a discretionary matching contribution to the Plan. The discretionary matching contribution is equal to 100% of each eligible participant's elective deferrals, up to 6% of eligible compensation. Participants direct the investment of all contributions into various investment options offered by the Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions, Ballad's contributions, an allocation of Plan earnings, and charged with an allocation of Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their elective contributions, plus actual earnings thereon. Vesting in Ballad's discretionary matching contributions is based on years of credited service. A year of credited service is based on the completion of 1,000 or more hours of service within a Plan year. Effective July 1, 2018, participants who worked one hour of service on or after July 1, 2018, are vested in Ballad's discretionary matching contributions according to the following schedule:

Participants with employer matching contributions made to the Wellmont Health System 401(k) Retirement Savings Plan for Plan years prior to July 1, 2018, are vested in the employer matching contributions after three years of service.

Forfeitures: At June 30, 2024 and 2023, forfeited nonvested accounts totaled approximately \$3,000 and \$300, respectively, and are included in Plan assets. Forfeitures are used to reduce future employer discretionary matching contributions. During 2024, no forfeitures were used to reduce employer contributions.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance of the participant's account and bear interest at rates between 4.25% and 9.50% at June 30, 2024, which were commensurate with local prevailing rates at the time the loans were initiated. The term of the loan is no longer than five years unless the

loan is used to purchase a principal residence. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: Upon termination of service, including due to death, disability, or retirement, a participant may receive a lump sum amount equal to the participant's vested account balance.

The Plan makes involuntary distributions (automatic rollovers) to terminated participants with account balances of \$5,000 or less.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments in shares of registered investment companies are reported at fair value based on the quoted market values of the shares held by the Plan.

The investment contracts held by the Plan are reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold during the year, as well as held at year end.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent participant loans are recognized as benefits paid to participants based upon the terms of the Plan document. No allowance for credit losses has been recorded as of June 30, 2024 or 2023.

Benefit Payments: Benefit payments are recorded when paid. There were no significant amounts of benefits requested and approved for payment but not paid as of June 30, 2024.

Administrative Expenses: Administrative expenses related to maintaining participant accounts and third-party administration are paid by the Plan and deducted from participant funds. Plan expenses related to legal and accounting fees may be paid by the Plan or the Plan sponsor.

NOTE C--INFORMATION CERTIFIED BY THE CUSTODIANS AND TRUSTEE

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information was certified by The Variable Annuity Life Insurance Company (VALIC) and Brighthouse Life Insurance Company (Brighthouse), custodians of the Plan, and by Lincoln Financial Group Trust Company, Inc., the trustee of the Plan, and was not subjected to any auditing procedures performed by the Plan's independent public accountants:

- The investments and notes receivable from participants were as shown in the accompanying Statements of Net Assets Available for Benefits of \$113,374,872 and \$656,790, respectively, as of June 30, 2024, and \$102,850,214 and \$648,229, respectively, as of June 30, 2023.
- Net appreciation in fair value of investments of \$10,959,253 and interest, dividends, and other income of \$2,849,099 were as shown in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended June 30, 2024.
- All investment-related information in the accompanying supplemental Schedule H, Line 4i - Schedule of Assets Held at Year End as of June 30, 2024.

NOTE D--CONTRACT WITH INSURANCE COMPANIES

The Plan has entered into a fully benefit-responsive investment contract with Lincoln National Life Insurance Company (Lincoln). Lincoln maintains the contributions in a general account. Lincoln is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Other contracts with insurance companies are not significant.

The Lincoln Stable Value Account is an unallocated group fixed annuity contract in which the value is derived from the contract provisions. The interest rate is declared at the beginning of each quarter and guaranteed for contributions received that quarter. The contractually guaranteed minimum interest rate is 1.00%. Participant transfers to a competing fund are not permitted. Participant withdrawals and transfers from the account are not permitted for 90 days after a transfer from any other investment option in the Plan to a competing fund. Withdrawals from the account

due to surrender of the contract by the Plan sponsor may be made at contract value over a 5-year period or in the form of a lump-sum payment subject to a market value adjustment.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. Management believes no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, and that would also limit the ability of the Plan to transact at contract value with the participants.

NOTE E--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy based on valuation inputs. The three levels of the fair value hierarchy are described as follows:

- *Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2:* Inputs to the valuation methodology include:
 - Quoted prices for similar assets and liabilities in active markets;
 - Quoted prices for identical or similar assets and liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or are corroborated by observable market data by correlation or other means.
- *Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The valuation inputs described in Note B may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan sponsor believes the valuation methods are appropriate and consistent with other market

participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at June 30, 2024 and 2023.

NOTE F--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

During the Plan year, the Plan's contracts were secured by the general assets of VALIC, Brighthouse, and Lincoln. VALIC and Brighthouse are custodians as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Lincoln serves as third-party administrator and trustee as defined by the Plan, and therefore, these transactions also qualify as party-in-interest transactions. Commissions and fees paid to VALIC and Brighthouse by the Plan were not significant during the year ended June 30, 2024. Fees paid by the Plan directly to Lincoln for administrative services totaled approximately \$52,400 during the year ending June 30, 2024.

Participants investing through VALIC may borrow from VALIC and use their Plan account balance as collateral for the loan. The balances of these policy loans are not paid through payroll deductions and are not included in the Plan assets. Upon commencement of the loan, an amount equal to the principal amount loaned by VALIC is transferred to a Loan Collateral Fund and Loan Escrow Fund. These funds are fixed-income investments that earn a stated rate of interest that is allocated to the individual participant. As loan payments are paid to VALIC, the collateral is released from the Loan Collateral and Loan Escrow Funds and reinvested according to participant elections for contributions. As of June 30, 2024 and 2023, \$140,877 and \$133,988 of Plan assets, respectively, were pledged as collateral or held in escrow for such loans made by the Plan's participants and are included in contracts with the insurance company in the Statements of Net Assets Available for Benefits. A policy loan is considered to be in default when no payments are made within 45 days of the due date of the payment. Upon default, VALIC will foreclose on the loan and remove the collateral from the Plan if the participant has a right to a current distribution.

If the participant is not eligible for a current distribution, the collateral will remain in the Plan until the loan is paid in full or the participant becomes eligible for distribution.

NOTE G--PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in their account balance.

NOTE H--INCOME TAX STATUS

On March 31, 2014, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE J--SUBSEQUENT EVENTS

Subsequent events have been evaluated through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued. During this period, management did not note any material recognizable subsequent events that required recognition or disclosure in the financial statements.
