Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Smoky Mountain Home Health and Hospice, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Smoky Mountain Home Health and Hospice, Inc. 401(k) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Smoky Mountain Home Health and Hospice, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets Held at End of Year is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF PLAN

The following description of Smoky Mountain Home Health and Hospice, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan for eligible employees of Smoky Mountain Home Health & Hospice, Inc. (“Sponsor,” or the “Company”). The Plan was originally effective on October 1, 1997, and was amended on October 1, 2015. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Administration

The Company serves as its own administrator (the “Plan Administrator”). The Plan has contracted with John Hancock Life Insurance Company to serve as custodian (the “Custodian”) and the recordkeeper (the “Recordkeeper”).

Participation

The Plan covers substantially all employees of the Company. Eligible employees for Plan participation are defined as full-time employees who have completed one year of service, worked at least 1,000 hours in one year, and have attained age 21. Actual entrance to the Plan will occur once eligible participants reach the Entry Date. Entry Date is defined as the date the eligibility requirements are satisfied.

Contributions

Participants may elect to defer a percentage of their annual compensation, as defined, subject to the limitations prescribed by the Internal Revenue Code (the “Code”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Rollovers in 2024 and 2023 amounted to \$25,661 and \$61,389, respectively. The Company contributes 3% of the compensation of each plan participant. The Company may also elect to make contributions to the Plan and these contributions are discretionary. The Company made contributions of \$350,000 for the year ended September 30, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of Plan earnings, and charged with withdrawals and an allocation of administrative expenses and Plan losses. Allocations are based on eligible compensation or account balances as defined. The benefit to which the participant is entitled is the benefit that can be provided from the vested portion of the participant’s account.

1. **DESCRIPTION OF PLAN**

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into any investment option offered by the Plan. The Plan Administrator provides information on investment options and the frequency with which a participant can change the options.

Vesting

Participants are fully vested in their contributions at all times. Vesting in the Company's discretionary contributions is as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years. The loans are secured by participants' vested interest in the Plan and bear interest at rates based on the prime rate published as of the dates of the loans. The interest rate will be fixed for the duration of the loan. Principal and interest are paid ratably through payroll deductions and are to be repaid over periods not exceeding five years, with the exception of a provision for qualified military service by a participant, which may permit a longer repayment term.

Withdrawals and Distributions

Upon severance of employment due to death, disability, or retirement, a participant or beneficiary will receive a lump sum amount equal to the value of the participant's vested interest in his or her account or may choose to receive payment in the form of an annuity or any other form of payment as provided for by the Plan. Upon termination of service for a reason other than normal retirement, death, or disability, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution.

1. **DESCRIPTION OF PLAN**

Plan Expenses

Plan expenses are generally allocated among all participant accounts. These expenses will be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of Participants in the Plan.

Forfeited Accounts

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan and are used to reduce employer matching contributions. At September 30, 2024 and 2023, forfeited, non-vested accounts totaled approximately \$3,230 and \$1,973, respectively. Employer contributions were reduced by \$3,230 and \$1,973 from forfeited, non-vested accounts in 2024 and 2023, respectively.

2. **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. As of September 30, 2024 and 2023, the Plan's investments are reported at fair value because the Plan holds no fully benefit-responsive investment contracts.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments in mutual funds are valued based on the quoted market prices.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments.

2. **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Investment Valuation and Income Recognition

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from the financial statements. Investment-related expenses are included in net appreciation/depreciation in fair value of investments. Administrative expenses of the Plan are allocated to participant accounts.

Cash and Cash Equivalents

The Plan considers all highly liquid investments with an original maturity of three months or less to be cash equivalents. Cash and cash equivalents consist primarily of a demand deposit account, which is stated at cost which approximates fair value.

Payment of Benefits

Benefit distributions to participants are recorded when paid by the Plan.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability. The Plan distributes the excess contributions to the applicable participants the subsequent year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are charged to the participant's account and are included in administrative expenses when incurred. As of September 30, 2024 and 2023, no allowance for credit losses has been recorded. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

3. **FAIR VALUE MEASUREMENTS**

The Plan has adopted Accounting Standards Codification 820, *Fair Value Measurement Disclosures* ("ASC 820"). ASC 820 established a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities inputs (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

3. FAIR VALUE MEASUREMENTS

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation methods described in Note 2 may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. GUARANTEED INTEREST ACCOUNTS

Through its contract with John Hancock Life Insurance Company, participants may invest in guaranteed interest accounts. John Hancock maintains the contributions in the Company's general accounts. Participant accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment accounts are not considered to be fully benefit-responsive, the accounts are presented on the statement of net assets available for benefits at fair value. Participant accounts may be subject to market value adjustments upon withdrawal.

The guarantee is based on John Hancock's ability to meet its financial obligations from its general assets. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

4. GUARANTEED INTEREST ACCOUNTS

There is no contract rate or minimum rate for the guaranteed accounts. Interest rates are established on the first date of each calendar month and apply to all regular contributions made to the guaranteed account in that month. This is called the “new money” regular rate. At the end of each year, a “composite rate” of interest is determined for each participant’s account, depending on the amounts contributed and the rate in effect on the day it is allocated to the participant account. The composite rate is the effective annual rate earned by all contributions to that guaranteed account during the year for that participant. Contributions continue to earn the calculated composite rate for the duration of the guarantee term.

5. INFORMATION CERTIFIED BY CUSTODIAN

The following is a summary of the unaudited information regarding the Plan, included in the Plan’s financial statements and supplemental schedule that was prepared by or derived from information reported by the Custodian of the Plan for 2024 and 2023. The Plan Administrator has obtained certifications from the Custodian that such information is complete and accurate at September 30, 2024 and 2023.

6. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust were designed in accordance with the applicable regulations of the Internal Revenue Code (“IRC”). Although the Plan has been amended and restated since receiving the opinion letter, the Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provisions for income taxes have been included in the Plan’s financial statements.

6. INCOME TAX STATUS

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. ADMINISTRATIVE COSTS

During the year ended September 30, 2024, the Smoky Mountain Home Health and Hospice, Inc. 401(k) Profit Sharing Plan incurred administrative costs of \$61,480. These administrative fees were paid by Smoky Mountain Home Health and Hospice, Inc. 401(k) Profit Sharing Plan. Other administrative fees were paid by the Plan Sponsor.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

9. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

During 2024, the Plan paid administrative fees to the Plan Advisor, Thoroughbred Financial Services, LLC, and to the third-party administrator, Employee Benefit Services.

10. RISKS AND UNCERTAINTIES

The Plan's investments include mutual funds, pooled separate accounts and guaranteed interest accounts. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities and the levels of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's financial statements and supplemental schedules.
