**(1) Description of Plan**

The following description of the Larson Dairy, Inc. Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the summary plan description or the plan agreement for a more complete description of the Plan's provisions.

**(a) General**

The Plan is a defined contribution plan covering all eligible employees of Larson Dairy, Inc. and, effective January 1, 2008, J.M. Larson, Inc. (collectively referred to as the Company or the Plan Sponsor) and was originally established July 1, 1972.

Eligibility provisions include completion of one year of service prior to July 1 or January 1 of each year. In addition, a terminated participant with more than 500 hours in the current plan year will still be considered an active participant for that plan year, should the participant be re-employed at a later date.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's trustee is Great West Trust Company, LLC (Great West). Empower Retirement, LLC (Empower) serves as recordkeeper for the Plan.

Effective October 1, 2022, the Plan was restated and 401(k) provisions were added, allowing employees to make elective deferral contributions and employers to make elective matching contributions. In addition, entry dates were modified to be the first day of each Plan year quarter, provisions allowing participants to direct their investments were added, and other administrative provisions were updated.

**(b) Contributions**

Prior to October 1, 2022, contributions to the Plan were determined at the discretion of the Company's Board of Directors and were funded currently. The participants were eligible to share in the contributions if they were employed on the last day of the plan year and have completed 1,000 hours of service during the plan year.

Effective October 1, 2022, the Plan was amended to allow employees to elect pretax contributions of up to 100% of their eligible annual compensation, as defined in the Plan Agreement, subject to certain IRS limitations. The Plan also allows employees to elect Roth after-tax contributions, and provides for discretionary employer matching contributions.

The Plan also provides for an employer profit sharing contribution, at the discretion of the Company's Board of Directors. The participants are eligible to share in the contribution and employer matching contributions if they are employed on the last day of the plan year and meet other eligibility provisions.

**(c) *Participants' Accounts***

The Company's annual contribution is allocated to participants based on the ratio of the individual participant's basic compensation to the basic compensation of all participants entitled to share in the allocation.

Through June 30, 2024, investments were not self-directed by participants. Investment earnings or losses are allocated to active and former participants in the ratio of the individual participant's account balance to the total balance of all participants' accounts as of the first day of the plan year. However, if the account of a former participant has been distributed prior to the plan year end, the former participant does not share in any allocation of investment earnings or losses.

**(d) *Vesting***

Employer contributions and accrued earnings vest to participants as follows:

Participants shall also be 100% vested upon the occurrence of any of the following events: (1) reaching normal retirement age, (2) death or disability, and (3) termination of the plan.

**(e) *Payments of Benefits***

Payments of benefits of the vested portion of participants' accounts are made only after a one year break in service occurs. Payments may be made in a lump sum or on a periodic basis.

**(f) *Forfeited Accounts***

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$4,434 and \$4,220, respectively. These accounts will be reallocated to participants in the same manner as employer contributions.

**(2) *Summary of Significant Accounting Policies***

**(a) *Basis of Accounting***

The Plan maintains its accounting records on the accrual basis of accounting which recognizes revenues when earned and expenses when incurred. Purchases and sales of investments are recorded on a trade-date basis.

**(b) *Valuations of Investments and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes realized gains and losses on investments bought and sold during the year as well as unrealized gains and losses on investments held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan's investments are invested in various types of investment securities and in various companies within various markets. Investment securities are exposed to several risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect the amounts reported in the Plan's financial statements and schedules.

**(c) *Administrative Expenses***

Administrative fees consist of management fees paid to the Trustee. The audit expenses of the Plan are currently paid voluntarily by the Company. In addition, the Company provides certain recordkeeping and other administrative services to the Plan at no cost.

**(d) *Tax Status***

A favorable tax determination letter dated June 30, 2020 has been received covering the Plan agreement, which states that the Plan, as designed, is qualified under Section 401 of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

**(e) *Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

(3) *Fair Value of Investments (Unaudited)*

The Plan follows the provisions of the Fair Value Measurements and Disclosures Topic of the FASB ASC, which established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(4) Non-Exempt Transactions**

During the year ended June 30, 2024, certain employee deferrals totaling \$481 were not transferred by the Sponsor to the Trustee in a timely manner in accordance with the Department of Labor requirements. The contributions, including lost earnings, were transferred into the Plan during November 2023.

**(5) Plan Amendment and Termination**

The Plan may be further amended or terminated by the Company, but no amendment may deprive participants of their vested interest. If the Plan is terminated, the interest of each participant may be distributed in a lump sum in cash, in periodic installments, or used to purchase an annuity.

**(6) Risks and Uncertainties**

The Plan invests in various investment funds that are subject to various risks that determine the value of the fund. Due to the level of risk associated with certain financial instruments and the level of uncertainty related to changes in the value of these investments, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

**(8) Subsequent Events**

In preparing these financial statements, management has evaluated subsequent events and transactions for potential disclosure through April 29, 2025, the date the financial statements were available to be issued.

Effective July 1, 2024, the Company's board of directors amended the Plan to add provisions requiring automatic enrollment of new eligible participants with a pretax deferral of 3% and providing for an employer matching contribution equal to 100% of the participants' first 1% contribution and 50% of the participants' remaining contribution up to 6%, and participant investments became self-directed. The Company also elected to discontinue funding the discretionary profit sharing contribution beginning July 1, 2024.
