### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Hilco 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2023, and the related notes to the financial statements.

#### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Hilco 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

#### **Plan Amendment**

The Plan was amended effective September 1, 2024 to recognize prior year service with Crestwood Transportation, LLC.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Hilco Transport, Inc. (the "Company"), the Plan sponsor. Employees become eligible to participate in the Plan on the first day of the calendar quarter following one year of employment and attaining age 21. Effective February 1, 2023, the Plan was amended to reduce the eligibility requirement to 6 months of service, reduce the age to 18, and change plan entry to monthly. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan. The Plan Sponsor and Investment Manager determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan administrator.

#### **Contributions**

Each year, participants may contribute up to 100% of their annual pre-tax compensation, as defined in the Plan, up to the maximum allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make qualified Roth contributions to the Plan and may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

As of February 1, 2023, after completing 6 months of eligible service, the Company makes safe harbor contributions equal to 100% of the first 4% of eligible compensation that a participant contributes to the Plan. The Company may also make discretionary matching and profit sharing contributions. There were no discretionary Company profit sharing or additional matching contributions made during the Plan year ended December 31, 2023. Contributions are subject to certain limitations as determined by the Internal Revenue Code.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, including amounts rolled over from other qualified plans, and Company matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### NOTE 1 - DESCRIPTION OF PLAN (Continued)

##### **Vesting**

Participants are vested immediately in their voluntary contributions, including amounts rolled over from other qualified plans, plus actual earnings thereon. Participants are 100% vested in the Company's safe harbor matching contributions immediately. Vesting in the Company's discretionary contributions and any actual earnings thereon is determined using a graded schedule based on years of continuous service with participants 100% vested after six years of credited service or in the event of death and disability, as defined by the Plan.

##### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. A participant may have one outstanding loan at a time. The loans are secured by the balance in the participant's account and bear interest at prime rate, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratable through regular payroll deductions.

##### **Payment of Benefits**

The Plan permits withdrawals when a participant terminates employment, reaches normal retirement age or becomes disabled or deceased. Upon termination, participant consent is not required for distributions of an account balance less than \$5,000. In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 59 1/2. Benefits are payable in lump-sum or partial payments.

##### **Forfeited Accounts**

Forfeited nonvested accounts totaled \$1 and \$5,945 as of December 31, 2023 and 2022, respectively. These accounts may be used to pay administrative expenses or to reduce future Company contributions. During 2023, \$3,295 of forfeitures were used by the Company to reduce administrative expenses and \$4,131 were used to reduce Company contributions.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

##### **Contributions**

Contributions from Plan participants and the safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation of fair value of investments. Expenses relating to specific transactions, such as loan setup and distribution fees are paid directly by the participant and are included in administrative expenses.

##### **Subsequent Events**

The Plan has evaluated events and transactions for potential recognition or disclosure through April 30, 2025, which is the date the financial statements were issued.

#### NOTE 3 - INFORMATION CERTIFIED (Unaudited)

#### NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

#### NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value collective trust fund:* A stable value fund that is composed primarily of benefit-responsive investment contracts that is valued using the NAV, provided by the administrator of the trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### NOTE 6 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of investment funds managed by Reliance Trust Company and related affiliates, the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Plan trustee services, recordkeeping, transaction processing, and loan maintenance services were provided by American Trust Company and related affiliates and StanCorp Financial Group and related affiliates, therefore, fees associated with these services qualify as party-in-interest transactions. Investment advisory services were provided by Fund Direct Advisors. Fees associated with these services qualify as party-in-interest transactions. The Company pays directly any other fees related to the Plan's operations.

The Plan may receive revenue sharing payments from the mutual fund service providers, which offset fees paid by the Plan. Investment fees in excess of revenue sharing amounts are allocated to participant accounts and expensed.

#### NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company discretionary contributions.

#### NOTE 8 - TAX STATUS

Effective February 1, 2023, the Plan adopted a prototype plan sponsored by Standard Retirement Services, Inc. The prototype plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

#### NOTE 8 - TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
