We have performed the audits of the financial statements of 401(k) Plan of PeoplesBank, A Codorus Valley Company (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of September 30, 2024 (in liquidation) and December 31, 2023 (ongoing), the related statement of changes in net assets available for benefits for the period January 1, 2024 through September 30, 2024 (in liquidation) and the year ended December 31, 2023 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and December 31, 2023, and for the period January 1, 2024 through September 30, 2024 and the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis

As discussed in Note 1 to the financial statements, the Board of Directors of PeoplesBank, the Plan's sponsor, voted on June 11, 2024 to terminate the Plan, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Note 1 - Description of Plan

The following description of the 401(k) Plan of PeoplesBank, A Codorus Valley Company (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General and Plan Termination

The Plan is a defined contribution pension plan covering substantially all employees of PeoplesBank (the Company) who have completed the employment probationary period (generally three months but not to exceed one year) and have attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On June 11, 2024, the Board of Directors voted to terminate the Plan with an effective date of June 30, 2024. As a result, management determined that liquidation was imminent. On June 30, 2024, a Notice of Intent to Terminate and Notice to Interested Parties was distributed to plan participants. As of this termination date, no new participants were entered into the Plan, all participant balances were immediately vested, and contributions were ceased. All accounts in excess of \$1,000 were rolled over into an individual retirement account or annuity in instances where the participant made no election. Final assets were liquidated by September 30, 2024.

Contributions

Prior to termination, participants could elect to defer from 1% to 100% of their compensation, as defined in the Plan. The Plan also allowed participants to make Roth contributions. These contributions were subject to limitations under federal law. Participants who had attained the age of 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of all contributions into various investment options offered by the Plan. If a participant failed to provide such direction, contributions were invested in the Vanguard Target Retirement Fund appropriate for the participant's expected retirement age (65). The Company provided an employer safe harbor matching contribution of 100% of the first 4% of compensation that a participant contributed. Contributions were subject to certain IRS limitations.

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their salary deferrals including Roth contributions, catch-up contributions, rollover contributions, and employer safe harbor matching contributions, plus actual earnings thereon.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Forfeited Accounts

Forfeited nonvested accounts, if any, were used to pay administrative expenses or reduce future employer contributions. Forfeited nonvested accounts at December 31, 2023 were immaterial.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

Due to the decision to terminate the Plan during 2024, management determined that liquidation of the Plan was imminent and the financial statements for 2024 have been prepared using the liquidation basis of accounting. The 2023 financial statements were prepared as a going concern on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

All investments reported in the 2024 statement of net assets available for benefits are reported at liquidation value. For all investments, fair value approximates the amount the Plan expects to collect at liquidation.

All investments on the 2023 statement of net assets available for benefits are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income for the period January 1 through September 30, 2024 is recorded on the liquidation basis, including amounts expected to be earned through the final distribution of Plan assets. Dividend income for the year ended December 31, 2023 is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Investment related expenses were included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Note 3 - Information Certified and Provided by VOYA Retirement Insurance and Annuity Company (VRIAC)

Certain information related to investments disclosed in the accompanying financial statements, including investments held at September 30, 2024 and December 31, 2023, and net appreciation in fair value of investments, and interest and dividends for the period January 1, 2024 through September 30, 2024 and the year ended December 31, 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by VRIAC, the custodian of the Plan.

Note 4 - Fair Value Measurements

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2023.

Pooled separate accounts are primarily valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Fully Benefit-Responsive Investment Contract

The Plan held a traditional investment contract. This contract met the fully benefit-responsive investment contract criteria and, therefore, was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan was a guaranteed investment contract. The contract issuer was contractually obligated to repay the principal and interest at a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer, but could not be less than 1.00%. The crediting rate is reviewed on a quarterly basis for resetting. The contract was terminated upon termination of the Plan.

Note 6 - Tax Status

The Company adopted a nonstandardized pre-approved profit sharing plan sponsored by Conrad M. Siegel Inc. The nonstandardized pre-approved profit sharing plan has received an opinion letter from the IRS, dated June 30, 2020, stating that the nonstandardized pre-approved profit sharing plan was qualified under the appropriate section of the IRC. The nonstandardized pre-approved profit sharing plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. The plan administrator believes that the Plan is designed and was operated in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. Federal, state, or local tax authorities for years before 2021.

Note 7 - Related Party Transactions and Party-In-Interest Transactions

The Plan invested in certain pooled separate accounts and a guaranteed investment contract managed by VRIAC. VRIAC is the custodian as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management and custody services were immaterial.

Note 8 - Reconciliation of Financial Statements to the Form 5500

The Plan invested in various pooled separate accounts (PSAs) that do not file a Form 5500 as a Direct Filing Entity. Accordingly, on the Form 5500 filed by the Plan, the percentage of the interest in the underlying assets of the PSAs must be reported in the appropriate categories on the asset and liability statement of the Form 5500 for the Plan.
