### NOTE 1 - DESCRIPTION OF PLAN

The following description of Scooterbug, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The plan administrator and trustee are responsible for the oversight of the Plan.

#### **General**

The Plan is a qualified contribution plan covering all full-time employees of Scooterbug, Inc. (“Company” or “Employer”), as well as Safemark, Inc. and Best Lockers, LLC. The Plan was established in January 2005 and most recently restated and amended January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The plan administrator and trustee are responsible for the oversight of the Plan.

#### **Eligibility**

Employees of the Company are eligible to participate in the Plan after reaching the entry date following the date of hire. Plan entry date is the 1<sup>st</sup> day of the month following eligibility.

#### **Contributions**

Subject to certain limitations, under the Internal Revenue Code (“IRC”) Section 401(k), participants may contribute up to the maximum amount allowed by law, subject to 2023 annual limits of \$22,500 and an additional \$7,500 for catch-up contributions for participants that are age 50 or older. Each year, participants may contribute up to 100% of compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make a discretionary matching contribution on behalf of each participant. During the year ended December 31, 2023 the Company matched 50% of salary deferrals up to 6% of compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant’s contributions and Company matching contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Participants are immediately vested in their elective contributions, as well as any rollover contributions, plus or minus actual earnings or losses thereon.

**Vesting (continued)**

Vesting in the remainder of their account (employer discretionary matching and nonelective contributions) is based on years of credited service (as defined by the Plan) as follows:

Five	100%

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account.

The loan interest rate, determined as loans are requested, is based on a commercially reasonable rate of interest established by the Administrator, which is generally the prime rate plus 1.0%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or a partial withdrawal of the participant's vested interest.

**Forfeited Accounts**

At December 31, 2023 and 2022, forfeited non-vested accounts totaled approximately \$12,500 and \$2,000, respectively. These accounts will be used to reduce future employer contributions or to pay expenses. During 2023, forfeitures of approximately \$2,000 were used to pay plan expenses.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES *(continued)*

##### **Investment Valuation and Income Recognition**

Plan investments are stated at fair value. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, as contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions and reinvested income, less any withdrawals, plus accrued interest.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

##### **Plan Expenses**

Certain expenses incurred in the administration of the Plan are paid by the plan sponsor. Expenses such as loan processing and investment transaction fees are charged directly to the participant's account. For the year ended December 31, 2023, administrative expenses incurred by the Plan totaled \$24,145.

##### **Payment of Benefits**

Benefits are recorded when paid.

#### NOTE 3 - INVESTMENT INFORMATION CERTIFIED BY THE PLAN CUSTODIAN

The Plan contracted with Capital Bank and Trust Company ("American Funds") to manage and invest the assets of the Plan and maintain participant account records. Participants can direct which account(s) their contributions are to be invested in and may change investment vehicles at any time.

The investment information included in the accompanying financial statements has been certified by American Funds as complete and accurate. Incorporation of this financial information in the accompanying financial statements and supplemental schedule is based solely on that certification.

#### NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

#### NOTE 4 - FAIR VALUE MEASUREMENTS (continued)

The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, are described as follows:

- Level 1: Quoted market prices in active markets for identical assets or liabilities.
- Level 2: Observable market-based inputs or unobservable inputs that are corroborated by market data.
- Level 3: Unobservable inputs that are not corroborated by market data.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Money Market Funds:** Stated at cost, which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All plan investments, as described above, are deemed to be Level 1 investments and are measured at fair value on a recurring basis.

#### NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

#### NOTE 6 - TAX STATUS

The Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has not requested a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. The plan administrator believes that the adopted and amended Plan continues to qualify and will remain exempt from federal income taxes under Section 401(a). As of December 31, 2023, with certain exceptions, the Plan is no longer subject to income tax examinations by U.S. federal taxing authorities for any tax years before 2020.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. The Plan holds investments managed by American Funds, the plan custodian, which qualify as party-in-interest investments. The plan's payments of custodian fees to American Funds and audit fees qualify as party-in-interest transactions.

**NOTE 9 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events and transactions that occurred after December 31, 2023 up to the date that the financial statements were available to be issued. Effective January 1st 2024, the Plan adopted a resolution to merge in the assets of another plan sponsored by a related company. All assets of that plan were transferred into Scooterbug, Inc. 401(k) Plan during 2024. As this transaction became effective after year end, the effects of this merger are not reflected in the financial statements as of and for the year ended December 31, 2023.
