### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Naman, Howell, Smith & Lee, P.L.L.C. Employees Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended September 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

September 30, 2024 and 2023

(1) Description of Plan

The following description of the Naman, Howell, Smith & Lee, P.L.L.C. (the “Company”) Employees Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering all employees of the Company who have one year of service with a thousand hours and are age twenty-one or older. Beginning January 1, 2024, employees who complete at least 500 hours up to 999 hours of service in the prior three consecutive years are eligible to participate in the Plan (“long-term part-time employees”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

(b) Contributions

Participants may contribute pre-tax annual compensation up to the annual maximum amount, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”). Participants direct the investment of their contributions into various investment options offered by the Plan. Long-term part-time employees are excluded from Company contributions. The Company contributes a discretionary employer contribution of 3% of each eligible employee’s annual wage. Each year, the Company may also contribute profit sharing amounts to the Plan at the discretion of the Company’s management. Contributions are subject to certain limitations. Unallocated Company contributions were \$1,495,000 and \$1,350,000 at September 30, 2024 and 2023, respectively.

(c) Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions, where applicable, (b) Plan earnings, and (c) forfeitures of terminated participants’ nonvested accounts and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

(d) Vesting

Participants are immediately vested in their contributions and, where applicable, the Company's discretionary employer contributions plus actual earnings thereon. Vesting in the Company's profit sharing contribution portion of applicable participant accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

(e) Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

(f) Risks and Uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

(g) Forfeited Accounts

At September 30, 2024 and 2023, there were \$19,785 and \$11,743, respectively, of forfeited nonvested funds available for allocation. These amounts will be allocated to the participants as if the forfeiture were an additional employer non-elective contribution. Forfeitures allocated to participants in 2024 and 2023 amounted to \$11,743 and \$25,337, respectively.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

(b) Investments

The Plan provides for self-directed investment programs for individual participants. The Plan's investments, except for the unallocated investment contract with an insurance company, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

The unallocated investment contract with an insurance company is a stable value fund (Guaranteed Fixed Interest Fund IV) which invests in one group annuity contract which is a fully benefit-responsive investment contract. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to direct investments in fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of Benefits

Benefits are recorded when paid.

(d) Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided in the Plan Agreement. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan and registered investment advisor fees are paid by the Plan and recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

(e) Income Taxes

The Plan recognizes the effect of income tax positions only if those positions are more likely than not of being sustained. Recognized income tax positions are measured at the largest amount that is greater than 50% likely of being realized. Changes in recognition or measurement are reflected in the period in which the change in judgment occurs.

(f) Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) Information Certified by the Trustee

The financial information included in the Plan financial statements, except for self-directed brokerage accounts and related investment income, contributions receivables, contributions, benefits paid to participants, and administrative expenses, have been derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan, in accordance with Section 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA.

(4) Unallocated Investment Contract with an Insurance Company

The following methods and assumptions were used to report the value of the unallocated investment contract with an insurance company:

The unallocated contract is a stable value investment option (Guaranteed Fixed Interest Fund IV) (the "Fixed Fund") under a contract with Standard Insurance Company. Contract value represents contributions made under the contract plus interest at the contract rate, less benefit payments and administrative expenses. The primary objective of the Fixed Fund is to preserve principal while generating returns in excess of money market funds. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest at the start of each quarter and is locked-in and will not change for the entire quarter. The minimum rate cannot fall below 1%, and there is no stated maximum interest rate for the Fixed Fund. Participant withdrawals and transfers are freely

permitted on a daily basis. The Fixed Fund provides participants with full book value liquidity for benefit payments and transfers to other non-competing investment options. No penalties, fees, or surrender charges apply. There are no unfunded commitments as of September 30, 2024 and 2023.

(5) Fair Value Measurements

Generally accepted accounting principles establish a framework for measuring fair value. This framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the asset or liability.

The level in the fair value hierarchy within which a financial instrument in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

The following methods and assumptions were used to estimate the fair value of each class of financial instruments:

*Mutual funds:* Valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. Mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Self-directed brokerage accounts are mainly comprised of common stocks and mutual funds. The common stocks are valued at the closing price reported on the active market on which the individual securities are traded multiplied by the number of shares held at year-end. The mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. Mutual funds held by the Plan are deemed to be actively traded.

(5) Fair Value Measurements (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(6) Tax Status

The Plan is using a standardized volume submitter profit-sharing plan document. In a letter dated June 30, 2020, the Internal Revenue Service ("IRS") indicated the form of the Plan is acceptable under Section 401 of the Internal Revenue Code (the "Code"). The opinion of the IRS regarding the acceptability of the form of the Plan is not a ruling or determination as to whether the Plan qualifies under Code Section 401(a). Although the Plan has been amended since receiving the acceptability letter, the Plan Administrator believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer profit sharing accounts.

(8) Party-In-Interest Transactions

Certain Plan investments are interest-bearing cash and shares of mutual funds managed by Fidelity Management & Research Company (“FMR”). Fidelity Management Trust Company, an affiliate of FMR, is the trustee defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. National Financial Services provides brokerage services to participants with self-directed brokerage accounts. National Financial Services is an affiliate of FMR and, therefore, these transactions qualify as party-in-interest transactions.

The Plan has not considered contributions to the Plan or benefits paid by the Plan to participants as party-in-interest transactions.

(9) Subsequent Events

The Plan has evaluated subsequent events from the date of the statements of net assets available for benefits through April 29, 2025, the date at which the financial statements were available to be issued and determined there are no items to disclose.
