Eligibility Requirements

Each employee becomes a Participant on the Plan Entry Date on or next following the attainment of age 21 years and the completion of 1 Year of Service.

Plan Entry Dates

An eligible employee will participate in the Plan on the July 1 on or next following completion of the eligibility requirements.

Credited Service

Definition

Prior to September 1, 1977, under the terms of the prior Plan.

On or after September 1, 1977, all Plan Years with 1,000 or more Hours of Service.

Compensation

Definition

Compensation is the total compensation received by the Participant for the prior calendar year, including bonuses, overtime and commissions and any amounts deferred under a qualified 401(k), 403(b) or 125 Plan. Excluded are amounts for other fringe benefits, moving expenses, automobile allowances, taxable values of employer--paid group term life insurance, and any other special forms of payment.

Final Average

Highest three (3) out of the last five (5) years of compensation, subject to a maximum limit of \$25,000.

Vesting

All Participants shall be vested according to the following schedule:

Years of Service	% Vested
0-4	0%
5	100%

All participants shall be 100% vested upon attainment of their normal retirement date.

Vesting Benefit

The vested benefit shall be the vested portion of the Accrued Benefit as of the date of determination.

Normal Retirement

Eligibility

The normal retirement date for each Participant is the first of the month on or next following the later attainment of age 65, and the 5-year anniversary of Plan participation.

Benefit

The amount of annual retirement benefit payable according to the normal form of payment is calculated as follows:

- 1.0% of Final Average Compensation (FAC) multiplied by Years of Credited Service

Minimum Benefits

The Normal Retirement Benefit shall be no less than the Normal Retirement Benefit the Participant had accrued as of February 26, 2002.

Accrued Benefit

The Monthly Accrued Benefit, with respect to the formula above, as of any date, is calculated using actual service and compensation as of the date of determination.

Delayed Retirement

Eligibility is the first of the month on or next following the actual date the Participant terminates employment after Normal Retirement Date. The Benefit is based on service and final average compensation as of the actual retirement date or actuarial equivalent of Normal Retirement Benefit, if greater.

Early Retirement

Eligibility

Eligibility is contingent upon the attainment of age 55 and the completion of 10 years of Vesting Service.

Benefit

A Participant may retire on the first day of any month following attainment of eligibility. The amount of the monthly early retirement benefit is the Participant's Accrued Benefit reduced to reflect the early commencement of payments.

The reduction is 6% for each year which the benefit commences prior to Normal Retirement Date.

Disability Retirement

Eligibility

Age 55, 10 Years of Service and eligible for and receiving disability benefits under the Social Security Act or permanently disabled due to a job-related injury or disease and receiving Workman's Compensation.

Benefit

Accrued Benefit as of the Disability Retirement Date.

Payments

The first day of the month on or next following the date a Participant meets the disability requirements established in the Plan.

Death Benefit

Eligibility

Eligibility is contingent upon the vesting date and a minimum of 1 year of marriage.

Benefit Definition

A benefit computed assuming the Participant had terminated on date of death and had elected a 50% Joint and Survivor Annuity.

Payment

Monthly benefit at what would have been the Participant's Earliest Retirement Date, in the case of the 50% Joint and Survivor Annuity.

Post-retirement Death Benefits

Post-retirement Death Benefits are dependent upon the form of payment selected.

Methods of Payments

Under the Normal Form of payment, a Participant's retirement annuity is payable monthly for life, without further payments after death. A Participant may elect to receive the benefit under one of the following actuarially-equivalent optional modes:

- A reduced benefit is paid to the Participant for life, with such benefit (50%, 67% or 100% of such benefit thereof) continued after death for the subsequent lifetime of the eligible spouse.
- A reduced benefit is paid to the Participant for life, with 120, 180 or 240 monthly payments guaranteed. If the Participant dies within the guarantee period, the payments continue to a beneficiary until 120, 180 or 240 have been paid.
- A lump sum payment of the actuarial equivalent of the participant's retirement benefit, provided the amount does not exceed \$10,000.

Unless the Participant has elected an option above, it is automatically assumed that a Participant, who has been married for at least one year, has elected a Joint and Survivor option with one-half of the initial amount continuing to the surviving spouse as contingent annuitant.

Contributions

The entire cost of the plan is borne by the Employer.

Amendments

The employer reserves the right to amend the Plan at any time.

Generally, the Pension Benefit Guaranty Corporation reserves the right to terminate the Plan if the Employer fails to meet the minimum funding standards, or is unable to pay benefits when due. If the Plan is terminated, the plan assets will be distributed among the plan participants based upon a priority allocation procedure, and the Employer shall be liable for any unfunded vested benefits to the extent required by law.
