NOTE 1: DESCRIPTION OF PLAN

The following description of the Westmoreland Community Action 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document of Summary Plan Description for a more complete description of the Plan's provisions.

A. General

The Plan is a 403(b) tax-sheltered annuity retirement plan covering substantially all employees of Westmoreland Community Action (the Agency). The Agency has been established under the Laws of Commonwealth of Pennsylvania and are organized and operated exclusively for charitable, educational, and/or scientific purposes.

Employees of the Agency are eligible to participate in elective salary reduction deferral (employee) contributions immediately upon hire by the Agency and are eligible to receive matching (employer) contributions when they have attained age 21 and completed one year of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective April 1, 2012, the Plan was amended and restated to comply with final regulations under section 403(b) of the Internal Revenue Code of 1986, as amended, and to make certain other changes. The amendments did not have a significant effect on benefits or net assets.

The Board of Directors of the Agency is responsible for oversight of the plan. The Trustees determine the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

B. Contributions

Participants may contribute from a minimum of \$200 up to the maximum allowed by the Internal Revenue Code through employee elective salary deferrals. The Agency matches up to 8% of employee contributions. There are no minimum age or service requirements to make elected deferrals into the plan, however, to be eligible to receive matching contributions an employee must be at least 21 years of age and work 1,000 hours during the 12 month period immediately following their date of hire. Once eligibility has been satisfied, an employee may begin participating on the next entry date of either January 1 or July 1.

Participants are also allowed to contribute on an after-tax basis by designating their deferrals as Roth deferrals, on which participants are taxed as they contribute, and amounts can be withdrawn tax free. Matching of Roth deferrals is consistent with pre-tax deferrals at 8%, and all eligibility requirements remain the same. Roth deferrals are also regulated by the Internal Revenue Code.

C. Participant Accounts

Each participant's account is credited with their allocations of the employee's and the Agency's contribution and Plan earnings and charged with an allocation of investment and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting

Participants are vested immediately in all employee and employer contributions plus actual earnings thereon.

E. Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest rates that are commensurate with rates charged by other lenders on similar loans. As of June 30, 2024 and 2023 the plan had loans receivable from participants with principal balances totaling \$183,212 and \$142,355, respectively.

F. Payment of Benefits

Plan benefits begin at the normal retirement age of 65, however, in service distributions can commence upon age 59 ½. Participants who have attained their retirement age shall have a 100% non-forfeitable right in the value of their account. Upon termination of employment due to death, disability, retirement, or other separation participants or their beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum payment or in annual installments over a period of not more than the participants assumed life expectancy. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

G. Plan Termination

Although it has not expressed any intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

H. Related Party Transactions

Plan investments consist of shares of mutual funds and annuities managed by Lincoln National Life Insurance Company, Empower Retirement and One America. Lincoln National Life Insurance Company, Empower Retirement and One America are trustees of the Plan and, therefore all transactions with the trustees qualify as party-in-interest transactions exempt from prohibited transaction rules.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting and in conformity with generally accepted accounting principles.

B. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of June 30, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the loan to be in default, the loan balance is reduced, and the delinquent participant loan receivable is recorded as a benefit payment based on the terms of the Plan Document.

E. Payment of Benefits

Benefits are recorded when paid.

F. Subsequent Events

Subsequent events have been evaluated through April 15, 2025, which is the date the financial statements were available to be issued.

NOTE 3: PLAN ADMINISTRATION

The Plan is administered by the Agency. The Plan is responsible for payment of all administrative expenses. For the years ended June 30, 2024 and 2023, such expenses totaled \$27,320 and \$31,499, respectively. All other administrative costs (i.e. payroll costs related to administration of the Plan) are paid by the Agency and not a deduction from Plan net assets.

NOTE 4: TAX STATUS

The Internal Revenue Service does not currently have a process for this type of plan to be submitted for a determination letter. However, the Plan's tax counsel believes that the Plan is designed, and the Plan administrator believes that the Plan is currently operating, in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained up examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5: INVESTMENTS AND FAIR VALUE MEASUREMENTS

During 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated/(depreciated) in value by \$912,525 and \$685,184, respectively. Interest income on the guaranteed investment contract and loans receivable were \$20,754 and \$14,447 during 2024, and 2023, respectively.

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 or 2023.

Registered Investment Companies: Mutual funds with One America and Lincoln National Life Insurance Company are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. There have been no changes in the methodologies used at June 30, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6: INVESTMENT CONTRACTS WITH INSURANCE COMPANY

The Plan has fully benefit responsive guaranteed investment contracts with American United Life Insurance Company and Lincoln National Life Insurance Company. Participant contributions to these contracts are deposited in a general account. The accounts are credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses. The guaranteed investment contracts issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. These contracts meets the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value approximates fair value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contracts at June 30, 2024 and 2023 was \$792,947 and \$812,644, respectively. All contributions and transfers to the contract will earn interest at the guaranteed rate in effect at the time of the contribution or transfer. All monies in the investment contract will earn interest at the guaranteed rate until the guaranteed rate is changed. American United Life Insurance Company and Lincoln National Life Insurance Company may declare a new guaranteed rate for the investment contracts that becomes effective on January 1st.

NOTE 6: INVESTMENT CONTRACTS WITH INSURANCE COMPANY

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, (4) the failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 8: CERTIFIED FINANCIAL INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at June 30, 2024, and net appreciation in fair value of investments and interest and dividends, for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Retirement, One America and Lincoln National Life Insurance Company (the trustee/custodian) of the Plan.

The following information certified by Empower Retirement, One America and Lincoln National Life Insurance Company was relied upon in the preparation of the 2024 and 2023 financial statements:
