### Note 1 - Plan Description

The following description of GFL Environmental Services USA, Inc. Safe Harbor 401(k) Profit-Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of GFL Environmental Services USA, Inc. (the "Company") who have completed two months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan includes provisions for automatic enrollment. Unless a participant elects otherwise, the participant's automatic deferral shall be 6 percent. Participant deferral rates increase by 1 percent at the beginning of each plan year, up to 10 percent, unless participants elect otherwise. The Plan allows participants to contribute up to 100 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer matching contributions of 100 percent of the first 1 percent of a participant's contribution, plus 60 percent of participant contributions that exceed 1 percent, not to exceed 6 percent of the employee's deferred compensation.

The Company can make annual discretionary contributions to the Plan, as approved by the Company's board of directors. The Company did not make any discretionary contributions during 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's portion of their accounts, plus actual earnings thereon, is based on years of service. Participants do not vest in contributions made by the Company until they become fully vested after two years of service.

#### **Benefit Payments**

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons or upon attainment of age 59½, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may request that all or a portion of their accounts, limited to participant contributions, be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

### Note 1 - Plan Description (Continued)

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Mutual of America Life Insurance Company or its affiliates. Mutual of America Life Insurance Company is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The Plan prepares its financial statements on the modified cash basis of accounting. Revenue is recorded when received rather than when earned, expenses are recorded when paid rather than when the obligation is incurred, and investments are recognized at fair value. Accordingly, the financial statements are not intended to be in conformity with accounting principles generally accepted in the United States of America.

#### ***Investment Valuation***

The Plan's investments are stated at fair value except as noted below.

The fully benefit-responsive guaranteed interest accounts are valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Use of Estimates***

The preparation of financial statements in conformity with modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including March 19, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Mutual of America Life Insurance Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances included in the accompanying financial statements are based solely on information certified by the Custodian as of December 31, 2022.

**Note 4 - Investment Contracts**

The Plan has a benefit-responsive investment contract with Mutual of America Life Insurance Company (Mutual). Mutual maintains the contributions in the general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates at Mutual are reviewed on a semiannual basis for resetting. When establishing interest crediting rates for its products, Mutual considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

**Note 5 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 6 - Plan Merger**

Effective January 1, 2023, the Plan merged and combined with the GFL Environmental US 401(k) Plan. Accordingly, all assets, participants, and their related account balances were transferred to the GFL Environmental US 401(k) Plan.

### Note 1 - Plan Description

The following description of GFL Environmental Services USA, Inc. Safe Harbor 401(k) Profit-Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of GFL Environmental Services USA, Inc. (the "Company") who have completed two months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan includes provisions for automatic enrollment. Unless a participant elects otherwise, the participant's automatic deferral shall be 6 percent. Participant deferral rates increase by 1 percent at the beginning of each plan year, up to 10 percent, unless participants elect otherwise. The Plan allows participants to contribute up to 100 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer matching contributions of 100 percent of the first 1 percent of a participant's contribution, plus 60 percent of participant contributions that exceed 1 percent, not to exceed 6 percent of the employee's deferred compensation.

The Company can make annual discretionary contributions to the Plan, as approved by the Company's board of directors. The Company did not make any discretionary contributions during 2022.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's portion of their accounts, plus actual earnings thereon, is based on years of service. Participants do not vest in contributions made by the Company until they become fully vested after two years of service.

#### **Benefit Payments**

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons or upon attainment of age 59½, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may request that all or a portion of their accounts, limited to participant contributions, be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

**Note 1 - Plan Description (Continued)**

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Mutual of America Life Insurance Company or its affiliates. Mutual of America Life Insurance Company is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan prepares its financial statements on the modified cash basis of accounting. Revenue is recorded when received rather than when earned, expenses are recorded when paid rather than when the obligation is incurred, and investments are recognized at fair value. Accordingly, the financial statements are not intended to be in conformity with accounting principles generally accepted in the United States of America.

***Investment Valuation***

The Plan's investments are stated at fair value except as noted below.

The fully benefit-responsive guaranteed interest accounts are valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Company.

***Use of Estimates***

The preparation of financial statements in conformity with modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including July 31, 2024, which is the date the financial statements were available to be issued.

Effective January 1, 2023, the Plan merged and combined with the GFL Environmental US 401(k) Plan. Accordingly, all assets, participants, and their related account balances were transferred to the GFL Environmental US 401(k) Plan.

**Note 3 - Certified Information**

Mutual of America Life Insurance Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year - modified cash basis are based solely on information certified by the Custodian.

**Note 4 - Investment Contracts**

The Plan has a benefit-responsive investment contract with Mutual of America Life Insurance Company (Mutual). Mutual maintains the contributions in the general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates at Mutual are reviewed on a semiannual basis for resetting. When establishing interest crediting rates for their products, Mutual considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

**Note 5 - Tax Status**

For the year ended December 31, 2021, the Plan was a prototype plan. The prototype plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Effective January 1, 2022, the plan document was restated to a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
