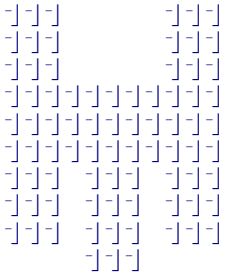

INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Xponent HR Solutions 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Xponent HR Solutions 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

1. **Description of Plan**

The following description of the Xponent HR Solutions 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- a) *General* – The Plan is a defined contribution plan sponsored by Xponent HR Solutions, LLC (the "Plan Sponsor") for the benefit of all employees of Seeman Holtz Property and Casualty, LLC and P & C Payroll Management, LLC (collectively "the Company"), except leased employees, non-resident aliens, and those covered under a collective bargaining agreement, who have at least one year of service to the Company, as defined, and have attained the age of twenty-one. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was formed on January 1, 2017, and restated in its entirety on January 1, 2022, as required by Internal Revenue Service's (IRS) restatement cycle.
- b) *Plan Administration* – The Plan is administered by management of the Company and by EJ Reynolds, Inc., a third-party administrator (TPA). The Plan's trustee is an officer and employee of the Company. As of December 31, 2023 and 2022, the record keeper, custodian and party which directs the custody and management of the Plan's assets is Empower Retirement (Empower).
- c) *Contributions* – Each year participants may contribute up to 100% of pretax annual compensation, as defined in the Plan and as subject to limitations defined by the Internal Revenue Code. The Plan does allow for after-tax Roth contributions as well. Participants may also contribute amounts representing distributions from other qualified plans. The Company makes a Safe Harbor nonelective contribution equal to 100% of salary deferrals that do not exceed 3% of compensation, plus 50% of salary deferrals between 3% and 5% of compensation.
- d) *Participant Accounts* – Each participant's account is credited with participant's contribution, the employer's matching contribution, Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan.
- e) *Vesting* – Participants are immediately vested in their contributions, as well as employer safe harbor contributions, plus actual earnings thereon.
- f) *Administrative Expenses* – Individual participants pay for loan fees and investment fees. Other fees and administrative costs associated with Plan operations and compliance are paid first from forfeitures and then from Plan Assets.
- g) *Investment Options* – Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options offered in the Empower program and determined by the Plan Administrator. Participants may change their investment options via phone or Internet access to Empower at any time.

1. Description of Plan, continued

- h) *Participant Notes Receivable* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their individual vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loans fund. Loan terms range from 1-5 years or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the loan administrator at the time the loan was taken. The interest rates on participant loans receivable as of December 31, 2023 and 2022 range from 4.25% to 8.75%. Principal and interest is paid ratably through weekly payroll deductions. Participant loans are reported at their unpaid principal balances plus any accrued interest. The loan balances are secured by the participants' investment accounts, therefore, no allowance for uncollectible loans was deemed necessary. For purposes of presentation on the schedule of assets held for investment purposes, the participant notes receivable are presented as part of the investments in the Form 5500 and are referred to as participant loans.
- i) *Payments of Benefits* – Upon retirement, disability, death, or termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period not to exceed the participant's life expectancy. Hardship distributions are allowed under the Plan as well as in-service distributions for participants that have attained age 59 ½.
- j) *Forfeited Accounts* – Under the Safe Harbor provisions of this plan, all contributions are 100% vested. Therefore, there are no forfeitures. Upon termination of employment, participants are entitled to their entire account balance.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

- a) *Basis of Accounting* – The accompanying financial statements are prepared on the accrual basis of accounting.
- b) *Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- c) *Valuation of Investments and Income Recognition* – Investments in registered investment companies (i.e., mutual funds held in pooled separate accounts) are reported at fair value of the fund's quoted market price, which represents the fair value (FV) of the shares held by the Plan at year end. Investment in the guaranteed investment contract is reported at contract value (Note 5). Investment options that do not have readily available market quotations are valued according to quotations from the custodians. Purchases and sales of securities are recorded on a trade-date basis.

2. Summary of Significant Accounting Policies, continued

- d) *Payment of Benefits* – Benefits are recorded when paid.
- e) *Plan Risk and Uncertainties* – The Plan and the Plan assets are sensitive to economic pressures prevalent in the investment market. The pressures primarily stem from interest rate, market and credit risk and their effect on bond rates, mortgage rates, the value of real estate, stock prices, and the overall stability of the market. Certain Plan investments are shares of pooled trust funds managed by the custodian. Change in the custodian's management may affect operating results of the funds adversely. Additionally, the financial position of the Company, Seeman Holtz Property and Casualty, LLC and P & C Payroll Management, LLC, may have a significant impact on the Plan. Specifically, this include the ability of the Company to continue to make contributions under the program and/or the stability of the Company's operations. Other external factors which may affect the Plan and the Plan assets include legislation or regulations established by the Internal Revenue Service, Employee Retirement Income Security Act of 1974 (ERISA), and/or Department of Labor (DOL).

3. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

3. Fair Value Measurements, continued

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following description provides the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023.

- a) *Non-interest bearing cash* – The carrying amount reported approximates fair value due to the short term duration of the instrument.
- b) *Mutual funds held in pooled separate accounts* – Valued at quoted market prices of a national security exchange on the last business day of the year, of units held by the Plan at year end.

5. Investment Contract with Insurance Company

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Great-West Life & Annuity Insurance Company (Great-West). The funds are maintained in the MassMutual Guaranteed Interest Account, an interest-earning investment option backed by Great-West's general account assets, and are administered by Empower as of December 31, 2023 and 2022. Because the MassMutual Guaranteed Interest Account is a general account product offered through a group annuity contract, participant principal and interest are fully guaranteed by the entire general account assets of Great-West. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. New contributions are guaranteed to earn the applicable quarterly interest rate regardless of when it was deposited.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, the retirement business brand of Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value as of December 31, 2023 and 2022 was \$425,875 and \$524,688, respectively. The average yield earned by the plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The actual average yield earned by the plan for the benefit responsive fund can be derived by averaging the plan's quarterly interest rates. That average for 2023 and 2022 was 1.25% and 1.00%, respectively.

5. Investment Contract with Insurance Company, continued

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor, (4) premature termination of the contract. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable.

7. Plan Termination

Although the Company intends the Plan to be permanent and continuing, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and accrued benefits, to the extent funded or required to be funded, must be distributed to the participants.

8. Tax Status

The Plan is utilizing a pre-approved defined contribution plan provided by its custodian, Empower. The Plan reflects the implementation of the recent legislative changes in the regulations governing qualified tax-deferred arrangements via the IRS's Cycle 3 restatement. The restated Plan received an opinion letter from the Internal Revenue Service dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Subsequent Events

The Plan's management has evaluated subsequent events through May 1, 2025, the date on which the financial statements were available to be issued, and determined there were no events to disclose in these financial statements.
