INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of the
Marcal South 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Marcal South 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (liquidation basis) and 2022 (ongoing), and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. As a result, the Plan has changed its basis of accounting from the ongoing basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE 1 - DESCRIPTION OF PLAN

von Drehle Corporation and certain related entities and Blue Ridge Molding, LLC (collectively, “the Company” or “Plan Sponsor”) established the von Drehle Corporation 401(k) Profit Sharing Plan and Trust (“the Plan”) on November 1, 1994. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

During 2022, the Plan amended the name of the Plan from von Drehle Corporation 401(k) Profit Sharing Plan and Trust to Marcal South 401(k) Plan when the plan sponsor changed from von Drehle Corporation to Marcal Manufacturing.

General

The Plan was a defined contribution plan covering all full-time employees of the Company who had completed 90 days of service and are age 21 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Merger and Termination

The governing body of the Plan approved a plan merger on November 28, 2023. The Plan merged with the Marcal Paper Non-Union 401(k) Plan. The Plan was terminated as of December 31, 2023. As a result, the Plan changed its basis of accounting from ongoing basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements.

Contributions

Each year, participants could contribute up to 100% of pre-tax annual compensation, as defined in the Plan, and in accordance with applicable sections of the Internal Revenue Code. Participants who had attained the age of 50 before the end of the Plan year were eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered a fixed account, several pooled separate accounts, and registered investment companies as investment options for participants. The Company could make an employer matching contribution for participants each pay period of the Plan year equal to 100% of the participant’s elective deferral up to 5% of the participant’s eligible compensation. During the year ended December 31, 2023 and 2022, the Company made employer contributions of \$741,042 and \$0, in 2023 and 2022 respectively. Contributions were subject to certain limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions and an allocation of (a) the Company's contributions and (b) Plan earnings, and charged with an allocation of administrative expenses (if paid by the Plan's Trust). Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account.

Vesting

Participants are vested immediately in their own contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus related earnings is based on years of service, as follows:

All amounts credited to a participant's account became 100% vested on the date the plan was terminated.

Participant Loans

In cases of hardship or financial necessity, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. The notes were secured by the participant's remaining vested account balance, and bore interest at rates ranging from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the plan administrator. Principal and interest were paid ratably through payroll deductions.

Participant Withdrawals

Upon termination of service, due to termination, death, disability or retirement, a participant could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account balance. Distributions were subject to applicable provisions of the Plan agreement. In addition, the Plan allowed hardship distributions and distributions to eligible participants that had attained age 59 ½, as defined by the Plan.

Forfeitures

Forfeitures could be used to pay administrative expenses of the Plan and then to reduce the Company's contributions to the Plan. Unallocated forfeitures were \$0 as of December 31, 2023 and 2022, respectively. During the years ended December 31, 2023 and 2022, \$0 and \$0, respectively forfeitures were used to pay administrative expenses of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Benefit Payments

Benefits were recorded when paid.

Administrative Expenses

Certain administrative expenses were paid by the Plan and allocated to participant accounts. Remaining fees for legal, accounting and other administration are paid by the Plan Sponsor.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Contract value is the relevant measurement attribute for that portion of net assets available for benefits of a defined contribution plan attributable to a benefit-responsive investment contract because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on the investments bought and sold, as well as held during the year.

Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 3 - FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC), provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets.

Level 2

Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Registered Investment Companies: Valued at the net asset value (NAV) of shares held by the Plan at year end. Fair value is considered reasonably determined.

Pooled Separate Accounts (PSAs): Investments in pooled separate accounts are valued using the unadjusted NAV as of the reporting date, which is the basis for current transactions. The NAV is used as a practical expedient to estimate fair value. PSAs are valued based on the underlying investments (i.e., common stock, mutual funds, and short-term securities) in the separate account as reported by Principal Life Insurance Company (Principal Life). While the majority of the underlying assets values are based on quoted prices, NAV of the PSAs are not publicly quoted. The NAV is reported by Principal Life as of the financial statement date based on recent transaction prices. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan invests in the Principal Fixed Income Guaranteed Option (“the Contract”), a benefit responsive group annuity contract issued by the Principal Life Insurance Company. The Contract is not a portfolio of contracts whose yields are based on changes in the fair value of underlying assets, but rather a single group annuity contract with a fixed rate of interest. As a result, the average yield earned by the Plan is the yield earned, or the interest credited, on the group annuity contract. The underlying assets consist primarily of treasuries, commercial real estate mortgages, mortgage-backed securities and short-term cash equivalents.

The interest crediting rate is determined on a semiannual basis and is calculated based upon many factors, including current economies and market conditions, the general interest rate environment, and purchased and redemptions by unit holders. An employer-level surrender of the Plan’s interest in the Principal Fixed Income Guaranteed Option or employer-initiated transfer will be subject to either a 12-month irrevocable advance notice or a 5% surrender charge, whichever the employer chooses. The average market yield earned by the Contract, which is also the actual interest credited to participants in the Contract for the year ended December 31, 2023, was 5.15%. The average market yield earned by the Contract for year ended December 31, 2022 was 4.05%. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

NOTE 5 - RELATED-PARTY TRANSACTIONS

Certain Plan investments are units of registered investment companies, pooled separate accounts, and a fixed account managed by Principal Trust Company and Empower Trust Company, the certifying entities as defined by the Plan. These transactions qualify as party-in-interest transactions. Fees paid by the Plan to parties-in-interest for Plan services amounted to \$72,399 and \$115,931 for the years ended December 31, 2023 and 2022, respectively.

NOTE 6 - TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - CERTIFICATION

The following is a summary of the unaudited information included in the Plan's financial statements and supplemental schedule that were prepared or derived from information prepared by Principal Trust Company (Principal) and Empower Trust Company (Empower), the certifying entities of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from Principal and Empower that such information is complete and accurate.

Statements of Net Assets Available for Benefits – all items and amounts, except for contributions receivable.

Statements of Changes in Net Assets Available for Benefits – all items and amounts, except for contributions, benefits paid to participants, transfers, and administrative expenses.

Supplemental Schedule – all items and amounts, except for delinquent participant contributions.

NOTE 8 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events that have occurred through May 1, 2025, the date the financial statements were available for issuance.

NOTE 9 - PLAN TRANSFERS

During the year ended December 31, 2023, \$9,499,400 was transferred to the Marcal Paper Non-Union 401(k) Plan because of the Plan merger.
