**NOTE 1 – Description of The Plan**

The following description of the Angelos Recycled Materials ("Company") 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering all employees of Angelos Aggregate Materials, Ltd. (the "company") who have completed three months of service and are eighteen years of age. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The company is responsible for oversight of the plan and determines the appropriateness of the plan's investment offerings, monitors investment performance.

***Eligibility***

Employees qualify for participation in the plan after completing three months of service and are age 18 or older. An employee becomes a participant in the Plan the first day of the first month following completion of the eligibility requirements. Excluded employees include non-resident aliens and residents of Puerto Rico.

***Contributions***

Each year, participants may elect to contribute up to 90% of their annual compensation, as defined by the Plan, subject to the restrictions of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled at a 3% deferral rate, unless they affirmatively elect not to participate in the Plan. The Plan also includes an auto-increase provision whereby deferral percentages increase by 1% on the first period that begins after the period in which the initial deferral amount was withheld and will occur as of each anniversary of the participants entry date to a maximum of 6% for those employees automatically enrolled. The Company provides a safe-harbor matching contribution of 100% of participant's elective deferrals up to 4%. The Company may also make a discretionary non-elective contribution each year. For the years ended December 31, 2023 and 2022, there were no discretionary non-elective contributions made.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's safe harbor or profit-sharing contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 1 – Description of The Plan (Continued)**

***Investment Options***

Participants direct the investment of their contributions into various investment options offered by the Plan. The Company's safe harbor and profit-sharing contributions are invested in the same investment funds as elected by the participant.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon and company match contributions. Vesting in the Company's profit sharing contribution portion of their accounts is based on years of service according to the following schedule:

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a direct rollover to another qualified plan or IRA. The Plan also permits withdrawals of active participants' vested balance, only in amounts necessary to satisfy financial hardship as defined by the Plan document. Account balances less than \$5,000 are paid in a single lump sum upon termination.

***Forfeitures***

At December 31, 2023 and 2022, forfeited non-vested account totaled \$13,810 and \$1,671. These accounts will be used to reduce future employer contributions or pay administrative expenses. The forfeitures used during December 31, 2023 and 2022 total \$12,907 and \$0.

**NOTE 2 – Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America and, accordingly, reflect all significant receivables, payables and other liabilities.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value based on quoted market prices, except as noted below. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2023 and 2022, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan invests in a variety of investment funds. Investments, in general, are exposed to various risks, such as interest rate, credit and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

***Administrative Expenses***

Participants' accounts are assessed certain plan expenses that are incurred by, or are attributable to, a particular participant based on use of a particular plan service. Other administrative costs are paid by the Organization.

***Subsequent Events***

Subsequent events have been evaluated by management through April 23, 2025, which was the date that the accompanying financial statements were available to be issued. The Plan name was changed to Angelo's Florida Properties, LLC 401K Plan effective April 1, 2024.

**NOTE 3 – Summary of Information Certified by The Trustee (Unaudited)**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected in the accompanying statement of assets available for benefit as of December 31, 2023 and 2022, the investment income in the statement of changes in net assets available for benefits for the year ended December 31, 2023, as well as the accompanying supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year). The Plan's independent certified public accountants did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule of assets (held at end of year).

**NOTE 4 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no transfers between levels in 2023 and 2022.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – Related Party Transactions**

Certain Plan investments are annuities administered by Reliance Trust Company, the custodian for the Plan and, therefore, these transactions qualify as party- in-interest transactions. Fees incurred by the Plan for investment management and recordkeeping services are included in the net appreciation in the fair value of investments and are paid through revenue sharing, rather than a direct payout.

The Plan also paid certain fees for third party administration for the year ending December 31, 2023. The Organization will incur most administration, legal and accounting expenses associated with the Plan. All the above transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

**NOTE 6 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants are 100% vested in their accounts.

**NOTE 7 - Tax Status**

The Plan utilizes a volume submitter plan document, which received a favorable advisory letter from the Internal Revenue Service (IRS) dated March 30, 2014, stating that the Plan was designed in accordance with the provisions of the Internal Revenue Code (IRC). The Plan has not filed for its own determination letter from the IRS. The Volume Submitter Profit Sharing Plan has been amended since the date of the opinion letter. However, Plan management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and is exempt from taxation under the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2020.
