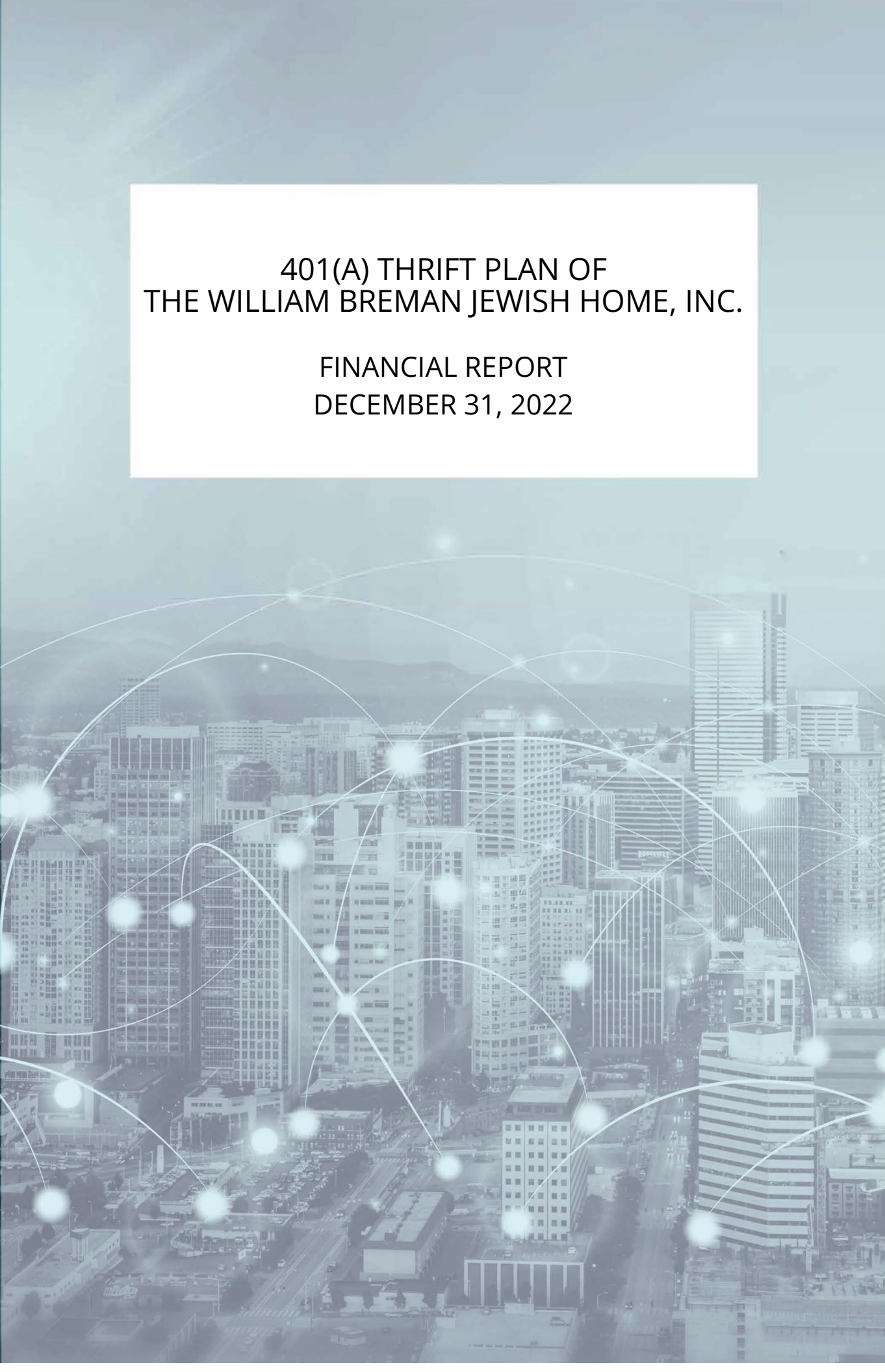

## Independent Auditor's Report

**To the Board of Directors**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of **401(a) Thrift Plan of the William Breman Jewish Home, Inc.**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits (in liquidation) for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 401(a) Thrift Plan of the William Breman Jewish Home, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of 401(a) Thrift Plan of the William Breman Jewish Home, Inc. and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Emphasis of Matter**

As described in Note 1 to the financial statements, the Plan Sponsor elected on February 11, 2021 to terminate the Plan, and the Plan administrator determined that liquidation is imminent. As a result, the Plan changed its basis of accounting from the going concern basis. Our opinion is not modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

# Notes To Consolidated Financial Statements

## NOTE 1. PLAN DESCRIPTION

The following brief description of the 401(a) Thrift Plan of The William Breman Jewish Home, Inc. (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

### **Plan Termination:**

Effective February 1, 2021, the Board of Directors agreed to terminate the Plan as soon as administratively feasible and therefore applied the liquidation basis of accounting to the Plan for the years ended December 31, 2022 and 2021. As a result of the termination, the following changes were made to the Plan: (1) no employee shall become eligible to become a participant in the Plan on or after February 1, 2021; (2) for purposes of determining Employer contributions, compensation does not include any amounts earned on or after February 1, 2021 and rollover contributions are no longer allowed as of February 1, 2021; (3) any participant accounts that are not 100% vested will become 100% vested as of February 1, 2021; (4) forfeitures shall be allocated per capita among the Participants who are Employees as of February 1, 2021; (5) each participant shall be entitled to receive a distribution of the total balance of his vested accounts as a result of the termination of the Plan. All Plan assets have been distributed as of December 31, 2022.

### **General:**

The Plan is a defined contribution plan covering all full-time employees of The William Breman Jewish Home, Inc. (the "Organization" or "Sponsor"). Prior to the Plan termination, employees were eligible to participate after one year of service, 1,000 hours of service, and attainment of age 21. Any prior employment in the health and welfare field does not count as service for this purpose. The Plan is subject to the provisions of ERISA. The Board of Directors oversees the management of the Plan, is responsible for the safekeeping of the Plan assets, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

### **Contributions:**

Prior to Plan termination, the Plan provided for a discretionary contribution by the Organization on behalf of participants based on a rate set forth and approved by the board of directors. There was no contribution made for 2021. Employee contributions are not allowed by the Plan, except for rollover contributions from qualifying plans that occurred before the Plan termination date of February 1, 2021.

### **Participant Investment Options:**

Participants may direct the Organization's contributions to selected investments as made available and determined by the plan administrator. Any contribution made on behalf of a participant for which no investment direction is in effect shall be allocated to a Mutual of America retirement fund appropriate to the age of the participant at the time of allocation. Participants may change their investment options any time throughout the year via direct phone or internet access to Mutual of America.

### **Participant Accounts:**

Each participant's account is credited with the Organization's contribution and an allocation of (i) Plan earnings or losses, and (ii) forfeitures of terminated participants' non vested account balances, if any, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## **NOTE 1. PLAN DESCRIPTION (CONTINUED)**

### **Vesting:**

Prior to Plan termination, the amounts in a Participant's employer contribution account became 100% vested upon the attainment of normal retirement age, or if earlier, upon completion of 3 years of credited vesting service. As of the Plan termination date, all participant account balances became fully vested.

### **Notes Receivable from Participants:**

Employee loans are not permitted under the Plan.

### **Payment of Benefits:**

Participants are entitled to their vested portion of employer contributions upon the following events: termination of employment, disability, retirement, death, or termination of the Plan. Participants should refer to the Plan agreement for more complete information related to benefit payments and withdrawals.

### **Forfeitures:**

Forfeitures of terminated non-vested account balances available at December 31, 2022 and 2021 were \$- and \$55,575, respectively. These accounts can be used to pay plan expenses or be reallocated to the participants as defined by the termination provisions. During the year ended December 31, 2022, forfeited balances totaling \$20,543 were used to pay plan expenses, and forfeited balances totaling \$35,059 were reallocated to participants.

## **NOTE 2. SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

As disclosed in Note 1, the Company terminated the Plan during 2021. As a result, the Plan changed its basis of accounting for the years ended December 31, 2022 and 2021 from the on-going basis to the liquidation basis. Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process. As the Plan's assets were previously reported at fair value, the application of the liquidation basis of accounting did not have a material impact on the Plan's financial statements.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

## **NOTE 2. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

### **Administrative Expenses**

Certain administrative functions are performed by employees of the Organization. No such employee receives compensation from the Plan. Most administrative expenses for trustee and other fees of the Plan are paid directly by the Organization. Certain administrative fees for participant-directed transactions are paid from participant accounts in accordance with the Plan service agreement.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## **NOTE 3. FAIR VALUE MEASUREMENTS**

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under this guidance are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Investments with insurance company in pooled separate account funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The redemption frequency is daily and the redemption notice period is daily. Were the Plan to initiate a full redemption of a pooled separate account, the investment adviser reserve the right to temporarily delay withdrawal from the account in order to ensure that the securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments related to the pooled separate accounts.

*Guaranteed interest account with insurance company:* The general account is credited with a contractual rate of return. The account's fixed income assets are carried at amortized cost, or contract value, which is deemed to be fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

No assets were measured at fair value as of December 31, 2022. The following table sets forth by level, within the fair value hierarchy, the Plan's fair value measurements at December 31, 2021:

**NOTE 5. INCOME TAX STATUS**

The IRS has determined and informed Mutual of America Life Insurance Company that its standardized prototype plan and the related trust are designed in accordance with applicable sections of the IRC. The plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the relevant taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6. PLAN TERMINATION**

As described in Note 1, the Plan was terminated in 2021. See Note 1 for a description of the Plan termination provisions.

**NOTE 7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (in liquidation) as of December 31, 2022 and 2021.

**NOTE 8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of separate account funds and group annuity contracts managed by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in administrative expenses and net depreciation in fair value of investments on the statement of changes in net assets available for benefits (in liquidation).
