


### Termination Benefit

Credited years are plan years from date of hire excluding the following:

- Years before the effective date
- Years before age 18
- Years with less than 1,000 hours

### Top-Heavy Minimum Benefit

Top-heavy minimum benefits are provided under another plan of the employer

### Top-Heavy Status

A plan is top-heavy if over 60% of the value of all accrued benefits in all of the employer's plans are for the benefit of key employees. A key employee is generally an officer or owner of the company. This plan is currently top-heavy.

### Death Benefit

Actuarial Equivalent of the accrued benefit earned to date of death

### Disability

Equal to present value of the accrued benefit

### Cash Balance

The annual Interest Crediting Rate for this plan year is 4.00%
