## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator  
Savannah Christian Preparatory School 401(k) Retirement Plan  
Savannah, Georgia

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Savannah Christian Preparatory School 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Savannah Christian Preparatory School 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Note 1 - Description of Plan

The following description of the Savannah Christian Preparatory School 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on July 1, 1998, and is a defined contribution plan which covers all eligible employees of Savannah Christian Preparatory School, Inc. (the School), who have one month of service and have attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants may contribute from 1% to 50% of annual wages up to the total amount allowed by the Internal Revenue Service for 401(k) plans. The School matches 100% of the employee contributions up to 3% of compensation. Additional amounts may be contributed at the option of the School's board of trustees.

Participants direct the investment of contributions to their accounts into various investment options offered by the Plan. The Plan currently offers twenty-seven (27) mutual funds.

Participant Accounts

Each participant has an individual account which is credited with (a) the participant's contribution, (b) the Company's matching contribution, and (c) Plan earnings.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. A participant is 100 percent vested in the School's matching contribution after the completion of six years of service as defined in the Plan instrument. Forfeitures of terminated participants are used to pay plan expenses and to reduce School contributions, at the discretion of the employer.

Payment of Benefits

On termination of service, a participant may receive his or her vested benefits in a lump-sum amount.

Forfeited Accounts

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$27,538 and \$20,978, respectively. These accounts are used to pay plan expense and then to reduce the employer's contributions at the discretion of the employer. The plan used \$0 in 2024 and 2023 to reduce employer contributions. All operating expenses of the Plan were absorbed by the School.

Note 2 - Summary of Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as determined by Fidelity Management and Trust Company (the Trustee) based on the last sales price reported as of the last business day of the fiscal year. Purchases and sales of securities are recorded as of the trade date. Gains or losses on sales of securities are determined on an average-cost basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on an accrual basis.

The plan presents in the statement of changes in net assets available for benefits the net earnings on the investments for the year. This amount includes both the net appreciation (depreciation) in the fair market value of its investments and any interest income and dividend income earned during the plan year.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 3 - Investments

All of the Plan's investments are held by Fidelity Management Trust Company. The following table represents the fair values of investments of the Plan. SFAS No. 157, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were available to the Plan.

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 1 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date; and

Level 1 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The fair value of all plan investments is based on quoted net asset values of the shares held by the Plan at year end (Level 1). The values and shares held by the Plan at June 30, 2024 and 2023, are as follows:

Note 4 - Terminated Participants with Account Balances

At June 30, 2024 and 2023, accounts for the benefit of persons who have withdrawn from the plan but have not been paid amounted to \$2,921,615 and \$2,200,506, respectively.

Note 5 - Related Party Transactions

All Plan investments are shares of mutual funds managed by an affiliate of Fidelity Management Trust Company. Fidelity Management Trust Company is the custodian of the assets and the paid plan administrator; therefore, these transactions qualified as party-in-interest transactions.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA. In the event of Plan termination, participants will be 100 percent vested in their employer contribution accounts.

Note 7 - Tax Status

The Plan Administrator has received a determination letter from the District Director of the Internal Revenue Service, which determined that the Plan is in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan is qualified and the related trust was tax-exempt as of the financial statement date.

Note 8 - Information Prepared and Certified by Custodian

The following information included in the accompanying financial statements and supplemental schedules for the year ended June 30, 2024 and 2023, was obtained from data that has been prepared and certified to be complete and accurate by the trustee.

We are writing to request that the IRS waive any potential penalties associated with the one-day late filing of our Form 5500 for the plan year ending 06/30/2024, due to reasonable cause.

Our organization was impacted by the federally declared disaster in the State of Georgia (Hurricane Idalia/Helene), for which the IRS granted a filing extension. While we relied on this extension in good faith, the final audit report necessary for our 5500 filing was not completed and matched until the day of the deadline. Despite our efforts to submit the return promptly, the Form 5500 was filed one calendar day late due to this timing mismatch.

We maintain robust procedures for complying with filing requirements and have a strong history of timely submissions. This isolated delay was caused by circumstances outside our control and not due to willful neglect.

Given the minimal delay, our prior compliance record, and the good-faith reliance on the disaster-related extension, we respectfully request that any penalties be waived under the IRS's reasonable cause provisions.
