Management has obtained certifications from a qualified institution as of December 27, 2022 and December 31, 2021 and for the period January 1, 2022 through December 27, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. As discussed in Note 7 to the financial statements, the Board of Directors of the Physicians Immediate Care, LLC, the Plan's sponsor, voted to terminate the Plan effective July 1, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis to the liquidation basis for the 2022 and 2021 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Physicians Immediate Care LLC 401(k) Profit Sharing Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. ### Note 1: Description of the Plan

The following description of the Physicians Immediate Care LLC 401(k) Profit Sharing Plan (Plan) provides only general information. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees who are not leased employees or classified as needed (PRN) of Physicians Immediate Care LLC (Company) and Urgent Care Services Group, LLC, an affiliated entity of the Company. Participants are eligible to enter the Plan on the first day of the month following the date of hire. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

#### **Contributions**

The Plan permits voluntary contributions by participants at an amount up to 100% for pre-tax dollars, subject to certain Internal Revenue Code (IRC) limitations and up to 100% for after-tax dollars of the participant's compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from the other qualified benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company will make discretionary matching contributions in the amount of 100% of the first 3% of participant elected deferrals. Discretionary matching contributions of \$428,296 were made in 2022, and invested in the same options as participant contributions, at the participant's discretion.

The Company can also make discretionary profit sharing contributions determined annually. The Company did not make any profit sharing contributions for the period ended December 27, 2022. Discretionary profit sharing contributions are invested in the same options as participant contributions, at the participant's discretion.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

### ***Vesting***

Participants are immediately vested in their elective contributions plus earnings. Participants' interests in their share of the Company's discretionary profit sharing and matching contributions vest in accordance with the following schedule based on years of service, as defined in the plan document:

Less than 2 years	0.0%
2 years	20.0%
3 years	40.0%
4 years	60.0%
5 years	80.0%
6 years or more	100.0%

If an active participant dies prior to attaining normal retirement age, the participant's vesting percentage shall be 100%. Full vesting also occurs upon attainment of normal retirement age, termination of employment due to disability or satisfaction of early retirement requirements. Early retirement requirements are the participant attains age 55 and completes at least five years of service.

### ***Payment of Benefits***

Benefits are payable to the participant upon:

- (a) Death or retirement from the service of the Company on or after normal retirement date (age 65), or on account of disability or
- (b) Resignation or dismissal from the service of the Company prior to normal retirement date.

If the vested benefits are less than \$5,000, the balance will be distributed as either a cash distribution to the participant or transferred to an eligible retirement plan, at the direction of the participant. If the participant does not elect a method of payment and the balance is less than \$5,000, it will automatically be distributed in cash to the participant. If the balance is more than \$5,000, an election to receive the benefit must be made.

Each participant or former participant may, in writing, designate a beneficiary or beneficiaries to whom distributions of interest in the trust shall be made in the event of the participant's death.

### ***Forfeitures***

Forfeitures from less than 100% vested accounts are first used to pay any administrative expenses. Excess forfeitures are used to provide additional employee contributions or to reduce employer

contributions. At December 27, 2022, there were no unallocated forfeitures. At December 31, 2021 there were \$187,165 of unallocated forfeitures, which were used during 2022 to reduce administrative expenses and employer contributions..

### Note 2: Summary of Significant Accounting Policies

#### ***Basis of Accounting***

Due to the decision to terminate the Plan during 2022, the financial statements for 2021 and 2022 have been prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### ***Valuation of Investments and Income Recognition***

The Plan's investments are stated at liquidation value. For all investments, fair value approximates the amount the Plan expects to collect at liquidation. The Plan's investments in shares of registered investment companies and self-directed brokerage accounts are valued at quoted market prices.

The common or collective trust fund is valued at net asset value (NAV) of units held at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate the fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The securities are wrapped in third party wrap contracts designed to maintain a constant NAV. There are no participant redemption restrictions for these investments and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at December 31, 2022 and 2021.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Revenue Sharing***

The Plan recognizes income from revenue-sharing agreements when received. Amounts received are utilized to pay qualified plan expenses. During 2022 and 2021, the Plan received \$17,533 and

\$18,387, respectively, all of which was used to pay expenses for professional and investment management advisory services.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Certain expenses of administering and operating the Plan are paid by the Company. The Plan pays certain administrative expenses and transaction costs related to investment fees. Investment fees are included in the unrealized appreciation of the investments. The Plan also earns credits to offset its expenses, which are recorded in other income.

### **Note 3: Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

**Level 1** Quoted prices in active markets for identical assets or liabilities

**Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

**Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2022 and 2021.

The fair value of registered investment companies and self-directed brokerage accounts are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of

Therefore, no provision for income taxes has been included in the Plan's financial statements.

Certain plan investments are funds managed by the trustees. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services amounted to \$124,827 for the period ended December 27, 2022. Certain administrative functions are performed by officers or employees of the Company for which no compensation is received from the Plan.

### Note 9: Risks and Uncertainties

The Plan provides for investments that, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
