Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Indiana Glass Company Union Employees Retirement Benefit Plan (the Plan), an employee benefit plan subject to the Employees' Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits and of accumulated plan benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits and of changes in accumulated plan benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Notes 2 and 5 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

1. Description of Plan and Tax Status

The Indiana Glass Company Union Employees' Retirement Benefit Plan (Plan) is contained in the agreement dated February 2, 2005 between Dkirk, Inc., formerly known as Indiana Glass Company (Company), and the United Steelworkers of America, AFL-CIO. Effective July 1, 2015, the Company's obligations under the Plan were assumed by Lancaster Glass Corporation as a result of the merger of the Company into Lancaster Glass Corporation. The Plan is a noncontributory defined benefit plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Participants should refer to the Plan document as well as the aforementioned agreement for more complete information. See Note 7 for amendments to benefit provisions.

At June 30, 2024 and 2023, the Plan had no active participants.

The Plan invests a significant portion of its assets in the Lancaster Colony Corporation Master Pension Trust (Master Trust) with other subsidiaries of Lancaster Colony Corporation whereby they pool their investment assets. Allocation of net assets, net investment income, and gains and losses to participating plans are allocated to the plans on a pro rata basis based on the Plan's undivided interest. Participants should refer to the Master Pension Trust Agreement for more complete information. See Note 5 for summary information on the Master Trust. The Plan's interest in the Master Trust was approximately 60% at June 30, 2024 and 2023.

On November 1, 2002, the Company announced a partial plant shutdown. As a result of this event, Plan participants terminated during the 12-month period ended on November 26, 2002 became 100% vested in the Plan. This plant was closed, and all remaining employees became fully vested and were terminated on February 28, 2009.

The Plan's trustee changed from Huntington National Bank to Charles Schwab Trust Bank. This transition occurred during December 2023.

The Plan obtained a favorable determination letter dated June 27, 2014 from the Internal Revenue Service (IRS). The Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, including any that have become effective since the effective date of the amendments in the latest determination letter, and continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America (GAAP) require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Benefit Payments

The Plan generally provides for normal retirement benefits at age 65, early retirement benefits at age 60 and ten years of service, disability benefits, and survivor benefits. A vested participant who terminates for any reason other than retirement, disability, or death is entitled to the monthly vested termination benefit beginning on his or her normal retirement date in the amount of his or

her accrued benefit. The benefit payment is based on participants' years of service and the corresponding amount per credited service year on their last day worked with the Company.

Participants may elect to receive their distributions, subject to certain Plan provisions, in the form of various annuity payment options. If the participant's actuarial equivalent of the accrued benefit payable at their normal retirement date is less than \$1,000, the participant is paid a lump-sum payment as soon as practicable after his or her termination date. If the participant's actuarial equivalent of the accrued benefit payable at their normal retirement date is less than \$5,000 but greater than \$1,000, the participant may elect to receive a single lump-sum payment in full discharge and satisfaction of any benefit otherwise payable under the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Fair values of investments, in and outside of the Master Trust, are based on the latest securities quotations available as provided by the trustee of the Plan. See Note 5 for discussion of the investment in the Master Trust and Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, and (b) beneficiaries of employees who have died. Benefits under the Plan are based on employees' years of credited service. The accumulated plan benefits for active employees are based on their years of credited service ending on the date the benefit information is presented (the valuation date). Benefits payable under all circumstances—retirement, death, disability, and termination of employment—are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by an independent actuary, CBIZ Benefits & Insurance Services, Inc., and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuations as of June 30, 2024 and 2023 were (a) life expectancy of participants (for 2024 and 2023, the SOA PRI-2012 Blue-Collar Dataset Amount-Weighted Mortality for Employees, Retirees, and Contingent Survivor, projected with Scale MP-2021 fully generation, was used), (b) retirement age assumptions (the assumed average retirement age was 65), and (c) investments return (5.0% and 5.1%, respectively). The computations of the actuarial present value of accumulated plan benefits were made as of July 1, 2024 and 2023. Had the valuation been performed as of June 30, there would be no material differences.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

Plan amendments are included in the actuarial calculation of accumulated plan benefits as of their effective date (see Note 7).

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Certification of Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments held at June 30, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Huntington National Bank, a qualified institution, from June 30, 2023 through December 31, 2023, and Charles Schwab Trust Bank, a qualified institution, from January 1, 2024 through June 30, 2024.

Administrative Expenses

Substantially all administrative expenses are paid by the Plan.

Subsequent Events

The Plan has evaluated events and transactions that occurred between July 1, 2024 and May 2, 2025, the date that the financial statements were available to be issued. No significant events or transactions were identified other than that discussed in Note 4.

3. Funding Policy

The Company's funding policy is to make annual contributions to the Plan at least equal to an amount based on an actuarial calculation of the Plan's minimum funding requirements under ERISA. There was no contribution required for 2024 and 2023.

4. Plan Termination and Subsequent Event

The Company has the right under the Plan, in certain circumstances, to discontinue its contributions and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, the assets of the Plan would be allocated for payment of Plan benefits to the participants in an order of priority determined in accordance with ERISA, applicable regulations thereunder, and the Plan document.

Certain benefits under the Plan are insured by the Pension Benefit Guarantee Corporation (PBGC) if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's assets to provide for accumulated benefit obligations, and may also depend on the financial condition of the Company and the level of benefits guaranteed by the PBGC.

Effective August 14, 2024, the Company's Board of Directors announced their intent to (1) merge the Plan into the Indiana Glass Company Union Employees' Retirement Benefit Plan, (2) rename the Indiana Glass Company Union Employees' Retirement Benefit Plan to be the Lancaster Legacy Pension Plan (Legacy Plan), and (3) terminate the Legacy Plan effective November 30, 2024.

5. Investment in Master Trust

At June 30, 2024 and 2023, a significant portion of the Plan's assets were held in a Master Trust, referred to as the Master Trust. At June 30, 2024 and 2023, the Plan had an undivided interest in the Master Trust having a fair market value of \$15,838,969 and \$16,653,335, respectively.

6. Fair Value Measurements

Accounting Standards Codification (ASC) 820-10, *Fair Value Measurements and Disclosures*, defines fair value and provides guidance for measuring fair value and expands disclosures about fair value measurements in accordance with GAAP.

ASC 820-10 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobserved inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at June 30, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Level 1 - The securities classified as Level 1 include money market funds and mutual funds. Quoted market prices in active markets are available for investments in this category.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. Plan Amendments

As of February 28, 2009, the Plan effectively ceased the crediting of credited service for benefits since the Company no longer employed any of the participants and the status of the Plan became "frozen" with regards to each participant's accrued benefit. This change in the Plan simply freezes the amounts of the accrued retirement benefits and the Plan will otherwise continue and does not affect the basic amount of any pension that is currently payable to, or on behalf of, any retired employee or former employee who previously retired or terminated employment with a vested right to benefits under the Plan.

Effective July 1, 2020, the Plan was amended to correct the definition of "Company" from Dkirk, Inc. to Lancaster Glass Corporation. The amendment updated Section 4.02, *Benefits Upon Postponed Retirement*, and Section 4.04, *Deferred Vested Retirement Benefit*, to specify when a participant commences benefits, their pension benefit would not be less than the actuarial equivalent value of the accrued benefit at normal retirement date.

Effective for annuity starting dates after September 1, 2021, the Plan amended Section 4.04 to specify when a participant commences benefits and the annuity starting date is after the date described in Section 5.06(a), their pension benefit will be equal to the benefit payable on the date

described in Section 5.06(a). The participant must receive a make-up payment (including interest) to reflect any missed payments for the period from the date described in the immediately prior sentence to the date of the actual make-up payment.

The Plan document was amended and restated effective November 30, 2024 in conjunction with the subsequent event described in Note 4.

8. Related Party and Parties-in-Interest Transactions

Parties-in-interest are defined under the Department of Labor's Rules and Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. The Plan holds investment interest in the Master Trust. The Plan's trustee, Huntington National Bank from June 30, 2023 through December 31, 2023, and Charles Schwab Trust Bank from January 1, 2024 through June 30, 2024, are the trustees of the Master Trust (see Note 5). Accordingly, the Plan's investments in the Master Trust qualify as party-in-interest transactions, which are exempt from prohibited transaction rules under ERISA.

In addition, certain employees of Lancaster Colony Corporation, the Plan Administrator, provide administrative and investment services, some of which may be fiduciary in nature, to the Plan; however, the Plan does not provide any compensation for these services.

9. Risks and Uncertainties

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Investment securities, in and outside of the Master Trust, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in these risks, estimates, and assumptions in the near term could materially affect the amounts reported in the financial statements.

The "Limited to 25 Year Corridor" rates are adjusted by the applicable maximum and applicable minimum percentages of the 25-year average segment rates, as set forth in the American Rescue Plan Act of 2021 ('ARPA-21') for use in Minimum Required Contribution calculations. The IRS Maximum Deductible Limit Calculations use the rates from the "Non-Stabilized" column above.

The interest rates used to value the Target Liability for determining the minimum and maximum contributions are prescribed by law and based on elections made by the Plan Sponsor.

Effective Interest Rate The Effective Interest Rate (EIR) for the current Plan Year is 5.14%. For the prior Plan Year, the EIR was 5.30%.

The EIR is the single rate of interest which, if used to determine the Funding Target, would equal the Funding Target determined using the Plan Sponsor's above elected discount rates. The EIR is used to discount contributions for minimum funding requirements and to accumulate excess contributions to the end of the year.

Funding Expected Return on Assets The Expected Return on Assets (EROA) used in the calculation of the Actuarial Value of Assets is the lesser of a) or b), below:

a) The Plan Sponsor's expected long-term rate of return on assets based on policy trust allocations; or

b) The third segment rate in the IRS-prescribed three-segment rate assumption, based on the elections made by the Plan Sponsor for minimum funding purposes.

SUMMARY OF METHODS

Minimum Funding Cost Method

The actuarial cost method used to determine the liabilities for minimum funding calculations is the Traditional Unit Credit method. The objective under this method is to fund each participant's benefits under the plan as they accrue. Under this cost method, the actuarial accrued liability is the sum of the individual accrued liabilities for all participants and the normal cost is the sum of the individual normal costs for each participant. The individual accrued liability for a participant is the present value of the accrued benefit as of the valuation date taking into account service and/or pay as of the valuation date. The individual normal cost for a participant is the present value of the benefit expected to accrue in the plan year being valued.

If a plan is frozen, there is no normal cost attributable to benefit accruals.

Maximum Deductible Contribution Method

The actuarial cost method used to determine the liabilities for maximum deductible calculations is the Projected Unit Credit method. The objective under this method is to fund each participant's benefits under the plan as they accrue, taking into consideration expected future compensation increases. Under this cost method, the actuarial accrued liability is the sum of the individual accrued liabilities for all participants and the normal cost is the sum of the individual normal costs for all participant. The individual accrued liability for a participant is the sum of 1) the present value of the accrued benefit earned as of the valuation date taking into account service and/or pay as of the valuation date; plus 2) the present value of the accrued benefit expected to be earned because of any expected future compensation increases.

The individual normal cost for a participant is the sum of the present value of the benefit expected to accrue in the plan year being valued taking into account any expected future compensation increases.

Asset Method

We used financial data submitted by the trustee as of the valuation date without further audit. We have reviewed the information for internal consistency, and we have no reason to doubt its substantial accuracy.

Actuarial Value of Assets For funding purposes, Actuarial Value of Assets is a smoothed market value assets adjusted by the applicable percentage of gain or loss calculated in each year during the smoothing period. The gain or loss is the difference between the current year's market value, and prior year's market value brought forward with contributions, benefit payments, and administrative expenses, all adjusted at the expected interest rate to the valuation date. The expected interest rate for each year is the lesser of the expected rate of return and the third segment rate. The applicable percentage is 66-2/3% for the year preceding the valuation date, and 33-1/3% for the second year preceding the valuation date. The actuarial value of assets will be adjusted to be no greater than 110% and no less than 90% of the current (market) value of assets.

Receivable contributions are discounted back to the valuation date at the prior year's effective interest rate.
