**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Centurion Investments, Inc. 401(k) Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Centurion Investments, Inc. 401(k) Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. ## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following brief description of the Centurion Investments, Inc. 401(k) Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

#### **General**

The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established effective January 1, 1990 and most recently restated July 15, 2024. The Plan sponsor is Centurion Investments, Inc. d/b/a/ AVMATS (the Company). The Plan covers all employees of AVMATS and Georgian Aerospace, LLC who are age 18 or older.

#### **Contributions**

Employees may contribute up to the amount permitted by Internal Revenue Service (IRS) regulations, which was \$23,000 in 2024. Employees who meet certain age requirements are also permitted to make catch-up contributions. The Plan also permits Roth contributions, as well as rollover contributions. The Plan provides for automatic enrollment at six percent of a participant's eligible compensation.

During 2024, the Company made a matching contribution of fifty percent of the first six percent of amounts deferred by participants. As permitted by the plan document, the Company may make discretionary profit-sharing contributions to be determined annually. In order to be eligible for the profit-sharing contribution, a participant must have worked at least 1,000 hours during the plan year and must be employed on the last day of the plan year, unless termination is due to death, disability, or retirement. The amount allocated to eligible participants is based on compensation. All contributions are subject to maximum amounts as permitted by the Internal Revenue Service (the IRS).

#### **Participant Accounts**

All Plan investments are participant directed. Plan participants have the option of having their contributions invested in a variety of mutual funds or common collective trusts.

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

Each participant's account is credited with the participant's contributions, and allocations of (a) the Company's contributions, (b) Plan earnings or losses, and (c) charged with administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### **Vesting**

Under the provisions of the Plan, participants are immediately 100 percent vested in their contributions and rollovers plus earnings thereon. Participants vest in their employer contributions plus earnings thereon over a two-to-six-year graded vesting schedule.

#### **Benefits**

On termination of service due to death, disability, or early retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Installment distributions and partial lump sums are also allowed. The Plan permits in-service and hardship withdrawals under certain conditions.

#### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prime interest rate plus one percentage point at the time the loan is originated. Principal and interest are paid ratably through payroll deductions.

#### **Administrative Expenses**

Certain costs of administering the Plan are paid by the Company and are therefore not reflected in the Plan's financial statements. Other costs are paid by plan assets and are reflected in the financial statements.

### **1. Description of the Plan (continued)**

#### **Forfeitures**

At December 31, 2024 and 2023, the forfeitures account totaled \$5,291 and \$2,212, respectively. These accounts represent forfeitures of non-vested participant accounts. These amounts may be used to reduce employer contributions or to pay plan expenses. During the year ended December 31, 2024, forfeited amounts of \$11,427 were used to reduce expenses.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the company contribution portion of their account.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting.

#### **Valuation of Investments and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are accounted for on a trade-date basis. Net investment income reported in the financial statements includes the effects of dividends received, interest earned, and net appreciation on the Plan's mutual funds and collective trusts bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid to participants.

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Notes Receivable from Participants**

Notes receivable from participants are carried at their unpaid principal balance plus accrued but unpaid interest. Related fees are recorded as administrative expense and are expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

##### **Other Income**

Other income includes immaterial revenue sharing and changes in the cash value of the life insurance accounts.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

##### **Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

##### **Excess Contributions Refundable**

Amounts payable to participants for contributions in excess of the amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in February 2025.

##### **Reconciliation to Form 5500**

Certain amounts were classified differently in the 5500 than on the financial statements. These classifications did not have any impact on the total net assets or changes in net assets available for benefits.

##### **3. Investment Information Certified by Custodian**

All investment information, except information related to the cash value of life insurance, disclosed in the accompanying financial statements and supplemental schedule, including investments held and participant notes receivable at December 31, 2024 and 2023, and net appreciation in fair value of investments, and dividends and interest and interest on participant notes receivable for the year ended December 31, 2024, were obtained or derived from information supplied to the plan administrator, and certified as complete and accurate, by the custodian, Charles Schwab Trust Bank.

##### **4. Fair Value Measurements**

The Plan follows accounting standards which establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under accounting standards are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

### Notes to Financial Statements (continued)

#### **4. Fair Value Measurements (continued)**

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds are valued daily based on quoted market prices on stock exchanges.

The common collective trust funds are valued at the NAV of units held. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by each fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchase and sales) may occur daily. The common/collective trust funds trade daily at the NAV with no trading restrictions or unfunded commitments.

The life insurance cash value is determined using methodologies as dictated by National Life Insurance Company in accordance with specified maturity tables as defined within the policies.

#### 5. Life Insurance Cash Value

In prior years, the Plan offered a life insurance policy for participants who elected this option. The Plan was amended in prior years and participants were no longer allowed to elect life insurance within the Plan. Participants who had elected the life insurance when it was offered by

the Plan are allowed to continue and premiums are deducted from the participant's bi-weekly payroll. As of December 31, 2024 and 2023, one participant and four participants remained, respectively. The balance and activity of the life insurance policies were excluded from the certification by the custodian.

#### **6. Administration of Plan Assets**

The Plan's investment assets are held by the custodian of the Plan. An insurance company holds amounts related to a former life insurance policy, as described in Footnote 5. Employee contributions are held and managed by the custodian, which invests cash received, interest, and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

#### **7. Related Party Transactions**

As noted in Notes 1 and 6, the Plan has a number of service providers. Such parties are a party-in-interest under ERISA.

#### **8. Income Tax Status**

On June 30, 2020, the Internal Revenue Service informed the Company by letter that the Plan is designed in accordance with and qualifies under Internal Revenue Code (IRC) Section 401(a). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position more likely than not, would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax

positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Subsequent Events**

Management has evaluated all subsequent events through April 11, 2025, which represents the date the financial statements were available to be issued.
