We were engaged to perform an audit of the financial statements of 403(b) Thrift Plan of MFI Recovery Center, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(c). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of 403(b) Thrift Plan of MFI Recovery Center's financial statements performed in accordance with ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(c), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from Mutual of America Life Insurance Company as of June 30, 2024, and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the 403(b) Thrift Plan of MFI Recovery Center (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. MFI Recovery Center (the "Center") is the Plan's administrator, trustee and sponsor. Mutual of America Life Insurance Company is the Plan's custodian.

General: The Plan is a defined contribution plan providing benefits to all employees of MFI Recovery Center. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors oversees governance of the Plan. The Board determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions: Under the provisions of the Plan, each year, participants may contribute pre-tax compensation, up to the maximum statutory limitations as described yearly by the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a general account as investment options for participants. Contributions for participants who do not select their investments upon enrollment are automatically invested in a designated balanced fund until changed by the participant.

Employer Contributions: Participants who have completed one year of service are eligible for employer base and matching contributions. The Center contributes 3% of participants' base compensation earned each year for eligible participants. The Center also makes a matching contribution consisting of 100% of the salary reduction amount that a participant contributes to the Plan that does not exceed 2% of annual compensation received. Contributions are subject to certain statutory limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution, allocations of the Center's base and matching contributions and Plan earnings and losses, and charged with an allocation of administrative expenses by the Plan. Allocations are based on participant earnings or account balances, as defined.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Center's contribution portion of their account is based on years of continuous service. Participants are fully vested in the employer contributions portion of their account after three years of service.

Notes Receivable from Participants: Participants may take out a loan based on the vested value of their individual account, which may not exceed the lesser of \$50,000, or 50% of the value of their vested account balance. Notes receivable from participants are secured by the balance in the participants' account and bear interest at rates of 3.25% to 5.85% per annum. Principal and interest are paid ratably over the term of the note through payroll deductions.

Payment of Benefits: Upon termination, participants with vested account balances in excess of \$1,000 may elect a life annuity contract (for unmarried participants), a joint and survivor annuity contract (for married participants), or a lump sum payment. Distributions must be taken in a single distribution of cash as soon as administratively feasible if the participant's account balance is equal to or less than \$1,000. Participant consent to such distribution shall be required after the participant's annuity starting date of the distributions to the participant is subject to Code Sections 401(a)(11) and 417. In the event of disability, a participant may receive a distribution at any time. Hardship and in-service withdrawals are allowed, subject to the Plan provisions.

Forfeited Accounts: Participants who terminate employment forfeit a non-vested portion of their account. Forfeitures may be used to reduce future employer contributions. For the year ended June 30, 2024, employer contributions were reduced by \$26,844 from forfeited non-vested accounts. At June 30, 2024, there were no remaining forfeited non-vested accounts.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Investments held by a defined contribution plan are required to be reported at fair value.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when earned. Fees related to notes receivable from participants are charged directly to the participant's account and are included in administrative expenses when incurred. Participant loans in which the participant has a distributable event (such as employment termination, death, or disability) are deemed distributions, at which point, the remaining loan balance is adjusted to distributions and removed from net assets available for benefits. Delinquent loans (although they may be "deemed distributions" for tax purposes) are assets of the plan for financial statement purposes, and continue to accrue interest, until they are determined to be uncollectible or cancelled in the event the loans go into "default". This is because active participants may still have an opportunity to make the delinquent payments. Therefore, this may result in a reconciling item between the Form 5500 and the financial statements.

Payment of Benefits:

Benefits are recorded when paid. There were no benefits requested before the year-end that were unpaid at year-end.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates:

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition:

Investments in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the plan's realized gains and losses on investments sold during the year, as well as unrealized gains on investments held at the end of the year.

Amounts held in the General Account are valued at contract value which approximates fair value. Amounts held in the General Account are cash equivalents and are not subject to fair value evaluation.

Recently Issued Accounting Standards:

In December 2022, Congress passed the Securing a Strong Retirement Act of 2022 ("the Act"). The Act's provisions have effective dates ranging from January 1, 2023 through January 1, 2026. Among other changes, the Act includes an increase in required minimum distribution ("RMD") age, decreased penalties for missed RMD's, Roth employer match option, penalty free withdrawals for terminal illness, reduced service income requirement for part-time, long-term employees, hardship withdrawal self-certification, age and income-based catch-up contribution requirements, and an automatic enrollment requirement for new plans. Employers may amend their plan to take into account Secure 2.0 Act provisions by December 31, 2026, provided their plan operates in accordance with such amendment as of its effective date. The Plan is reviewing the provisions of the Act. The Plan is currently evaluating whether or not to implement certain optional features within the Act. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown on the statements of net assets available for benefits as of June 30, 2024 and 2023;
- Net investment activity as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2024;
- Investment information included in the footnotes and supplemental schedule of assets (held for investment purposes at end of year) as of June 30, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurement and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices accessible in active markets for identical assets or liabilities at the measurement date.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets or inputs (other than quoted prices) that are observable or that are derived principally from or corroborated by observable market data through correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used for the year ended June 30, 2024. During the year ended June 30, 2024, there were no transfers of financial instruments into or out of Level 3.

Mutual Funds: Valued at closing price reported on the active market on which the individual funds are traded. Mutual funds held by the Plan are open ended mutual funds that are registered with the Securities & Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed activity traded. The Plan can redeem these investments daily, and there are currently no redemption restrictions on these investments.

NOTE 5. RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of Mutual of America Life Insurance Company. Mutual of America is the custodian as defined by the Plan, and therefore, these transactions with an affiliate qualify as party-in-interest transactions. Fees paid by the Plan for commissions and investment management services amounted to \$4,838 for the year ended June 30, 2024.

NOTE 5. RELATED-PARTY TRANSACTIONS (CONTINUED)

The Plan's administrative fees, other than the contract administrator fee and commissions, are paid by the Center. Therefore, these expenses are excluded from these financial statements. In addition, the Center provides certain services, such as accounting, to the Plan without compensation.

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA. In the event of plan termination, participants immediately become 100 percent vested in the employer contribution portion of their accounts.

NOTE 7. PLAN TAX STATUS

Individually designed 403(b) plans currently are not required to submit plans to the Internal Revenue Service for determination.

The IRS has informed Mutual of America Life Insurance Company, the prototype plan sponsor of the Plan, in an opinion letter dated March 31, 2017, that the form of the Plan is acceptable under the requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code and the Plan continues to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
