Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of The Kinkaid School 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended July 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Kinkaid School 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of July 31, 2024 and 2023 and for the year ended July 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of The Kinkaid School 403(b) Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

As discussed in Note 8, The Kinkaid School 403(b) Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to August 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Kinkaid School 403(b) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.


Auditors' Responsibilities for the Audit of the Financial Statements

Notes to Financial Statements for the year ended July 31, 2024

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of The Kinkaid School 403(b) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan established September 1, 1967, covering substantially all employees of The Kinkaid School, Inc. (the School), other than non-resident aliens, students and those who normally work fewer than 20 hours per week and less than 1,000 hours per year. Covered employees are eligible to participate on the first day of the month following their employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – The Plan provides for both participant contributions and employer contributions as follows:

- *Participant contributions* – Participants may contribute a minimum of 1% up to 100% of their compensation on a pre-tax basis as defined by the Plan, subject to certain limitations under the Internal Revenue Code (the Code). Participants age 50 and older may elect to make additional catch-up contributions, as defined by the Plan. Participants also may rollover any amounts they receive as distributions from another qualified retirement plan. Effective January 1, 2024, the Plan was amended to allow participants to contribute after-tax Roth deferrals and rollovers into the Plan.
- *Employer contributions* – The School makes a matching contribution equal to 100% of the participant's elective deferral subject to the maximum contribution schedule for all faculty employees who are assigned to teach at least three classes for the full school year and for faculty and non-faculty employees who are scheduled or have completed 1,000 or more hours of service during the Plan year as follows:

Participants direct the investment of all contributions into various investment options offered by the Plan.

Vesting – Participants are immediately 100% vested in all contributions plus actual earnings thereon.

Participant accounts – Each participant's account is credited with the participant's contribution and an allocation of the investment earnings and expenses for each fund in which their account is invested. Allocations of investment income and expenses are based on the proportion that each participant's account balance bears to the total of all participant account balances. The only benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Distribution of benefits – The Plan provides for benefit distributions to plan participants or their beneficiaries, equal to the balance of their accounts upon death, disability, retirement, or other termination of employment. Participants may withdraw a portion or all of their account balances, while still employed, upon reaching the age of 59½. Additionally, participants may qualify for a hardship withdrawal of their elective participant contributions, while still employed, for the purpose of immediate and heavy financial needs, as defined in the Plan document. In-service withdrawals of rollover contributions also are permitted.

Plan termination – Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The Plan’s financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the investment advisers and insurance companies. See Note 7 for discussion of fair value measurements.

The Plan invests in fully benefit-responsive investment contracts and presents these investments in the financial statements at contract value. Because contract value is the amount participants would receive if they were to initiate permitted transactions under the Plan, it is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. The contract value of fully benefit-responsive investment contracts represents contributions plus earnings, less participant withdrawals and administrative expenses.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Contributions from Plan participants and the employer matching contributions are recorded in the year in which the participant contributions are withheld from compensation.

Benefit payments – Benefit payments to participants are recorded upon distribution.

Expenses – Certain expenses of maintaining the Plan are paid directly by the School and are excluded from these financial statements. Certain investment management fees are included in net appreciation in fair value of investments. Other investment-related and recordkeeping expenses paid by the Plan are included in administrative expenses.

Estimates – Management must make estimates and assumptions to prepare financial statements in accordance with generally accepted accounting principles. These estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported amounts of additions and deductions. Actual results could vary from the estimates that were used.

NOTE 3 – TAX STATUS

The School has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated March 31, 2017 stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Code. Plan management has indicated it will take the necessary steps, if any, to bring the Plan’s operations into compliance with the Code.

NOTE 4 – INVESTMENTS

At July 31, 2024 and 2023, certain assets of the Plan which relate to contributions made before March 1, 2013 and related earnings were invested in funds managed by Teachers Insurance and Annuity Association of America (TIAA), College Retirement Equities Fund (CREF) and American General Life Insurance Company (AGLIC), as insurance companies. These transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.

Individual investments that represent 10% or more of the Plan’s net assets as of July 31 are as follows:

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.

NOTE 5 – INFORMATION CERTIFIED BY INSURANCE COMPANIES AND CUSTODIAN

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of July 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended July 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA, CREF, AGLIC, and State Street Bank and Trust Company, qualified institutions.

NOTE 6 – INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

TIAA Contracts

Prior to March 1, 2013, some plan participants entered into investment contracts with TIAA. The fixed annuity portion of these contracts, or the TIAA Traditional Annuity Account (TIAA TAA), is maintained by TIAA in a general account and is backed by TIAA’s claim-paying ability. During the accumulation phase, TIAA TAA provides a guarantee of principal, a guaranteed minimum rate of interest, and the potential for additional interest if declared by TIAA. Together, the guaranteed minimum and additional amounts make up the “crediting rate” in the accumulation phase of the account. TIAA groups the funds received over discrete time periods into “vintages.” The interest credited to each vintage reflects the investment returns initially obtained on TIAA’s investments during the period. Certain TIAA contract

types are fully benefit-responsive; therefore, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to these contracts. Of the amounts invested in TIAA TAA, \$8,946,326 and \$10,107,713 are fully benefit-responsive at July 31, 2024 and 2023, respectively, and \$334,467 and \$332,467 are non-benefit-responsive at July 31, 2024 and 2023, respectively. Non-benefit-responsive contracts contain liquidity restrictions on the redemption of TIAA TAA accumulations by participants, which could impact the value realized upon exiting the contract.

PRIAC Contract

The Plan has entered into a benefit-responsive investment contract with Prudential Retirement Insurance and Annuity Company (PRIAC). Under the group annuity contract, fixed interest contributions are maintained by PRIAC in a guaranteed separate account, the Prudential Principal Preservation Separate Account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. PRIAC is contractually obligated to repay the principal at a specified rate that is guaranteed to the Plan. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at contract value; however, percent limitations do apply each year.

Crediting Interest Rates

The methodology for calculating the crediting interest rate for each contract is as follows:

TIAA Contracts

The crediting interest rate is supported by the investment performance of a large, diversified portfolio (TIAA's general account), is correlated with the highest quality debt security yields, and is adjusted for contract liquidity, but may not be less than 1.0% to 3.0% based on the individual participant's contract type. TIAA declares a current interest rate annually.

PRIAC Contract

The crediting interest rate is based on current economic and market conditions and the general interest rate environment. The rate is established without the use of a specific formula and is not based on the performance of the assets held in the collateral account (the Prudential Principal Preservation Separate Account). The minimum crediting interest rate is based on an average yield of five-year treasury securities over a period of time specified in the contract, less 1.25%, but not less than 1.0% nor greater than 3.0%. The crediting interest rate is subject to reset semi-annually on January 1st and July 1st and is guaranteed for a six-month period.

The Plan's ability to receive amounts due under each contract is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

inflation-indexed bonds whose returns are designed to track a specified inflation index over the life of the bond. Lifecycle accounts seek high total return over time through a combination of capital appreciation and income by investing in an asset allocation strategy designed for investors planning to retire at certain intervals. There are no participant-directed redemption restrictions; however, the Plan is required to provide a notice 60 days in advance, but no more than 90 days, to liquidate its entire share in the accounts. Redemptions can be made daily and there are no unfunded commitments.

Following is a description of the valuation methods and inputs used for each major class of assets measured at fair value. There have been no changes in the methods used at July 31, 2024 and 2023.

- *Mutual funds* are valued using quoted market prices. These funds are all traded on an exchange in an active market.
- *CREF accounts* invest principally in equity securities, fixed-income instruments and short-term investments in accordance with each portfolio's investment objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments, including matrix pricing. CREF Money Market Account holdings are generally valued at amortized cost. Each account determines its unit value each day. Unit values are published each day the New York Stock Exchange (NYSE) is open and are the basis for current transactions.
- *TIAA Real Estate Account* generally invests in real estate properties and real estate-related investments. The account's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. Securities held are priced using values obtained from independent pricing sources. Unit values are calculated and published each day the NYSE is open and are the basis for current transactions.
- *Non-benefit responsive fixed annuity contracts* are valued using a quantitative model based on assumptions of future interest rates and related discounted cash flows. Since the annuity is not available for sale or transfer on any securities exchange, transactions in similar investments are not observable.
- *TIAA Access accounts* are variable annuities funded through the TIAA Separate Account VA-3 (VA-3), a separate investment account of TIAA registered under the Investment Company Act of 1940. VA-3 invests in mutual funds through various subaccounts. The subaccounts are valued at the net asset value (NAV) of the shares held by the Plan. The NAV is used as a practical expedient to estimate the fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities.

These valuation methods may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate, the use of different methods or assumptions could result in a different fair value measurement at the reporting date.

Purchases of Level 3 assets during the year ended July 31, 2024 totaled \$22,082. There were no transfers into or out of Level 3 for the year ended July 31, 2024. The following table represents the Plan's Level 3 financial instruments, the valuation techniques used to measure the fair value of those financial instruments, and the significant unobservable inputs and the ranges of values for those inputs.

NOTE 8 – NET ASSETS AVAILABLE FOR BENEFITS

The provisions of ERISA related to 403(b) plans for plan years beginning after January 1, 2009 were amended to include an audit requirement for large plans (generally those with 100 participants or more). Prior to that time, the School did not routinely receive participant account records from the third-party administrator. Further, the School's record retention policies did not result in the maintenance of payroll records dating to the inception of the Plan. As a result, adequate documentation was not available for the Plan to verify the proper balance of net assets available for benefits at July 31, 2010, which was the first year an audit was required.

NOTE 9 – SUBSEQUENT EVENTS

Management has evaluated subsequent events through April 25, 2025, which is the date that the financial statements were available for issuance. As a result of this evaluation, no events were identified that are required to be disclosed or would have a material impact on reported net assets available for benefits or changes in net assets available for benefits.
