### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Lawrence School 403(b) Defined Contribution and Tax Deferred Annuity Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### 1. Description of the Plan

The following description of the Lawrence School 403(b) Defined Contribution and Tax Deferred Annuity Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan under section 403(b) of the Internal Revenue Code (IRC) covering substantially all employees of the Lawrence School (the Organization and Plan sponsor), except for students, non-resident aliens, and employees working less than 1,000 hours during the Plan year. Employees are eligible to participate in the Plan at the commencement of employment. Employees may enter the Plan on the earlier of the first day of January or July. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Plan management is responsible for oversight of the Plan.

Teachers Insurance and Annuity Association of America (TIAA) is the Plan's recordkeeper, and together with College Retirement Equities Fund (CREF) (collectively, TIAA) is a custodian and insurance company issuer of the annuity contracts to the Plan. In addition, TIAA Trust, N.A. is the custodian of the mutual funds held by the Plan.

#### *Contributions*

Participants may elect to contribute 1% to 100% of their pre-tax annual compensation as defined in the Plan document and subject to Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may not rollover amounts from other qualified defined benefit or contribution plans into this Plan. The Organization may make a discretionary matching contribution to the Plan participants eligible (as defined) on a pro-rata basis based on employee compensation. A participant must be 21 years of age and have completed one year of service to be eligible for the Organization's contributions. The Organization contributes 100% of matching contributions up to 3% of eligible wages that a participant contributes to the Plan. After completing 10 years of service, employees are eligible to receive an employer matching contribution up to 6% of eligible wages.

Effective July 1, 2024, the Plan implemented a 3% automatic enrollment provision for eligible new hires and allows for Roth contributions. Effective August 16, 2024, the Plan offers an annual 1% automatic escalation provision up to 10% to eligible current and future participants.

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 containing over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator determined the optional provisions to elect and amend the Plan document. Most of the significant provisions became effective during 2024 and thereafter.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, Plan sponsor contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant

earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their salary reduction contributions and the Plan sponsor's contributions plus actual earnings thereon.

### ***Payment of Benefits***

Distributions from a participant's account are permitted in the event of death, disability, termination of employment or financial hardship, as defined. A participant may receive in-service distributions of the participant's salary deferral contributions at the attainment of age of 59 ½. Participants may elect to receive a single lump-sum amount equal to the value of the participant's vested interest in his or her account, installment payments or an annuity contract. If a participant's account balance is less than \$1,000, the Plan may make an automatic lump sum distribution to the participant. Effective November 1, 2022 the automatic lump sum distribution limit was increased to \$5,000. Distributions are subject to the applicable provisions of the Plan agreement.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodians and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Plan Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

### *Subsequent events*

The Plan has evaluated subsequent events through April 15, 2025 the date the financial statements were available to be issued.

## **3. Certified Investments**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the TIAA and CREF, the custodians of the Plan. In addition, TIAA certified on behalf of TIAA Trust, N.A., the custodian of the mutual funds and related earnings held by the Plan.

## **4. Guaranteed Investment Contracts**

*TIAA Traditional Annuities:* The TIAA Traditional Annuities (TIAA Traditional) are fixed annuity contracts that are fully and unconditionally guaranteed by TIAA. During the “accumulation phase”, the TIAA Traditional provides a guarantee of principal, a guaranteed 3% minimum rate of interest and the potential for additional interest if declared by TIAA’s Board of Trustees. Additional interest, when declared, remains in effect for the declaration year and is not guaranteed for future years. Contributions to a participant’s account purchases a guaranteed amount of lifetime annuity income. When the accumulation in the TIAA Traditional is converted to an annuity based on life expectancy, the present value of the stream of payments is equal to the accumulation.

The TIAA Traditional is offered through a variety of contract types which are both nonbenefit-responsive and fully benefit-responsive. The nonbenefit-responsive contract has certain liquidation restrictions with respect to lump-sum cash withdrawals and transfers. The Group Supplemental Retirement Annuities (GSRA) contract is considered fully benefit-responsive and does not have liquidity restrictions (as noted below). The type of contract through which a participant invests in the TIAA Traditional determines the interest declarations, the degree of liquidity of the participant’s account, and the options for receiving income upon retirement. Together, the guaranteed minimum interest and additional interest, when declared, make up the crediting interest rate. See Note 5 for additional crediting interest rates.

### *Fully Benefit-Responsive Contract*

The Plan holds a traditional fully benefit-responsive guaranteed investment contract (FBRIC) with TIAA totaling \$715,797 and \$722,514 at December 31, 2024 and 2023, respectively.

This contract represents a TIAA Traditional fixed annuity, the GSRA. TIAA maintains the contributions in a general account.

The FBRIC is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The FBRIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the FBRIC criteria and therefore is reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent upon the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

There are no events noted in the contract that would limit the ability of the Plan to transact at contract value with participants.

There are no events that would allow the issuer to terminate the contract with the Plan and settle at an amount different than the contract value.

The Organization does not believe that any events which would limit the Plan's ability to transact at contract value are probable of occurring.

## 5. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the funds. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and transact at that price.

*Variable annuities:* The CREF Accounts and the TIAA Access Annuity (TIAA Access) are separate accounts of TIAA which are variable annuities registered with the SEC as open-end management investment companies under the Investment Company Act of 1940.

The CREF Accounts are published on the National Association of Securities Dealers Automated Quotations (NASDAQ), but not traded on this or any public exchange. Investments in the CREF Accounts are valued at the accumulation unit value (AUV) as determined in accordance with the policies and procedures reviewed by CREF and are calculated daily.

The TIAA Access operates as a unit investment trust and invests in shares of underlying mutual funds. Investment in TIAA Access is valued at the AUV as determined in accordance with the policies and procedures reviewed by TIAA and is calculated daily. The AUV is considered a net asset value (NAV) used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the TIAA Access. This practical expedient is not used when it is determined to be probable that the TIAA Access will sell the investment for an amount different than the reported NAV. The annuities allow for daily redemptions and contributions. The investment strategy of the annuities mirrors the investment strategy of the underlying mutual funds.

*Pooled separate account:* The TIAA Real Estate Account is an investment option offered through the group variable annuity contract issued by TIAA. Investment in the TIAA pooled separate account is valued at the AUV as determined in accordance with the policies and procedures reviewed by TIAA and CREF. This pooled separate account's daily unit values are published on the NASDAQ, but not traded on this or any public exchange. The account allows

for daily contributions. Internal transfers from this account are limited to once per quarter. TIAA limits the ability of participants to transfer funds into the TIAA Real Estate Account. Specifically, individual participants are limited from making internal transfers into their account if, after the transfer, the total value of the participant's account (under all contracts issued to the participant) would exceed \$150,000.

*Nonbenefit-responsive guaranteed investment contract:* The TIAA Traditional Annuity account is reported at fair value, as approximated by contract value, which is determined by the sum of the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. Fair value is determined and reported to the Plan by TIAA and CREF. The TIAA Traditional Annuity is not available for sale or transfer on any securities exchange. This annuity contract is subject to various restrictions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of investments within the fair value hierarchy. Changes in economic conditions or valuation techniques may require a transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. There were no transfers into or out of Level 3 investments during the years ended December 31, 2024 and 2023. In determining the reasonableness of the fair value of the Level 3 investments, Plan management reviews the terms of the contracts and information provided by TIAA and CREF.

### 6. Related-Party and Party In Interest Transactions

Certain Plan investments are managed by TIAA and CREF. TIAA, CREF and TIAA Trust, N.A. are the custodians of the Plan. TIAA is the recordkeeper for the Plan. During the years ended December 31, 2024 and 2023, the Plan paid fees to TIAA of \$14,307 and \$2,991, respectively. Therefore, these transactions qualify as party in interest transactions.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100 percent vested in their Organization's contributions.

### 8. Tax Status

The Plan adopted a volume submitter 403(b) plan sponsored by TIAA. TIAA received an opinion letter dated August 7, 2017 from the IRS stating that the prototype plan is acceptable under Section 403 (b) of the IRC for use by employers for benefit of their employees. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan and related trust are designed and operating in accordance with applicable sections of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
