INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the
Host Healthcare 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of Host Healthcare 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of March 11, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period January 1, 2024 through March 11, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Host Healthcare 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of March 11, 2024 and December 31, 2023, and for the period January 1, 2024 through March 11, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Host Healthcare 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

The accompanying financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Note 1 to the financial statements, the Board of Directors of Host Healthcare, Inc. elected to liquidate the Plan on March 11, 2024 and to transfer Plan assets to Medical Solution 401(k) Plan which indicates that the Plan is not a going concern. The financial statements do not include any adjustments that might be necessary upon liquidation. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – PLAN DESCRIPTION

The following description of the (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan, which was adopted on October 15, 2013, is a defined contribution plan covering substantially all employees of Host Healthcare, Inc. and Locorum Healthcare Staffing, Inc. (the "Company" or the "Employer"). The Plan was amended and restated effective January 1, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness and monitors performance of the Plan's investment offerings.

On February 2, 2023, the Board of Directors of Host Healthcare, Inc. elected to liquidate the Host Healthcare 401(k) Plan with an effective date of January 2, 2024, in conjunction with the sale of the Company to Medical Solutions, L.L.C. As a result, the Host Healthcare 401(k) Plan was frozen effective December 22, 2023. All Plan assets were transferred to the Medical Solutions 401(k) Plan between January 2, 2024 and March 11, 2024. As a result, the Plan is not a going concern. The financial statements do not include any adjustments that might be necessary upon liquidation.

Contributions - Participant salary reduction contributions: Participants could contribute up to 100% of pretax annual compensation, as defined by the Plan. Participants who attained age 50 before the end of the plan year were eligible to make catch-up contributions. As defined by the Plan, participants were permitted to designate a portion or all of the deferral contributions they were otherwise eligible to make under the Plan as Roth deferral contributions. Such contributions were 100% vested and nonforfeitable. Participant contributions were subject to certain Internal Revenue Service ("IRS") limitations.

Employer discretionary matching contributions: The Company could make a discretionary matching contribution in an amount equal to a percentage of participant salary reduction contributions, as determined by management. Employer discretionary matching contributions were made through 2019 and were replaced by the Employer safe harbor matching contributions below.

Employer safe harbor matching contributions: Effective January 1, 2020, the Company began making safe harbor matching contributions equal to 100% of each participant's contribution up to 3% plus 50% of each participant's contribution in excess of 3% to a maximum of 5%. For the period January 1, 2024 through March 11, 2024, the Company didn't make any safe harbor matching contributions. Participants were eligible to receive matching contributions through the Medical Solutions 401(k) Plan for this period.

Employer discretionary and profit sharing contributions: The Company could make an Employer discretionary contribution and a profit sharing contribution to the Plan. The contributions were allocated to a participant's account in the same ratio as the participant's compensation bears to total compensation of eligible participants. These discretionary contributions were subject to overall Employer contribution limits and additions to individual participant account limits. The Company elected not to make an Employer discretionary or profit sharing contribution for the period January 1, 2024 through March 11, 2024.

Contributions (continued) - *Participant* rollover contributions: Participants could also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans.

Eligibility to Participate - Beginning in January 1, 2020, employees were eligible to make contributions after 6 months of service provided they were Eligible employees at that point as defined by the Plan. Employees who completed 1,000 hours of service in a year were eligible to receive Employer safe harbor matching, Employer discretionary, Employer discretionary matching and profit sharing contributions immediately upon meeting the service requirement.

Forfeitures - Any participant who terminated employment prior to the normal retirement date for reasons other than death or disability, forfeited all non-vested Employer contributions. Forfeitures of non-vested participant accounts could be used to first reduce Plan expenses and then to reduce future Employer contributions. At March 11, 2024 and December 31, 2023, the forfeited non-vested account balance totaled \$0. During the period January 1, 2024 through March 11, 2024, there was \$0 of forfeitures utilized to reduce Employer contributions and Plan expenses.

Notes Receivable from Participants - Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the value of their vested account balance on the loan date. Loan terms ranged from one to five years or up to 30 years for the purchase of a primary residence. At March 11, 2024 and December 31, 2023, there were no outstanding notes receivable from participants.

Participant Accounts - Each participant's account was credited with participant's contributions, rollover contributions, Employer safe harbor and discretionary matching contributions and Employer discretionary and profit sharing contributions and allocations of Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant account balances, as defined by the Plan. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account. Participants directed the investment of their contributions into various investment options offered by the Plan.

Payment of Benefits - Upon disability, retirement, or death, participants could elect to receive a distribution of their account (as defined) in lump sum, or defer distribution if the account exceeded \$5,000. For termination of service for other reasons, participants could receive the value of the vested interest in their account in a lump sum or elect to defer receiving these benefits until retirement age if the vested account balance exceeded \$5,000.

Hardship Withdrawals - Participants could withdraw their vested contributions in the event of hardship as defined in the Plan agreement as a "qualified distribution."

Vesting - Participants were vested immediately in their contributions and the Employer safe harbor matching contributions plus actual earnings thereon. The participants vesting schedule for the Employer's discretionary matching and Employer's discretionary and profit sharing contributions were as follows:

For vesting purposes, a year of service was defined as the total number of a participant's countable periods of service without regard to hours of service.

Participants became fully vested upon transfer for reason of retirement, death or disability. Upon the Board's decision to liquidate the Plan on February 2, 2023, all participants became fully vested. Nonvested benefits were forfeited by participants upon liquidation for reasons other than normal retirement, death or disability.

Plan Liquidation – During the period January 1, 2024 through March 11, 2024, the remaining Plan assets were transferred to the Medical Solutions 401(k) Plan, at which time, all Plan assets were deemed to be fully liquidated.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates that were used.

Payment of Benefits - Benefits were recorded when paid.

Administrative Expenses - The Company pays expenses incurred for the administration and operation of the Plan. Other administrative fees associated with distributions and loans were paid by the participants. For the period January 1, 2024 through March 11, 2024, administrative expenses paid by the Plan was \$30.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment Valuation and Income Recognition - The group annuity contract was a fully benefit-responsive, and therefore, reported at contract value. See Note 4 for discussion of the group annuity contract. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends (if declared) were recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the trustees, Empower Annuity Insurance Company of America and Empower Trust Company, LLC have certified to the completeness and accuracy of all investments in the accompanying statements of net assets available for benefits as of March 11, 2024 and December 31, 2023, and the statement of changes in net assets available for benefits for the period January 1, 2024 through March 11, 2024.

NOTE 4 – GROUP ANNUITY CONTRACT

The Plan had a group annuity contract with Great-West Life & Annuity Insurance Company that invested contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund was a general account product. The methodology for calculating the interest crediting rate was based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the Key Guaranteed Portfolio Fund approximates fair value.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest was based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates were reviewed on a quarterly basis for resetting.

NOTE 5 – TRANSFERRED OUT TO OTHER PLAN

During the period January 1, 2024 through March 11, 2024, the remaining Plan assets of \$268,996 were transferred out to another plan, at which time, all Plan assets were fully liquidated.

NOTE 6 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Empower Annuity Insurance Company of America, Empower Trust Company, LLC and Host Healthcare, Inc. are parties-in-interest in accordance with the definition provided by ERISA. Certain Plan investments were held in and transacted in accounts managed by Empower Annuity Insurance Company of America. These investments and transactions qualify as exempt party-in-interest transactions.

NOTE 7 – TAX STATUS

The Plan utilizes a Defined Contribution Volume Submitter Plan of a third-party administrator. The third-party administrator obtained its latest advisory letter on March 31, 2014, in which the IRS stated that the document is designed and in compliance with the applicable requirements of the Internal Revenue Code (“Code”). Although the document has been amended and restated since receiving this determination letter, the Plan Administrator, the Plan’s trustee and third-party administrator believe the Plan is designed and currently operating in compliance with the applicable requirements of the Code; and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 11, 2024 and December 31, 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 – SUBSEQUENT EVENTS

The Plan Administrator has evaluated subsequent events, as defined by FASB ASC 855, Subsequent Events, through the date that the financial statements were available to be issued on April 8, 2025.
