*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Alliance Partners 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (an ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following description of Alliance Partners 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

The Plan is a multiple employer plan sponsored by NCP Management Holdings, Inc. (formerly NCP CAPCO Development Co., Inc.) (the Sponsor) as a defined contribution plan. Employees eligible to participate in the Plan are those employees of NCP Management Holdings, Inc., Firerock Products, LLC, Empirian Health, LLC, and Care Services LLC (collectively, the Employers). Participants should refer to the joinder agreements of each Employer to determine the eligibility requirements of the Plan as adopted by the respective Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Plan Amendment and Restatement**

Effective January 1, 2024, the Plan was amended and restated in order for the Plan sponsor to change the Company name to NCP Management Holding, Inc. and change the EIN to 20-2154231.

#### **Contributions**

Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) matching contributions made by the Employers, (iii) safe harbor matching contributions made by the Employers, (iv) nonelective contributions made by the Employers, and (v) rollovers (including in-Plan Roth rollovers) from new participants in another qualified plan. Participants should refer to the joinder agreement of each Employer for a complete description of the Employers' contributions to the Plan. Participants may direct the investment of their contributions and any Employers' contributions into various investment options offered by the Plan. Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan document, and Roth contributions not to exceed federal limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

## Alliance Partners 401(k) Plan

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### **Administrative Expenses**

Certain administrative expenses of the Plan, including trustee, recordkeeping and accounting fees, have been paid by the Sponsor and/or Employers. Participant initiated distribution and loan fees are charged directly to the participant's account. All other administrative expenses and investment transaction fees (including investment-related expenses which are included in net appreciation in fair value of investments) are paid by the Plan.

##### **Participant Loans**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions. Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### **Vesting**

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in all other Employers' contribution portions of their accounts plus earnings thereon is based on years of continuous service. Participants should refer to the Joinder agreements of each Employer to determine the vesting requirements of the Plan as adopted by the respective Employer.

##### **Benefit Payments**

On termination of service due to separation, death, disability, or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Hardship and in-service withdrawals may be available as defined in the Plan document.

#### **1. Description of the Plan (continued)**

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Employers' contribution and Plan earnings or losses from that account's activities. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Forfeitures**

Forfeitures of terminated nonvested participant accounts may be used to pay administrative expenses of the Plan or to reduce future Employers' contributions.

##### **Plan Termination**

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue contributions and participation in the Plan at any time and the Sponsor may terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100 percent vested in matching and any nonelective Employers' contributions.

#### **2. Summary of Significant Accounting Policies**

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend rate. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and any investment-related expenses. The Plan provides for investments in various investment securities that in general are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management of the Sponsor to make estimates that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Basis of Presentation**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

#### **3. Investment Information**

All investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Mid-Atlantic Trust Company, the trustee.

#### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2      Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;

#### 4. Fair Value Measurements (continued)

Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective trust: a stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the daily net asset value (NAV) of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual funds: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**5. Tax Status**

The Company adopted a non-standardized pre-approved profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax.

**6. Subsequent Events**

Management of the Sponsor evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through April 28, 2025 which is the date the financial statements were available to be issued.
