Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.



NOTES TO THE FINANCIAL STATEMENTS

Period Ended September 13, 2024, and Year Ended December 31, 2023

NOTE 1. DESCRIPTION OF PLAN

The following description of the Alta Planning + Design, Inc. 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution 401(k) profit sharing plan, originally adopted January 1, 2003 and most recently amended and restated January 1, 2021. The Plan covers all full-time, non-union employees of Alta Planning + Design, Inc. (the “Plan Sponsor”) who are age 21 or older and who have completed 250 hours of service within three consecutive months of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Plan merged with The Trilon Group Retirement Savings Plan, formerly Waggoner Engineering, Inc. 401(k) Plan & Trust. The successor plan is sponsored by Trilon Group, LLC, which purchased the Plan Sponsor in 2023 (Note 7).

Contributions – Participants may elect to contribute a portion of their pretax or post-tax (Roth) annual compensation, as defined by the Plan up to the maximum allowed under the Internal Revenue Code, which was \$23,000 in 2024. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Plan has automatic enrollment for all newly eligible participants. Unless elected otherwise, employees will be auto-enrolled with a 2% pre-tax deferral rate once the eligibility requirements are met.

The Plan is required to make mandatory annual safe harbor matching contributions and has the option to make an additional annual discretionary profit-sharing contribution. In 2023, the Plan Sponsor made safe harbor matching contributions equal to 100% of the first 4% of eligible compensation. No contributions were made during the 2024 plan year.

Investment Elections – Participants may choose any combination of investments as presented in the Plan documents. The accounts of employees who do not choose among these options are automatically invested in the appropriate Target Institutional Retirement Fund that most closely corresponds with their expected retirement age. Participants can change investment combinations as often as permitted under the particular investment vehicle.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Plan Sponsor’s contributions, (b) Plan earnings (losses), (c) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in the Plan Sponsor’s safe-harbor contributions plus actual earnings thereon. Vesting in the remainder of their account is based on years of service and occurs gradually. After one, two, three, four, and five years of credited service, the Plan Sponsor’s discretionary contribution portion becomes 20, 40, 60, 80, and 100 percent vested, respectively, to the participant. Participants shall become 100% vested upon attainment of normal retirement age, death, or disability.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, rollover their account balance to another qualified plan, or individual retirement account, as specified by Plan provisions. Hardship withdrawals are allowed by the Plan. The Plan Sponsor may force out accounts of terminated participants with balances of \$5,000 or less. These will be treated as a lump distribution.

Forfeited Accounts – At September 13, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$1,490, respectively. Forfeitures may be used to pay administrative expenses of the Plan with any remaining amounts used to reduce employer contributions. Forfeitures used to reduce employer contributions were \$0 and \$5,172 during the period end September 13, 2024, and the year ended December 31, 2023, respectively.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant’s vested account balance. Participant loans are secured by the vested balance of the participant’s account with stated interest rates. The repayment terms provide for loans to be amortized over a reasonable period of time not to exceed five years, unless the loan is used for the purchase of a primary residence. Effective January 1, 2024, outstanding loan balances of \$9,719 were fully paid and distributed to participants upon merger (Note 7).

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants – Notes receivable from participants are measured at amortized cost, which represent unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement.

Payment of Benefits – Benefits are recorded when paid. As of September 13, 2024, all participant distributions initiated during the ordinary course of Plan operations were completed. No unprocessed distributions remain at the merger completion date (Note 7).

Investment Valuation and Income Recognition – Shares of registered investment companies are valued at fair value based on published market prices. See Note 3 for further discussion of fair value measurement. The investment contract held in a general account is reported at contract value. Fair value and contract value of the investments of the Plan are certified by the custodians and insurance company of the Plan.

Purchases and sales of securities are recorded on a trade date basis. Interest income, including interest on outstanding loan balances, is recorded on an accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Expenses – Certain administrative activities are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Investment-related expenses are included in the net appreciation/(depreciation) of the fair value of investments.

Some investment options used by the Plan generate revenue sharing. The Plan is set up to return revenue sharing back to the participant account that generated it. This setup is taken into consideration by the Plan when evaluating the net expense of investment options used or being considered by the Plan.

Date of Management's Review – Subsequent events were evaluated through February 28, 2025, which is the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at September 13, 2024 and December 31, 2023.

Registered Investment Companies (Mutual Funds) – Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The following tables disclose the fair value hierarchy of the Plan’s assets by level as of September 13, 2024, and December 31, 2023:

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuations methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4. GUARANTEED INVESTMENT CONTRACT

In 2018, the Plan entered into a fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America (Empower). Empower maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attributable for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented at contract value on the face of the statements of net assets available for benefits. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. As of September 13, 2024, the contract was terminated, and to the Plan Administrator's knowledge, assets were released at contract value (Note 7).

The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, which is stipulated by the contract as 1.00%, and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the Plan for the years ended September 13, 2024, and December 31, 2023, was 1.39% and 1.23%, respectively.

The Plan may cease contributions and participation in the contract by written notice to the issuer 90 days ahead of the contribution cessation date. The Plan will then elect a cessation option to transfer at contract value the holdings in the contract. The Plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, and that also would limit the ability of the Plan to transact at contract value with the participants. These include but are not limited to premature termination of the contract by the Plan, plant closings, layoffs, plan termination, bankruptcy, and mergers.

NOTE 5. INFORMATION CERTIFIED BY THE CUSTODIAN

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, and Empower Annuity Insurance Company of America, the custodians of the Plan, have certified the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of September 13, 2024 and December 31, 2023, and related investment activity reflected in the statement of changes in net assets available for benefits for the period ended September 13, 2024.

NOTE 6. PARTIES-IN-INTEREST

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Plan Sponsor. The Plan Sponsor provides to the Plan certain accounting and administrative services for which no fees are charged.

Fees paid during the year to third party administrators or the trustees for services rendered by parties in interest were based on customary and reasonable rates for such services.

The Plan issues loans to participants, which are secured by balances in the participants' accounts. These transactions qualify as exempt parties-in-interest transactions.

Plan investments in shares of registered investment companies and investment contracts are managed by Empower Trust Company, LLC, and Empower Annuity Insurance Company of America. Empower Trust Company, LLC, and Empower Annuity Insurance Company of America are considered to be the Custodians as defined by the Plan. These transactions qualify as exempt parties-in-interest transactions.

NOTE 7. PLAN TERMINATION

The Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants who had an account balance as of December 27, 2023, were notified of a Plan merger and provided information regarding the Plan operations and distribution options. Participants became 100% vested in their account balances.

Effective January 1, 2024, the Plan merged with The Trilon Group Retirement Savings Plan, formerly Waggoner Engineering, Inc. 401(k) Plan & Trust. The successor plan is sponsored by Trilon Group, LLC, which purchased the Plan Sponsor in 2023. On January 3, 2024, Plan net assets available for benefits merged into the successor plan. The merger was completed on September 13, 2024, with the settlement of the Guaranteed Investment Contract (Note 4).

NOTE 8. TAX STATUS

The Plan adopted a pre-approved volume submitter plan document, which has an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is acceptable under the Internal Revenue Code (IRC) Section 401, as then designed. The Plan has not received an opinion letter specific to the Plan itself and the Plan has been amended since its adoption of the volume submitter Plan document for subsequent changes in applicable tax laws and regulations. However, the Plan administrator and the Plan's tax counsel believe that the Plan as designed was and continues to operate in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 8. TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 13, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
