Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Linzer Products Corp. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits - modified cash basis as of August 2, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits - modified cash basis for the period from January 1, 2024 through August 2, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Linzer Products Corp. 401(k) Plans' financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from Empower Trust Company, LLC as of August 2, 2024 and December 31 2023, and for the period from January 1, 2024 through August 2, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Linzer Products Corp. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Basis of Accounting

As discussed in Note 2, these financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Linzer Products Corp. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Note 1 - Description of Plan

The following description of Linzer Products Corp. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was established on January 1, 2019, and restated and amended on September 7, 2021, is a defined contribution plan covering substantially all employees of Linzer Products Corp. (the "Sponsor") who become eligible to participate in the Plan as of January 1 or July 1, coinciding with or following the date on which employees have attained age 21 or older and have completed one year of service, provided they worked at least 1,000 hours and are not otherwise specifically excluded as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The trustee of the Plan is Empower Trust Company, LLC. The custodians of the Plan are Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC. The recordkeeper of the Plan is Empower Life & Annuity Insurance Company of New York.

Effective August 1, 2024, the Sponsor entered into a Professional Employer Organization ("PEO") with CoAdvantage Corporation. On August 2, 2024, the total remaining Plan assets in the amount of \$7,907,621 were transferred into an existing multiple employer defined contribution plan with CoAdvantage Corporation Retirement Savings Plan (the "successor plan"). The financial statements have been prepared for the period from January 1, 2024 through August 2, 2024.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, not to exceed the limitations under the Internal Revenue Code (the "Code") for 2024 of \$23,000, plus a maximum of \$7,500 in catch-up contributions for participants who have attained age 50 before the end of the Plan year. Contributions may be made as a pre-tax deferral or after-tax (Roth) deferral. Highly compensated employees are subject to additional limits set forth in the Code. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Participants may modify salary deferral elections at any time. Contributions are automatically invested in a designated balanced fund until changed by the participant. Participants are immediately 100% vested in all elective deferrals made to the Plan, any investment earnings from these deferrals, and all employer matching contributions. Participant loans are not permitted from the Plan.

Contributions (cont'd.)

The Sponsor shall make a contribution for eligible employees employed by the Sponsor. The Sponsor, under safe harbor, must contribute 3% of all eligible compensation. During the period from January 1, 2024 through August 2, 2024, the Sponsor made safe harbor contributions of \$280,280. Under the terms of the Plan, the Sponsor may also make a nonelective discretionary contribution based on classifications of participants, as defined. Each participant constitutes a separate classification. During the period from January 1, 2024 through August 2, 2024, the Sponsor made a discretionary contribution of \$108,757 to a certain class of participants, representing 6% of the participants' total compensation for the year.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Sponsor's contributions, as well as allocations of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions and the Sponsor's contributions, plus actual earnings thereon.

Payment of Benefits

Upon retirement, termination of service, disability, or attainment of age 59½, a participant is entitled to receive distributions from all of his or her contribution accounts. A participant may receive a distribution from certain accounts in the case of financial hardship. In order to qualify for a hardship withdrawal, the participant must satisfy the legal requirements of a financial hardship as defined by Internal Revenue Code regulations.

Forfeitures

Forfeited nonvested accounts totaled \$0 and \$175 at August 2, 2024 and December 31, 2023, respectively. Forfeitures are used by the Plan to reduce future employer contributions. During the period from January 1, 2024 through August 2, 2024, there were no forfeitures utilized.

Note 2 - Summary of Significant Accounting Policies (cont'd.)

Basis of Accounting

The accompanying financial statements are prepared on a modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America ("U.S. GAAP") and is an acceptable method of accounting under Department of Labor regulations. The accounting records of the Plan are maintained on the basis of cash receipts and disbursements modified to record investments at fair market values and record investment income on the accrual basis. Accordingly, revenue and the related assets are recognized when received rather than when earned, and corrective distributions and expenses are recognized when paid rather than when the obligation is incurred.

Use of Estimates

The preparation of financial statements on the modified cash basis requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the group annuity contract, which is stated at contract value (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers. See Note 4 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation in fair value of investments. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan.

Note 4 - Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4 - Fair Value Measurement (cont'd.)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at August 2, 2024 and December 31, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan’s assets at fair value at August 2, 2024 and December 31, 2023. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. For the period from January 1, 2024 through August 2, 2024, there were no transfers between Levels 1 and 2 and no transfers in or out of Level 3.

Note 5 - Group Annuity Contract

As part of the Guaranteed Portfolio Fund, the Plan entered into a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company of America, which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum crediting interest rate, as stated in the contract, and prevailing market conditions. Crediting rates are reviewed on a quarterly basis for resetting.

Note 5 - Group Annuity Contract (cont'd.)

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Thus, the group annuity contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include:

- The Plan's failure of the trust to qualify for exemption under ERISA.
- Plan termination or merger.
- Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions.
- Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan.

The Plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The group annuity contract does not permit Empower Annuity Insurance Company of America to terminate the agreement prior to the scheduled maturity date.

Note 6 - Related Party Transactions and Party-in-Interest Transactions

The trustee of the Plan is Empower Trust Company, LLC. The recordkeeper of the Plan is Empower Life & Annuity Insurance Company of New York. The investment managers of the Plan are Cambridge Investment Research, Inc. and Empower Advisory Group, LLC. Therefore, fees paid by the Plan to these entities qualify as party-in-interest transactions. Such fees amounted to \$16,346 for the period from January 1, 2024 through August 2, 2024.

Note 7 - Tax Status

The Plan has adopted the pre-approved document of Empower Retirement LLC. The Internal Revenue Service ("IRS") has determined and informed Empower Retirement LLC by a letter dated November 14, 2022, that the Empower Retirement LLC Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believes that the Plan is qualified and the related trust is tax exempt.

The modified cash basis of accounting requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax benefit only if it is more likely than not that the tax position would be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that at August 2, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset), or disclosure in the financial statements. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Subsequent Events

The Plan administrator has evaluated all events or transactions that occurred after August 2, 2024 through January 16, 2025, which is the date that the financial statements were available to be issued. During this period, there were no material subsequent events requiring disclosure.
