**NOTE 1 DESCRIPTION OF PLAN**

The following description of McGough Companies 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established by McGough Construction Co., LLC and subsidiaries (collectively, the Company). The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Operations**

The Plan is sponsored and administered by the Company. Minnesota Life Insurance Company and Securian Trust Company, N.A. served as the insurance company and trustee of the Plan, respectively, through November 8, 2023. Effective November 9, 2023, Fidelity Management Trust Company serves as the trustee of the Plan. The insurance company and trustee are responsible for holding the investment assets of the Plan, carrying out participant-directed investment transactions, and making distributions to participants. The Company pays certain costs of administering the Plan, including professional services for recordkeeping, audit, tax, and legal matters of the Plan. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective June 21, 2024. The following provisions were added or changed:

- Wicked Machine Works, LLC was added as a participating employer effective March 1, 2023

**Eligibility**

Employees of the Company are eligible to participate in the deferral and discretionary match components of the Plan immediately upon hire. The Plan excludes leased employees, nonresident aliens, residents of Puerto Rico, and employees covered by a collective bargaining agreement, unless the agreement requires the employees to be included under the Plan.

Participants are eligible for discretionary employer profit sharing contributions immediately upon hire, subject to the following conditions. Participants must be employed by a participating affiliate of the Company on the last day of the Plan year and complete at least 1,000 hours of service during the Plan year to receive a profit sharing contribution, unless terminated due to retirement, death, or total and permanent disability.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. Participants may contribute up to the maximum amount allowed by law. Participants that are 50 years of age, or older, may elect to contribute additional catch-up contributions. Contributions, including catch-up contributions, are subject to Internal Revenue Service (IRS) limits. The Company may elect to make matching and/or profit sharing contributions.

**Contributions (Continued)**

For the Plan years ended December 31, 2024 and 2023, the Company made a discretionary nonelective contribution (profit sharing contribution) of \$3,673,437 and \$3,020,000, respectively (net of forfeitures applied). There were no discretionary matching contributions for the years ended December 31, 2024 and 2023.

**Participant Accounts**

Each participant's account is credited with the participant's elective deferral contributions, rollover contributions (if any), an allocation of the Company's contributions (if any), interest on loans (if applicable), and investment income or losses. Allocations of Company contributions are based on participant's eligible compensation, as defined in the Plan. The sum of these amounts represents the maximum benefit that participants are entitled to under the Plan.

**Investments**

Participants direct the investment of their contributions into various investment options offered by the Plan. The participant also directs Company contributions.

**Vesting**

Participants are always 100% vested in their elective deferral and rollover contributions to the Plan. Participants become vested in their allocated Company contributions ratably over a three-year period. Participants hired prior to January 1, 2015 are immediately 100% vested for all discretionary matching and discretionary nonelective contributions. Otherwise, a participant becomes fully vested immediately in Company contributions upon reaching normal retirement age, death, or becoming permanently disabled while employed.

**Notes Receivable from Participants**

Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less, with a minimum loan amount of \$1,000. The notes are secured by an assignment of the participant's vested interest in the Plan and bear a commercially reasonable fixed interest rate established by the Plan administrator. Interest rates on outstanding note balances were 6% to 9.5% at December 31, 2024 and 2023. Principal and interest are payable on a monthly basis over a term not to exceed five years, except in the case of loans for the purchase of the participant's principal residence, which may be longer. Loans that are not repaid when due are treated as distributions and become taxable income to the participant and could be subject to tax penalties.

**Benefit Payments**

Upon termination, retirement, or disability, a participant, or in the case of death, the participant's beneficiary, may elect to receive the vested balance in the participant's account. Benefit distributions of vested account balances of \$5,000 or more will be made in a lump-sum payment, installments, or partial withdrawals, as elected by the participant. Prior to November 9, 2023, vested account balances of less than \$5,000 were distributed only in a single lump-sum payment.

If a participant terminates employment and the participant's account balance does not exceed \$7,000 (\$5,000 in 2023), the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$7,000 (\$5,000 in 2023), the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. The Plan allows for in-service distributions if a participant reaches age 59 ½.

**Hardship Distributions**

Hardship distributions may be requested by the participant and are taxable per IRS guidelines. Qualified financial hardships include accident or illness; down payment on the purchase of the participant's principal residence; tuition, or fees for postsecondary educational costs; funeral expenses; payments necessary to prevent eviction from or foreclosure of the participant's principal residence; expenses for the repair of damage to the participant's principal residence that would qualify for a casualty loss deduction under Code Section 165; expenses or losses incurred on account of a disaster declared by FEMA, or any other financial need determined to be immediate and heavy under rules and regulations. The minimum hardship withdrawal is \$1,000 (\$500 effective November 9, 2023), and up to 100% of the participant's vested account balance may be distributed.

**Forfeited Accounts**

Forfeited accounts as of December 31, 2024 and 2023 totaled \$99,016 and \$3,454, respectively, and are included in investments in the statements of net assets available for benefits. Under the terms of the Plan, the Company can use forfeitures to pay Plan expenses or to reduce Company contributions. The Company elected to use forfeitures to offset the 2024 employer contributions in March 2025 in the amount of \$105,583. No forfeitures were used to offset the 2023 employer contributions. Employer contributions are shown net of forfeiture offset.

**Plan Termination**

Although it has not expressed any intent to do so, the Company may terminate the Plan at any time, subject to the provisions of the Plan and ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions and participants' account balances would be distributed in accordance with the terms of the Plan.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities, in general, are exposed to various risk factors, including, but not limited to, interest rates, market conditions, credit risk, and global market and geo-political risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis.

**Investment Income**

Interest income is recorded on the accrual basis and dividends (if any) are recorded on the ex-dividend date.

**Net Appreciation in Fair Value of Investments**

Net appreciation in fair value of investments includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation of investments held at the end of the year.

**Benefit Payments**

Deductions for benefits paid to participants or rollovers to another qualified plan or IRA are recorded when the funds are disbursed from the Plan.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Subsequent Events**

The Plan has evaluated subsequent events through May 6, 2025, the date the financial statements were available to be issued.

**NOTE 3 GROUP ANNUITY CONTRACTS WITH INSURANCE COMPANIES**

The Plan had a traditional fully benefit-responsive guaranteed investment contract with Minnesota Life Insurance Company through September 30, 2023. Effective October 1, 2023 the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with The Standard Insurance Company. The balance of these insurance contracts as of December 31, 2024 and 2023 were \$10,503,521 and \$8,727,717, respectively.

The insurance companies (Minnesota Life Insurance Company and The Standard Insurance Company) maintain the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses.

The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by the insurance companies, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The contracts prohibit direct transfers to a competing investment option. In addition, amounts transferred to a non-competing investment option may not be retransferred unless they have remained in the non-competing investment option for at least 90 days.

The guaranteed investment contracts do not permit the insurance companies to terminate the agreement prior to the scheduled maturity date.

**Limitations on the Ability of the Accounts to Transact at Contract Value**

Certain events might limit the ability of the Plan to transact at contract value with the issuers. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants other than contract discontinuance.

**Average Yields**

The guaranteed investment contract issuers are contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuers but may not be less than 1.5% (Minnesota Life Insurance Company) or 1% (Standard Insurance Company). Such interest rates are adjusted on a quarterly basis. The crediting rates of the contracts are intended to track current market yields on a trailing basis.

The crediting interest rate for the Minnesota Life Insurance contract was 2.10% for the year ended December 31, 2023. The crediting interest rate for The Standard Insurance Company contract was approximately 3.00% and 2.20% for the years ended December 31, 2024 and 2023, respectively.

**Contract Discontinuance**

In 2023, the Minnesota Life Insurance Company guaranteed investment contract was discontinued and a liquidation charge was applied. The Standard Insurance Company has agreed to make a payment of \$648,105 on the Plan's behalf of the exit charges assessed against the Plan by Minnesota Life Insurance Company. Subject to the minimum guaranteed interest rate, the Standard Insurance Company guaranteed investment contract interest rate will be reduced by 1.45% until the accumulated value of repayment due to the rate reduction reaches \$648,105 or for a period of 7 contract years, whichever occurs first. If the Plan terminates the contract or distributes substantially all assets before satisfying the repayment agreement, the remaining amount of \$648,105 will be deducted from the fund prior to the distribution of assets or will be invoiced to the Plan on the date termination of the contract is initiated.

**NOTE 4 LIFE INSURANCE POLICIES**

Prior to the adoption of the 401(k) deferral option, participants in the profit sharing plan were allowed to purchase life insurance policies from Northwestern Mutual Life (NWML). As of December 31, 2022, the Plan owned two policies for one participant with NWML and did not own any policies as of December 31, 2023. Each policy was a separate contract with NWML subject to crediting rates and other contract provisions typical for a life insurance policy. The life insurance policies are included in the financial statements at the cash surrender value. Premiums were paid from the participant's Plan account. Premiums paid are reported as a deduction, net of dividends, in the statements of changes in net assets available for benefits. No policies have been added to the Plan since 1990.

At the participant's election, the Plan will surrender, distribute, or transfer ownership of the policy. Participants electing to surrender their policies are required to transfer the cash value of the policies to their account. For participants electing to have their policies distributed out to them or transferred to a beneficiary, the cash surrender value of the policy is reported in the Plan financial statements as benefits paid to participants. In the event that an active participant dies, death benefits received by the Plan and the cash surrender value of the policy will be paid out to the participant's named Plan beneficiaries.

As of December 21, 2023, the life insurance policies with NWML were surrendered and transferred at the participant's election to the new qualified institution of the Plan effective November 9, 2023.

**NOTE 5 FAIR VALUE OF INVESTMENTS**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value, and requires additional disclosures about fair value measurements. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to financial assets valued using quoted prices from active markets for identical assets; Level 2, which refers to financial assets not traded on an active market, but for which observable market inputs are readily available; and Level 3, which refers to financial assets valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Asset Valuation Techniques**

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Investment Fund* – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 7 EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

The Plan engages in transactions involving the acquisition and disposition of investments managed by the qualified institutions and investment managers. These transactions are considered exempt party-in-interest transactions under ERISA. The Plan allows participants to take loans against their account balances, which also qualifies as an exempt party-in-interest transaction.

**NOTE 8 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter from the IRS on the pre-approved plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
