As described in note 2 to the financial statement, the Plan sponsor approved a Plan merger during the period ended September 5, 2024. As a result, the Plan transferred all of its assets into the Tenet Healthcare Corporation 401(k) Retirement Savings Plan effective August 31, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

1. PLAN DESCRIPTION

The following description of Healthcare Partners Investments, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General - The Plan was established on March 1, 1997 and restated on May 7, 2012. The Plan is a defined contribution plan covering substantially all employees of The Physicians’ Group, L.L.C.; Healthcare Partners Investments, LLC; Community Hospital, LLC; TPG Hospital, LLC; and HPI Physicians, LLC (collectively the “Employer”) who have completed three months of service and are age 18 or older. Part-Time employees of The Physicians Group, L.L.C. whose regularly scheduled service is less than 1,000 hours and whose job assignments do not exceed 90 days are excluded effective January 1, 2010. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions and Forfeitures - Participants may make contributions during the plan year through regular payroll deductions limited by provisions of the Internal Revenue Code and adjusted periodically for increases in the cost of living. Participants satisfying eligibility requirements are automatically enrolled in the Plan with a 3% deferral rate. Participants may elect to modify the deferral amount or decline to defer under the Plan by entering into a salary reduction agreement with the employer. When participants have (a) attained the age of 18, and (b) met the three months of eligibility service requirement, they become eligible to receive Employer’s matching contributions. Matching Employer’s contributions are made in an amount equal to 50% of participants’ elective deferrals to a maximum of 8% of such participants’ compensation.

The Employer’s contributions totaled \$973,814 for the period ended September 5, 2024. The non-vested portions of participant account balances are forfeited when a participant leaves the Plan and used to reduce Employer’s matching contributions or pay administrative fees of the Plan. Forfeited non-vested accounts totaled \$250,294 for the period ended September 5, 2024. During 2024, employer contributions were reduced by \$287,762 from forfeited non-vested accounts.

Participant Accounts - Each participant’s account is credited with the participant’s contributions and allocations of the Employer’s matching contributions and plan earnings and charged with the allocation of administrative expenses.

Vesting - Participants are immediately vested in their elective deferral contributions, plus the earnings thereon. Participants become vested in the Employer’s matching contributions, and the earnings thereon, at retirement age, as defined in the Plan, or in the event of death or disability.

Prior to participants’ retirement age, the Employer’s matching contributions become vested as follows:

Payment of Benefits - Participants who separate from service and whose value of all vested accounts is \$1,000 or less will have the value of their vested accounts distributed to them in a lump sum. If the vested account balance is greater than \$1,000 but less than \$5,000, the participant may elect to receive a lump sum distribution or make a rollover distribution. If the vested account balance exceeds \$5,000, the participant may elect to delay receiving the distribution until normal retirement age. If participants die before receiving a distribution of their accounts, the full amount of their accounts will be paid to their designated beneficiaries.

Notes Receivable from Participants - Notes receivable represent loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Loans are made available to all qualifying participants. A participant may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. The repayment period of any loan will be no more than five years unless any such loan is for the purchase of a participant's primary residence. The loan is secured by the balance in the participant's account and bears interest at rates specified in the plan agreement. Principal and interest are paid through payroll deductions.

Investment Options - Under enrollment in the Plan, a participant may direct employee contributions among investment choices in increments of 1 percent. Participants may change their investment options on any normal business day.

2. PLAN MERGER

During the period ended September 5, 2024, the Physicians Group, LLC and Tenet Healthcare Corporation approved the merger of the Plan into Tenet Healthcare Corporation 401(k) Retirement Saving Plan (the "Tenet Plan") effective August 31, 2024. Participant contributions were no longer allowed as of the effective date of the merger. Participants were notified of the intent to merge the Plan and were provided options for requesting distributions including cash, transfer funds into the merged plan, or rollover to another qualifying plan or an individual retirement account. As a result, all investments totaling \$87,673,916 were transferred into the Tenet Plan as of September 5, 2024. The Plan did not incur any significant costs with regards to the Plan merger.

3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of shares in underlying funds are recorded on a settlement date basis, which is generally trade-date plus one. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan’s management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent events - The plan administrator has evaluated subsequent events through April 16, 2025, the date the financial statements were available to be issued.

4. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by John Hancock Life Insurance Company or its affiliates. John Hancock Life Insurance Company is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

5. FAIR VALUE MEASUREMENTS

The Plan measures fair value in accordance with accounting standards that establishes a fair value hierarchy based on the observability of inputs used to measure fair value. These inputs are summarized in the three broad levels listed below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

In many cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The pooled separate accounts under the John Hancock group annuity contract are valued at the net asset value (“NAV”) of units held by the Plan at year end as provided by John Hancock. The NAV is based on the fair value of the underlying mutual funds owned by the fund which have publicly quoted pricing inputs adjusted for management fees prior to setting the daily unit value.

The unit value of the pooled separate account is based upon significant observable inputs, although it is not based upon quoted market prices in an active market. The observable inputs are unadjusted quoted prices for identical assets in an active market, which is defined as a market in which transactions take place with sufficient frequency and volume to provide pricing information on an ongoing basis. The underlying investments of the pooled separate accounts consist solely of mutual funds, each of which follows a separate investment strategy.

In accordance with accounting standards, the pooled separate accounts held by the Plan are not classified in the fair value hierarchy table because they are measured at NAV per share.

The Plan’s guaranteed interest accounts are not considered fully benefit responsive. The fair value of the guaranteed interest accounts is measured by comparing the rates in effect on a specific date to the

rates on which the actual interest is determined and adjusting the book value based on the difference. Daily rates are published and applied to both new deposits and to the calculation of fair value, constituting an active market (Level 1 inputs).

Furthermore, while the Plan’s management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. DETERMINATION OF TAX QUALIFICATION

The Internal Revenue Service has determined and informed the Employer by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan’s management believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan’s management believes it is no longer subject to income tax examinations for years prior to 2021.

7. INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA permits the Plan’s management to limit the procedures performed by the Plan’s independent public accountants with respect to assets that are held by the Plan when the custodian has

provided the Plan’s management with, and certified the accuracy of, a statement of those assets. Accordingly, the Plan’s independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

The following amounts, have been provided and certified as complete and accurate by John Hancock Life Insurance Company as of September 5, 2024, and December 31, 2023 and for the period ended September 5, 2024.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for Plan benefits.
