## Independent Auditor's Report

To the Plan Administrator and Participants  
of the Total Quality Maintenance, Inc. Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Total Quality Maintenance, Inc. Profit Sharing Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

#### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Total Quality Maintenance, Inc. Profit Sharing Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan that was established on October 1, 2000 by Total Quality Maintenance, Inc. ("the Company" or "Plan Administrator") covering all eligible employees of the Company as defined in the Plan agreement. Certain classes of employees as defined in the Plan agreement are excluded from plan participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

A Plan Committee ("the Committee") manages the operation and administration of the Plan, including the appropriateness of the Plan's investment offerings and investment performance. The Company has contracted with The Standard Insurance Company ("Standard") to act as custodian and recordkeeper to process and maintain certain records of participant data. A third-party administrator ("TPA") provides certain plan services. Certain company personnel serve as plan trustees.

The provisions of SECURE 2.0 Act of 2022 continue the themes and reforms that began with the 2019 SECURE Act. Certain provisions of both Acts have been implemented by the Plan and the Plan Administrator will continue to determine provisions which will impact the operation of the Plan. Participants should refer to plan documents for any changes made to the Plan.

**Contributions** - Each year, participants may contribute an amount of eligible pre-tax annual compensation as defined in the Plan agreement, not to exceed the maximum statutory amount. The Plan allows for ROTH deferral contributions. Participants who are age 50 or older can elect to make catch-up contributions to the Plan, not to exceed the maximum statutory amount. Participants may also contribute amounts representing distributions from other qualified eligible plans.

The Plan allows for an employer safe harbor matching contribution subject to certain eligibility requirements. For the year ended September 30, 2024, the Company contributed a safe harbor matching contribution equal to 100% of the participant's elective deferrals not to exceed 3% of the participant's eligible compensation, plus 50% of the participant's elective deferrals between 3% and 5% of the participant's eligible compensation. The Company's safe harbor matching contribution was \$135,644 for the year ended September 30, 2024 of which \$146 was receivable as of September 30, 2024 and was paid in 2025.

The Plan also allows for an employer discretionary matching contribution and an employer discretionary non-elective contribution subject to certain eligibility requirements; none were made for the year ended September 30, 2024.

**Participant Accounts** - Each participant's account is credited with the participant's contribution, the Company's safe harbor matching contribution, the discretionary matching contribution (if any), an allocation of the discretionary non-elective contribution (if any), plan earnings and losses, and plan expenses as applicable to the Plan. Allocations of the discretionary non-elective contribution are based on employee classification. Allocations of plan earnings and losses are based on individual participant investment choices. All contributions/investments are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are 100% vested in their contributions, rollover amounts and safe harbor matching contribution, plus actual earnings thereon. Vesting in the discretionary matching contribution and discretionary non-elective contribution and earnings is based on years of credited service as follows: less than 2 years – 0%, 2 years but less than 3 years – 20%, 3 years but less than 4 years – 40%, 4 years but less than 5 years – 60%, 5 years but less than 6 years – 80% and 6 years or more – 100%. Participants become fully vested in the event of death, disability, retirement age, or plan termination.

**Notes Receivable from Participants** - Notes receivable from participants are not permitted in the Plan.

**Payment of Benefits** - Upon the satisfaction of certain distributable events, participants or their beneficiaries may elect to receive their vested account balance and are paid in accordance with plan provisions.

**Forfeited Accounts** - Forfeited accounts can be used to restore forfeitures, reduce employer contributions, reallocated to eligible participants or pay plan expenses.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts

of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition*** - Investments are reported at fair value except for fully benefit-responsive investments which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by Standard. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions*** - Contributions from plan participants and employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

***Excess Contributions Payable*** - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability. As of September 30, 2024 and 2023, there were no excess contributions payable.

***Plan Expenses*** - For the year ended September 30, 2024, some plan fees were paid by the Company and these amounts are excluded from the Plan's financial statements. Investment/fund fees, certain participant transaction fees, annual plan administration fees, investment broker fees, and TPA fees are paid by the Plan and charged to participant accounts as applicable.

***Payment of Benefits*** - Benefits are recorded when paid.

***Subsequent Events*** - The Plan has evaluated subsequent events through April 29, 2025, the date the financial statements were available to be issued.

### NOTE 3 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably

possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 4 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at September 30, 2024 and 2023, interest and net appreciation in fair value of investments for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Standard.

### NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

**Level 2** - Inputs other than quoted prices include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of September 30, 2024 and 2023.

**Pooled Separate Accounts:** Units held in the Plan's pooled separate accounts under the Plan's contract with Standard are valued using a net asset value ("NAV") method similar to a mutual fund NAV calculation. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a pooled separate account is calculated based on a compilation of primarily observable market information. The number of units of the fund that are outstanding on the calculation date is derived from observable purchases, and redemption activity in the fund. The Plan invests in the custodian's pooled separate accounts, which invest in various types of securities. The NAV is used as a practical expedient to estimate fair value for the funds. This practical expedient would not be used if it is determined to be probable that the funds will sell the investments for an amount different from the reported NAV. For the pooled separate accounts under the Plan's contract with Standard, there are no unfunded commitments and the units can be redeemed daily. The contract can be liquidated with a 60 day discontinuance written notice sent by the Company to Standard. A market value/liquidation charge may apply upon termination of the contract. At this time, the Plan Sponsor does not intend to terminate its contract with Standard.

### NOTE 6 - GUARANTEED ACCOUNT

The Minnesota Life Guaranteed Return Account is invested in the general assets of Standard. General assets are predominately fixed income investments. The fund is considered fully benefit responsive. As of September 30, 2024 and 2023, the fund is reported at contract value which approximates fair value.

The fund's value does not fluctuate daily with the investment markets. Standard guarantees the principal amount and pays a stated rate of interest. The guarantees are based on the financial strength and claims-paying ability of Standard. Because the fund guarantees the preservation of principal and accrued interest, Standard assumes the market risk associated with the investment of these assets. To assist in managing this risk, the following transfer restrictions apply: transfer restrictions may exist for transfers out of the fund to any competing investment option. Currently the Plan has no competing investment options. The fund's minimum crediting rate under the contract is 1.50%. At this time, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with Standard or with participants. There are no unfunded commitments and daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions. There are no reserves against contract value as of September 30, 2024 and 2023.

### NOTE 7 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Plan investments are held by Standard. Any purchases and sales of these investments are performed in the open market at fair value or contract value. Plan related fees are paid to Standard, an investment brokerage firm, and the TPA. The Plan has other service providers. All these transactions, while considered party-in-

interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

### **NOTE 8 - PLAN TERMINATION AND/OR MODIFICATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **NOTE 9 - TAX STATUS**

The Plan adopted a non-standardized pre-approved plan which received an opinion letter dated June 30, 2020 from the IRS. The Plan has been amended since, however, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.


