Basis for Opinion

NOTE A - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The audited financial statements of the Operation Homefront 401(k) Plan (the “Plan”) are maintained on the accrual basis in accordance with U.S. generally accepted accounting principles.

Recognition of Income: The basis of investments held by the Plan is adjusted annually to closing market value and unrealized gains and losses are recorded as part of this adjustment. Realized gains and losses on investments are computed using adjusted basis (beginning of year market value). Security transaction expenses are considered in computing realized gains and losses on investments.

Investments: Investments in separate accounts are reported at fair value at year end based on quoted prices of the underlying securities. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded on the accrual basis and are considered in the determination of the net asset value. Gains and losses (realized and unrealized) are reported in net appreciation (depreciation) in fair value of investments in the statement of changes in net assets available for benefits.

The stable value fund is a general account investment contract held with the insurance company and is reported at contract value, which represents contributions plus credited interest, less participant withdrawals and administrative expenses. Contract value is the relevant measure for participant transactions, as it is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Concentration of Credit Risk: Concentration of credit risk with respect to separate accounts is reduced as a result of the diversity of the underlying investments.

Payment of Benefits: Benefit payments are recorded when paid.

Subsequent Events: Subsequent events have been evaluated by management through the date of the independent auditor’s report. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

New Accounting Pronouncements: Management is not aware of any new accounting pronouncements that have been released, and are not yet effective, which will have a significant impact to its financial position or results of operations in future periods.

Use of Estimates: The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

NOTE B - DESCRIPTION OF THE PLAN

The following description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: Operation Homefront 401(k) Plan (the "Plan") is a defined contribution plan covering virtually all employees of Operation Homefront, Inc. (the Plan Sponsor) who have at least three months of service and are age 21 or older. The Plan is for the exclusive benefit of its participants and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Amended and Restated: The Plan was restated effective January 1, 2023, to include an auto-enrollment provision.

Plan Termination: Although it has not expressed intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Contributions: Participants may contribute compensation up to the amount allowed by law, as defined in the Plan, on a pre-tax and after-tax basis. Participants direct the investments of their contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions ("rollovers") from other qualified plans. The Plan sponsor makes safe harbor contributions to eligible participants who have reached age 21 and have completed at least three months of service not to exceed 4% of the employees' deferral. The Plan sponsor may make discretionary and profit-sharing contributions as defined by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

Participant Accounts: Each participant's account is credited with their contribution and allocations of a) the Plan Sponsor contributions, b) plan earnings, and c) charged with an allocation of administrative expenses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are 100% vested at all times in their voluntary contributions, employer safe harbor contributions, nonelective employer contributions and actual earnings thereon.

Payment of Benefits: Benefits may be paid upon severance of employment, death, or disability. Mandatory distributions are required for terminated participants with an account balance less than \$5,000. Upon attainment of age 65, a participant may withdraw his or her vested account balance for any reason in a lump sum payment or installments based on required minimum distributions. In-service distributions may be taken at age 59½ from accounts that are fully vested. A participant may delay their distribution but must begin distributions once they reach age 72. Early retirement date is not permitted.

Administrative Expenses: The Plan's administrative expenses are paid either by the Plan or the Plan Sponsor as provided in the Plan document.

NOTE C – INVESTMENTS CERTIFIED BY THIRD PARTY (unaudited)

As permitted by Department of Labor CFR 2520.103-8, investments at December 31, 2024 and 2023 and the related investment earnings for the years then ended, were certified and held by Voya Retirement Insurance and Annuity Company, the Plan custodian and were not audited by the independent auditor.

NOTE D - TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan's administrative expenses are paid either by the Plan or the Plan Sponsor as allowed by the Plan document. Expenses paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE E – STABLE VALUE FUND

The Plan holds a fully benefit-responsive group funding agreement, the Voya Fixed Account, with a balance of \$95,089 and \$152,907 as of December 31, 2024 and 2023, respectively. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The agreement provides a fixed account that is contractually obligated to repay the principal plus a specified minimum interest rate guaranteed to the Plan.

Because the fixed account is fully benefit-responsive, it is reported at contract value, which represents contributions made under the contract, plus credited interest, less participant withdrawals and administrative expenses. Contract value is the relevant measurement for participant transactions, as it reflects the amount participants would receive upon permitted withdrawals under the Plan.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) full or partial plan termination, (2) insolvency of the Plan Sponsor, or (3) aggregate withdrawals exceeding 20% of the contract value in a single contract year. The Plan Administrator does not believe any such events are probable of occurring.

NOTE F – INCOME TAX STATUS

The Plan operates under a non-standardized adoption agreement in connection with a pre-approved specimen plan sponsored by Loren D Stark Company, which received an opinion letter dated November 30, 2020 that stated that it had received favorable determination that the Plan qualifies under applicable sections of the Internal Revenue Code. The Plan has not been amended since receiving the determination letter. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management is not aware of any tax positions that would have a significant impact on its financial position. Its federal tax returns for the last four years remain subject to examination.

NOTE G - FAIR VALUE MEASUREMENTS

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

NOTE G - FAIR VALUE MEASUREMENTS - continued

The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in inactive markets
 - inputs other than quoted prices that are observable for the asset or liability
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means
 - if the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in methodologies used to measure fair value, nor transfers between levels. Following is a description of the valuation methodologies:

Pooled Separate Accounts: Investments held in pooled separate accounts are reported at fair value of the underlying mutual funds based on quoted market prices in active markets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are subject to a range of risks including interest rate, market, and credit risks. Market risks may include global or domestic events such as inflationary pressures, interest rate volatility, geopolitical tensions, or supply chain disruptions that could impact the value of investment securities. Given the level of uncertainty in financial markets, it is at least reasonably possible that changes in the values of these securities will occur in the near term and could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
