## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
The College of Saint Rose 403(b) Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The College of Saint Rose 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 30, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to November 30, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 30, 2024 and December 31, 2023, and for the period from January 1, 2024 to November 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 1 to the financial statements, the Plan's Board of Trustees approved a plan of liquidation on March 8, 2024, and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the accrual basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 — DESCRIPTION OF PLAN**

The following description of The College of Saint Rose 403(b) Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The College of Saint Rose (“College”) previously maintained two separate 403(b) plans: The College of Saint Rose Defined Contribution Plan (“DCP”) and The College of Saint Rose Tax-Deferred Annuity Plan (“TDA”) until January 1, 2009 when the College combined these two plans into one restated plan which was known as The College of Saint Rose 403(b) Retirement Plan (“Plan”). The Plan had a salary reduction component, 403(b), and also a supplemental component covering all employees of the College. Through July 31, 2020, the salary reduction portion of the plan was open to faculty and administrators who had one year of service and were age twenty-one or older, referred to as DCP participants. Effective August 1, 2020, the Plan was amended to allow participation by collective bargaining (union) and hourly employees. The supplemental portion of the Plan was open to all regular employees of the College on their date of hire, referred to as TDA participants. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Teachers Insurance and Annuity Association (TIAA) was the Plan’s recordkeeper, and together with College Retirement Equities Fund (CREF) (collectively “TIAA”) was the insurance company issuer of the annuity contracts to the Plan.

Effective July 28, 2024, the Plan was terminated and all Plan assets have been liquidated as of November 30, 2024.

**Contributions**

Each year, participants were able to contribute up to 100% of pretax annual compensation, as defined in the Plan. Roth contributions were also permitted for TDA participants. DCP participants were able to begin making contributions after one year of service and age twenty-one or older, unless the individual was previously employed and participated in a retirement plan at another institution of higher education, in which case the individual would be eligible to participate in the DCP plan immediately. Through July 31, 2020, mandatory Employee Contributions of 5% of eligible compensation were required once a DCP eligible employee reaches the age of 30 and after 3 years of service. Effective August 1, 2020, the Plan was amended to eliminate mandatory employee contributions and to permit discretionary non-elective contributions to be allocated pro rata as a uniform percentage of employee compensation for eligible employees. There was no mandatory contribution requirement for TDA classified employees. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants who had worked at least 15 years for a qualified organization, were eligible to make special catch-up contributions, as defined in the Plan. Participants were also able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan.

TDA participant contributions were not matched by the College. The discretionary non-elective contribution was 3% for DCP participants. Contributions were subject to certain Internal Revenue Service (“IRS”) limitations.

**Participant Accounts**

Each participant's account was credited with the participant's contributions and allocations of the College's contribution, if any and plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings and account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

**Vesting**

Employees were 100% vested in all contributions.

**Plan Loans**

Plan loans were issued as separate contracts by TIAA as contemplated under IRC section 72(0)(5) and did not represent plan assets. Loans were collateralized using a participant's TIAA Traditional account balance in an amount equal to 110% of the outstanding loan balance. The maximum a participant could borrow was the lesser of \$50,000 or 45% of his or her TIAA Traditional account balance subject to annuity contract and plan provisions. Loan terms ranged from one to five years in one-year increments. Principal and interest was paid by the participant directly to TIAA and each payment reduced amounts collateralized by the borrowing participant's TIAA Traditional account balance.

Plan loan balances outstanding from participants to TIAA were \$0 and \$48,732 as of November 30, 2024 and December 31, 2023, respectively.

**Notes Receivable from Participants**

Participants were able to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined quarterly, was set at 1% above the prime rate, as defined. Participants had the ability to elect to pay principal and interest through monthly payroll deductions.

**Payment of Benefits**

Upon retirement or disability, and depending on the relevant funding vehicle contract, the forms of benefit that were available under the funding vehicle contract included, but were not limited to: lump sum, installments, single life annuities, joint and survivor annuities, fixed period annuities, and any other annuity and withdrawal option as provided under the funding vehicle contract.

In-service distributions were also able to be made from the Plan, these distributions were made from a participant's vested account balance. Withdrawals from a participant's salary deferral account (excluding earnings) were made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Withdrawals from a participant's account were also able to be made upon reaching age 59½, in accordance with the provisions specified in the Plan.

**Payment of Benefits** (Continued)

For the period January 1, 2024 to November 30, 2024, benefit payments includes distributions made on behalf of plan participants. With the plan termination, all plan assets have been distributed to plan participants based on their preferred distribution option (lump sum, rollover or individually owned annuity accounts), or, if a plan participant did not make a specific distribution election, the participant's vested account balance was transferred to an Individual Retirement Account (IRA) account with Inspira Financial for the participant. See Note 5 for additional information.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan were prepared on the accrual basis of accounting.

As a result of management's decision to terminate the Plan as described in Note 1, the Plan changed its basis of accounting from the accrual basis to the liquidation basis for the period January 1, 2024 to November 30, 2024. The liquidation basis of accounting presents assets at amounts expected to be realized in liquidation and liabilities at amounts expected to be paid.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investments Valuation and Income Recognition**

The Plan's investments were reported at fair value (except for fully benefit-responsive investment contracts which were reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold and held during the year.

Fixed annuity contracts are TIAA Traditional Annuity contracts (TIAA Traditional Annuity) that are unallocated fixed annuity contracts that are fully and unconditionally guaranteed by TIAA. TIAA Traditional Annuity within liquid contracts are benefit responsive. TIAA Traditional Annuity within illiquid contracts are non-benefit responsive. TIAA Traditional Annuity provides a guarantee of principal, a guaranteed minimum rate of interest (generally 3%, but in some contracts between 1% and 3%) and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the "declaration year," which begins each March 1. Additional interest is not guaranteed for future years. Contributions to a participant's account purchases a guaranteed amount of lifetime annuity income. When a participant's account in the TIAA Traditional Annuity is annuitized based on available options, the present value of the stream of payments is equal to the account balance. Certain contract types contain liquidity restrictions on the redemption of TIAA Traditional Annuity accumulations, which could impact the value realized upon exiting the contract.

**Investments Valuation and Income Recognition (Continued)**

TIAA Traditional Annuity, Benefit Responsive were valued at contract value. Because the annuities were fully benefit responsive, contract value was the relevant measurement attribute.

TIAA Traditional Annuity, Non-Benefit Responsive were reported at contract value, which approximates fair value.

The fair value of the registered investment companies were equal to the net asset value reported by the funds of the shares or units held.

**Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

All administrative expenses are paid by the Plan. Plan expenses primarily consist of recordkeeping fees and other general administrative fees. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

In preparing these financial statements the College has evaluated events and transactions for potential recognition through April 24, 2025, the date the financial statements were available for issuance.

**NOTE 3 — INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA, as the insurance companies of the Plan and as agent of TIAA Trust Company, have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of November 30, 2024 and December 31, 2023, and the schedule of assets held at end of year as of November 30, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the period January 1, 2024 to November 30, 2024.

**NOTE 4 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2024 and December 31, 2023.

**Fixed Annuity Contracts, Non-benefit Responsive:** Fixed annuity contracts, non-benefit responsive, are reported at contract value which approximates fair value. The contract value of the TIAA Traditional equals the accumulated cash contributions and interest credited to the Plan's contracts, and transfers, less any withdrawals and transfers. The TIAA Traditional is not available for sale or transfer on any securities exchange, accordingly, transactions in similar investment instruments are not observable.

**Registered Investment Company Accounts:** Shares are valued at the net asset value of shares held by the Plan at year end. The net asset value is based on quoted market prices in active markets.

**Real Estate Pooled Separate Account:** A pooled separate account investment is valued daily at the net asset value of the units held, and is comprised of investments in the TIAA Real Estate Account (REA), an insurance company separate account of TIAA investing mainly in real estate and real estate-related investments. This is a variable annuity. The REA's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on professional's opinion. Unit values are calculated each day. Units are available for transactions at the closing unit value on any day the New York Stock Exchange is open for business. Transfers out of the account are limited to one per calendar quarter.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Realized and unrealized gains are included in net appreciation in the fair value of investments on the statement of changes in net assets available for benefits. Earnings are included in interest and dividends on the statement of changes in net assets available for benefits. Inter-fund transfers represent participant elections to move invested balances from one investment option to another.

**NOTE 5 — PLAN TERMINATION**

The College has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

On March 8, 2024, in conjunction with the College closing, the College's Board of Trustees adopted a resolution to terminate the Plan effective July 28, 2024. As of November 30, 2024, all plan assets have been distributed to plan participants based on their preferred distribution option (lump sum, rollover or individually owned annuity accounts), or, if a plan participant did not make a specific distribution election, the participant's vested account balance was transferred to an IRA account with Inspira Financial for the participant.

**NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed by TIAA. TIAA is the Plan's record keeper and insurance company which holds plan assets and executes investment transactions and is the issuer of the annuity contracts of the plan and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

**NOTE 7 — TAX STATUS**

The IRS has determined and informed TIAA by a letter dated August 7, 2017 that the volume submitter plan adopted by the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the advisory letter. However, the Plan Administrator believes that the Plan was designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan was qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 — RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
