INDEPENDENT AUDITORS' REPORT

Opinion

We have audited the financial statements of the CAL NECA Health Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for plan benefits and statements of plan benefit obligations as of July 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits and changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

Basis for Opinion

NOTE 1 - Description of the Trust Plan

N.E.C.A. West Health and Welfare Trust Fund (the “Plan”) was created on August 1, 1977 under an agreement between signatory chapters of the National Electrical Contractors Association (N.E.C.A.) and participating N.E.C.A. contractors for the purpose of establishing a plan (N.E.C.A. West Health and Welfare Plan) to provide health and welfare benefits to eligible participants. At the October 5, 2011 Trustees meeting the Trustees voted to change the name of the organization to CAL NECA Health Trust.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan documents include detailed rules for each situation. Participants should refer to the Plan agreement regarding specific provisions of the Plan.

Participation

The following individuals are eligible to participate in the Plan:

- a. Eligible contractors and their permanent full-time office and technical employees who work 30 hours or more per week and are not members of a collective bargaining unit.
- b. N.E.C.A. representatives and eligible staff members of N.E.C.A. chapters who work 30 hours or more per week.
- c. Retirees eligible for Medicare who worked in either of the foregoing categories for a period during which contributions were made to the Plan.
- d. Other industry related organizations’ employees sponsored by a N.E.C.A. chapter and approved by the Board of Trustees.
- e. Spouses and dependent children of eligible participants.

NOTE 1 - Description of the Trust Plan (Continued)

Eligibility

Initial eligibility is established by the employer. Coverage may be immediate or there may be a waiting period as long as 90 days.

Benefits

The Plan provides medical, vision, prescription drug, dental, life and accidental death and dismemberment insurance benefits to participants.

Insured Benefits

The Plan offers various health plans that participants can choose. The Plan maintains and purchases annual insurance contracts for these insured benefits. Premiums for all insured benefits are paid from the assets of the Trust.

Funding

The Plan is maintained for active employees by monthly contributions from N.E.C.A. chapters, N.E.C.A. contractors and other industry related organizations sponsored by a N.E.C.A. chapter and approved by the Board of Trustees. The entire cost of retiree benefits is funded by monthly contributions from the retirees. The contribution rates vary, depending upon insurance coverage selected by the participants.

Administrative Expenses

The Plan pays all administrative expenses of the Plan, including management fees, administration fees, cost of investment, insurance, printing and postage, legal fees, etc.

Plan Changes

Plan benefits consists of the benefits available under various group insurance policies. Accordingly, Plan benefits may change as insurance carriers are replaced.

NOTE 1 - Description of the Trust Plan (Continued)

Plan Termination

The Board of Trustees may terminate the Plan at any time subject to the Trust Agreement and applicable Collective Bargaining Agreements.

Upon termination of the Trust, all obligations shall first be satisfied. The Board of Trustees shall thereupon use the remaining Trust assets to provide Plan benefits in such manner as the Plan may provide, or in the absence of a Plan provision, to continue to provide Plan benefits in a manner permitted by ERISA for so long as Trust assets permit.

NOTE 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Employer Contributions

Employers and participants must submit contributions monthly for continued eligibility. Contributions are due by the 15th of the month prior to the month of coverage.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and Cash Equivalents

Cash and cash equivalents include all monies in banks and highly liquid investments with original maturity dates of three months or less. The carrying value of cash and cash equivalents approximates fair value due to the short maturities of those financial instruments.

NOTE 2 - Summary of Significant Accounting Policies (Continued)

Tax-Exempt Status

No provision for Federal or state income tax is made. The Plan has received tax-exempt status from the Federal Government under Internal Revenue Code Section 501(c)(9) and the State of California under the Revenue and Taxation Code Section 23701i. The Plan's most recent favorable determination letter from the Internal Revenue Service was dated June 4, 1979.

Subsequent Events

In preparing the financial statements as of July 31, 2024, management considered the impact of subsequent events occurring through May 8, 2025, the date the financial statements were available to be issued, for potential recognition or disclosure in these financial statements.

NOTE 3 - Concentration of Credit Risk

Cash equivalents include money market accounts used in general operations.

Concentration of credit risk for cash:

For business purposes, the Plan maintains cash balances at Bridge Bank, which exceed the \$250,000 insurance provided by the Federal Deposit Insurance Corporation. The amount in excess of the \$250,000 insurance limit as of July 31, 2024 was \$1,259,607. The Plan has not experienced any losses in such accounts. The Plan management does not believe the Plan is exposed to any significant credit risk on cash.

NOTE 4 - Health Reimbursement Arrangement (HRA) Benefits

The Plan provides health reimbursement arrangement (HRA) benefits to eligible participants. A participant's account balance is funded by employer contributions and allows participants to be reimbursed for eligible out of pocket health benefits incurred. Included in the accompanying statement of net assets are amounts available to provide health reimbursement arrangement (HRA) benefits as of July 31, 2024 and 2023, totaling \$137,471 and \$114,345, respectively.
