Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Schottenstein Stores Associates' Benefit Plan #SS2 (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and of benefit obligations as of July 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended July 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the Schottenstein Stores Associates' Benefit Plan #SS2 (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established by Schottenstein Stores Corporation and affiliated companies (the Company) effective January 10, 1976, to provide comprehensive health and welfare benefits to eligible employees (and, where applicable, their enrolled eligible dependents). The Plan allows participants to elect from a number of available coverages and benefits provided through separately established welfare plans, so as to create a program to fit their specific needs.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Certain plan assets are held in a Voluntary Employees' Beneficiary Association (VEBA) trust.

Eligibility

The Plan provides benefits to eligible employees and their dependents. Participation in the Plan by eligible employees is voluntary. The Plan covers substantially all full time and part time employees who are regularly scheduled to work 28 or more hours per week. Employees are eligible the first day of the first month after completing 30 days of service.

Benefits

The benefits provided by the Plan include medical, pharmaceutical, dental and vision benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). The Plan does not provide for any post-retirement benefits. The Plan earns rebates from its service contractors. Rebates totaling approximately \$2.7 million for 2024 have been netted against payments of claims in the accompanying Statement of Changes in Net Assets Available for Benefits.

Insured Benefits

The Plan insures certain dental and vision benefits. The claims for insured benefits are processed by the plan's third-party claims processors. The claims processors pay claims directly to or on behalf of participants.

Contributions

The costs of the Plan are shared by the Company and the Plan's participants. Participating employees contribute a portion of their wages into the Plan through pre-tax payroll deductions. Employee contributions are calculated and set by the Plan administrator for each of the various Plan benefit coverage options. Participants make annual elections of the Plan coverage options during the open enrollment period offered by the Company.

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured medical benefits (individual claims over a specified dollar amount, as well as its aggregate exposure for all claims).

Self-Insured Benefits

The Plan self-insures certain medical and pharmaceutical benefits. The claims for self-insured benefits are processed by the plan's third-party claims processors. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan's VEBA trust.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Premiums paid for insurance coverage and benefits paid on behalf of participants are recorded when paid. Claim payments are recorded when paid by the third-party claims processors. Amounts due to claims processors that have yet to be reimbursed by the plan are recorded as payable to claims administrators in the benefit obligation, as disclosed below.

Administrative Expenses

All administrative expenses are paid by the Plan and are recorded as deductions in the accompanying Statement of Changes in Net Assets Available for Benefits.

Stop-Loss Coverage

Premiums for stop loss insurance are included in payments of premiums to insurance entities in the accompanying Statement of Changes in Net Assets Available for Benefits.

Claims Incurred but not Reported

The Plan's obligation for claims incurred but not reported is estimated based on claims data subsequent to the financial statement date provided by the Plan's third-party claims administrators. The estimate also takes into consideration prior claims experience and the expected time period from the date such claims are incurred to the date that the related claims are submitted and paid. This amount is paid by the Plan only if claims are submitted and approved for payment.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Subsequent Events

Subsequent events were evaluated through May 6, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at July 31, 2024 and 2023.

Money market fund: Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

4. Concentrations

As of July 31, 2024 and 2023, all of the Plan's investments were concentrated in one money market fund.

5. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, PNC Bank, National Association, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of July 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of July 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended July 31, 2024 and the information reported in the supplemental Schedule H, Line 4(j) - Schedule of Reportable Transactions for the year ended July 31, 2024.

6. Related-Party and Party in Interest Transactions

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, any covered expenses which have been incurred prior to the date of termination will be payable in accordance with the terms and conditions of the Plan. Plan assets will first be allocated to the payment of claims, taxes and administration expenses and thereafter in a manner that is for the exclusive benefit of the participants.

8. Tax Status

The VEBA trust that funds the Plan is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, the VEBA trust's net investment income is exempt from income taxes. The VEBA trust has obtained a favorable tax determination letter dated October 2, 1984 from the Internal Revenue Service (IRS), and the plan administrator believes that the VEBA trust is designed and currently being operated in accordance with applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The value of benefit obligations is reported based on claims activity, which is subject to change. Due to uncertainties inherent in the estimation process, it is at least reasonably possible that changes in this estimate in the near term would be material to the financial statements.

The Plan's investment consists solely of a money market fund. Money market funds are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with money market funds, it is at least reasonably possible that changes in the value of the money market fund may occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.
