Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of RPCS, Inc. 401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1. Description of the Plan

General

The following description of RPCS, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all employees of RPCS, Inc. (Company), other than those covered by a separate pension plan, who have at least six consecutive months of service and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Transamerica Financial Life Insurance Company holds the Plan's assets.

Contributions

Participants may contribute to the Plan by making an elective deferral of 1% to 50% of compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company may make a discretionary matching contribution on behalf of all participants. This contribution will be equal to a percentage of participants' 401(k) elective deferrals up to 6% of compensation. The Company made no discretionary matching contributions in 2024 and 2023. Contributions are subject to certain Internal Revenue Code limitations.

Participant Investment Account Options

Investment account options available include various funds. Participants have the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts plus earnings thereon is based on years of credited service. A participant is fully vested after five years of credited service. The nonvested balance is forfeited upon termination of service. Forfeitures may be used to pay plan expenses and reduce employer contributions. During 2024 and 2023, there was no forfeiture activity and the Plan had no forfeiture account balances.

Notes Receivable from Participants

In the case of financial hardship, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the federal prime rate in effect on the date the loan is made plus 1%. All loans are repayable over a period not to exceed five years except for loans for the purchase of or repair of a primary residence.

Payment of Benefits

Upon termination of service, an employee may elect to receive either a lump-sum amount equal to the value of their account, installments, partial payments, or form of annuity as defined. If a participant does not elect a distribution method and the vested balance does not exceed \$1,000, the participant will automatically receive a lump-sum payment. Withdrawals for reasons other than terminations are permitted under circumstances provided by the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Pooled separate accounts are valued at estimated fair value as provided by Transamerica Financial Life Insurance Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. A loan will be in default and treated as a deemed distribution if the participant fails to make a payment by the last day of the calendar quarter following the calendar quarter in which the loan payment is due. A participant's loan repayments may be suspended during a period of unpaid authorized leave of absence up to a maximum of 12 months. If the leave of absence extends beyond 12 months, the participant must start making loan payments beginning after the 12th month or the due date of the last installment, whichever comes first. A defaulted loan remains an outstanding debt payable to the Plan and must still be fully repaid, unless a distributable event occurs such as termination of employment, retirement, etc., whereby the loan can be distributed.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Insurance Company

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica Financial Life Insurance Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA required supplemental schedule is complete and accurate.

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such employer or employee association, or relatives of such persons.

The Plan invests in certain funds of Transamerica Financial Life Insurance Company. The Plan paid \$33,724 and \$39,742 of direct expenses to Transamerica Financial Life Insurance Company during 2024 and 2023, respectively. Expenses paid directly to Merrill Lynch Life Agency, Inc., the Plan's investment advisor, totaled \$13,352 and \$12,467 in 2024 and 2023, respectively. Certain other plan fees are included in net appreciation in fair value of the investments, as they are paid indirectly. The plan sponsor pays certain accounting and auditing fees relating to the Plan and provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows. Level 2 securities include pooled separate accounts. The pooled separate accounts are valued at net asset value (NAV) of units based upon quoted market prices of the underlying mutual fund investments. NAV is a readily determinable fair value and is the basis for current transactions which may occur daily. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 6. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a pre-approved profit-sharing plan document sponsored by Transamerica Retirement Solutions, LLC. This pre-approved plan document has been filed with the appropriate agency and obtained a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service. Therefore, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and the Plan was qualified and the related trust was tax exempt as of the financial statement date.
