## INDEPENDENT AUDITOR'S REPORT

To the Benefits Administration Committee of the  
Buck 401(k) Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Buck 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period of January 1, 2024 to July 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 31, 2024 and December 31, 2023, and for the period of January 1, 2024 to July 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter**

As discussed in Note 1 to the financial statements, the Plan was merged into the Arthur J. Gallagher & Co. Employees' 401(k) Savings and Thrift Plan effective August 1, 2024. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - PLAN DESCRIPTION

The following description of the Buck 401(k) Savings Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General - The Plan was a defined contribution plan available to all employees of Buck Global, LLC (the Company), except for nonresident, leased, part-time, temporary or seasonal employees, as well as those employees covered by a collective bargaining agreement or whose principal place of employment is Puerto Rico. There was no age or service requirement, and eligible employees could enter the Plan on first date of hire. The Plan was administered by the Company and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Benefit Committee administered the Plan and was responsible for Plan operations. During 2023, the Company was acquired by Arthur J. Gallagher. Effective January 1, 2024, the Plan was amended and frozen to new entrants and all contributions. The Plan merged into Arthur J. Gallagher & Co. Employees' 401(k) Savings and Thrift Plan, a plan sponsored by Arthur J. Gallagher effective August 1, 2024.

Contributions - Prior to January 1, 2024, participants could contribute up to 75% of pretax annual compensation, as defined by the Plan. Participants could also make after-tax contributions. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions in accordance with, and subject to, certain Internal Revenue Service (IRS) limitations. Participants could also contribute amounts representing distributions from other qualified plans (rollovers). Participants directed their contributions to various investment options offered by the Plan. The Company made safe harbor matching contributions of 100% of the participants' elective deferrals up to 5% of eligible compensation. Additionally, the Company could make discretionary profit-sharing contributions to the Plan as determined annually. Any such profit-sharing contributions would be allocated based on participant's compensation as compared to total compensation for all participants. There were no such contributions for the Plan period ended July 31, 2024 and the year ended December 31, 2023.

Participant Accounts - Each participant's account was credited with the participant's contributions and allocations of (a) the Company's contribution; (b) Plan earnings. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants were vested immediately in their voluntary contributions, employer safe harbor matching contributions and rollover contributions plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contributions was based on years of continuous service. Vesting in the Company discretionary profit-sharing contributions was as follows:

In the event of total and permanent disability or death, the participant would become fully vested.

Notes Receivable from Participants - Prior to January 1, 2024, participants could borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. Loan terms ranged up to five years or longer for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bear interest at the prime rate plus one percent. Principal and interest were paid ratably through payroll deductions through December 31, 2023. Effective January 1, 2024, the Plan was frozen, and no new loans were issued. The notes receivable from participants of \$1,092,680 was included in the net asset transfer to the Arthur J. Gallagher & Co. Employees' 401(k) Savings and Thrift Plan.

Payment of Benefits - Benefits were payable upon retirement at age 65, death, disability or termination of employment. Hardship withdrawals and in-service withdrawals at age 59-1/2 were also permitted, subject to provisions described in the Plan document. Withdrawals from after-tax contributions were permitted at any time. Benefits were payable in the form of rollovers, lump-sum payments or installments. If withdrawing participants were not entitled to their entire account balance, the amounts not received were forfeited.

Forfeited Accounts - Forfeited balances of terminated participants' nonvested accounts could be used to pay Plan expenses or reduce Company safe harbor matching contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by management in the preparation of the accompanying statements of net assets available for benefits and related statement of changes in net assets available for benefits and the related notes to the financial statements (financial statements) follows:

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based on the terms of the Plan document. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to recordkeeping, the administration of participant accounts and notes receivable from participants and distribution administrative fees are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events - Management has evaluated subsequent events through May 5, 2025, the date that the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Collective Trust Funds - Public and private investment vehicles valued using the NAV provided by the administrator of the fund. The NAV is based on the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV is a calculated price based upon inputs other than quoted prices that are directly or indirectly observable. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

As of July 31, 2024, all investments were transferred to the Arthur J. Gallagher & Co. Employees' 401(k) Savings and Thrift Plan. The following table set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31:

NOTE 4 - TRUSTEE CERTIFICATION (UNAUDITED)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements including investments and notes receivable from participants held at July 31, 2024 and December 31, 2023, net appreciation in fair value of investments, interest and dividend income and interest income on notes receivable from participants for the period ended July 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (Voya), the trustee of the Plan.

NOTE 5 - TAX STATUS

The Plan has been designed under the provisions of a Voya Retirement Insurance and Annuity Company Defined Contribution Prototype Plan and Trust, which has received a favorable opinion letter from the IRS dated June 30, 2020. The letter states that the form of the Plan is qualified under the Section 401 of the Internal Revenue Code (IRC), and the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain the qualification. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of July 31, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Should the Plan incur penalties and interest related to unrecognized tax benefits, such amounts would be recorded in administrative expenses. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

All Plan investments were managed and held by Voya, trustee as designed by the Plan; therefore, these transactions qualify as party-in-interest. In addition, participant loans were considered party-in-interest transactions, since these participants had a vested interest in Plan assets. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. Certain administrative functions were performed by officers or employees of the Company at no cost to the Plan. These transactions qualify as exempt party-in-interest transactions.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan's participants invested in securities offered by the Plan that were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
