- 5 All Participants are eligible to retire upon the later of attainment of age 62 and 5 years of Participation.
- 6 Vesting Schedule is 3-year cliff, as follows:

0% if less than 3 Years of Service
100% if 3 Years of Service or more

1,000 Hours of Service in a Plan Year is required for 1 (One) Year of Vesting Service for that Plan Year. In accordance with Federal Regulations, Participants become fully vested upon reaching their Normal Retirement Date. In addition, a Participant becomes fully vested upon death while an Employee.
- 7 Upon Normal Retirement, a Participant will be entitled to a benefit payable in the normal form which is equal to the Actuarial Equivalent of the Hypothetical Account Balance, the accumulation of Principal Credits plus the sum of Interest Credits for each future Interest Credit Period through the Participant's Normal Retirement Age (or current age, if later).

Principal Credits and Interest Credits are credited to his/her account at the end of each Plan Year.


