## INDEPENDENT AUDITOR'S REPORT

To the LCPA 403(b) Committee and Plan Administrator  
Lincoln Center Tax Deferred 403(b) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Lincoln Center Tax Deferred 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

**1. DESCRIPTION OF PLAN**

The following description of Lincoln Center Tax Deferred 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Lincoln Center for the Performing Arts, Inc. (Lincoln Center, or the Plan Sponsor) under the provisions of Section 403(b) of the Internal Revenue Code (IRC) for the benefit of its employees, to provide future financial security through a combination of personal savings and current tax savings. The Plan is known as a 403(b) Tax Deferred Plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The original effective date of the Plan was January 1, 2010, with an amendment and restatement effective July 1, 2023. The Plan includes employees of Lincoln Center for the Performing Arts, Inc. (LCPA) and Lincoln Center Development Project, Inc. (LCDP). Effective August 1, 2023, employees of LCPA and LCDP who were employed before July 1, 2017, whose benefit was frozen as of July 31, 2023 under The Lincoln Center Pension Plan, are granted immediate eligibility for employer contributions under the Plan.

Plan Administration

The 403(b) Plan Committee, as designated by the Executive Committee of the Board of Directors of Lincoln Center, administers the plan and is responsible for carrying out the Plan's provisions.

Under the terms of the service agreement between Lincoln Center and Voya Retirement Insurance and Annuity Company (Voya), Voya provides recordkeeping and administrative services with respect to the Plan. Voya performs these functions at the direction of the Plan administrator and Voya Institutional Trust Company serves as the custodian of the Plan.

Eligibility

All employees of participating entities are eligible to make elective contributions to the Plan. For non-elective and matching employer contributions, eligibility is subject to certain service and other requirements, with entry dates for eligible employees each January and July 1. Generally, non-union, full-time employees of participating entities hired after July 1, 2017, who are ineligible to participate in The Lincoln Center Pension Plan, qualify for employer contributions after completing one year of service. Effective July 1, 2023, all eligible employees are able to begin receiving employer contributions on the first day of the month following one year of service.

Contributions

Participants may make tax-deferred elective contributions to the Plan as soon as administratively feasible after their hire date, effectively the first day of the next payroll, subject to the limitations of the IRC. Participants age 50 or older or who attain age 50 during the Plan year may make a “catch-up” contribution as defined by the IRC.

Participants may also elect to transfer, or rollover, balances from other qualified plans.

Employer contributions are made to the Plan for eligible Lincoln Center employees hired on or after July 1, 2017. Employees receive nonelective contributions equal to 3% of eligible compensation, and a discretionary matching contribution, currently 50% of employee contributions of up to 4% of eligible compensation, subject to a vesting schedule.

Vesting and Forfeitures

Participants are fully vested in their contributions and earnings thereon. Effective July 1, 2023, amounts attributable to employer contributions vest after two years of service. Prior to July 1, 2023, amounts attributable to employer contributions vested after three years of service.

As of June 30, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$2,943, respectively. These amounts will be used in accordance with the applicable plan provisions. During the plan years 2024 and 2023, forfeitures of \$8,198 and \$0, respectively, were used to reduce employer contributions.

Participant Accounts

Individual accounts are valued daily and maintained for each of the Plan’s participants to reflect the participant’s contributions, as well as employer contributions on the participant’s behalf, if any, and the participant’s share of the actual earnings (losses) incurred by the funds in which the account balance is invested. Participants may transfer amounts between investments or allocate their future contributions to one or all of the investment options offered under the Plan.

Benefits

Participants are eligible to receive all or a portion of their vested account balance resulting from participant tax-deferred elective, employer nonelective, and employer discretionary matching contributions upon reaching 59½ years of age, the termination of their employment, upon becoming disabled, or upon incurring a hardship if certain criteria is met, as disclosed below.

Benefits (Continued)

Benefits are payable upon retirement under the following options: (a) lump sum; (b) installment payment; (c) flexible payment option or (d) the minimum distribution option which complies with federal tax law distribution requirements.

Participants who terminate employment prior to retirement may elect to have their balance distributed in a lump sum or transferred to an individual retirement account (IRA) or another employer's qualified plan. Death benefits are paid according to the benefits election in effect at the time of death.

Hardship Withdrawals

Under certain conditions, participants, while still employed by the Plan Sponsor, are permitted to make hardship withdrawals. A "hardship withdrawal" is a withdrawal made for an "immediate and heavy financial need," such as: to pay unreimbursed medical expenses, to prevent eviction or foreclosure from the participant's principal residence, or to pay other costs which the Internal Revenue Service (IRS) may define as causing an "immediate and heavy financial need."

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to the lesser of: 1) a maximum of \$50,000 or 2) 50% of the value of the vested interest in their Plan account attributable to salary deferral and rollover contributions. Participants can have two loans outstanding at any time. Loans used to purchase a primary residence may have a repayment period of no more than fifteen years. Loans for all other purposes must be repaid within five years. The interest rate on participant loans is determined based on rates for comparable commercial loans, defined as the prime rate as stated in The Wall Street Journal plus 1%.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America (US GAAP) and requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The LCPA 403(b) Committee determines the Plan's valuation policies utilizing information provided by the investment adviser, custodian, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest less amounts defaulted (if any). Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are excluded from these financial statements. Loan administration and distribution fees are charged directly to the participant's account and are included in administrative expenses. The Plan also pays certain investment advisory and plan administration fees from plan assets. Certain investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

Recent Accounting and Regulatory Pronouncements

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended June 30, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and awaiting additional regulatory guidance from the IRS and DOL. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan year ended June 30, 2024 and 2023. The Plan will be amended to reflect any changes made in response to SECURE 2.0 prior to the deadline set by law or applicable regulations.

**3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets,
- b. Quoted prices for identical or similar assets or liabilities in inactive markets,
- c. Inputs other than quoted prices that are observable for the asset or liability,
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Mutual funds:* the Plan utilizes net asset value reported by the funds and quoted market prices. The net asset value is an unadjusted quoted price on an active market and classified within Level 1 of the fair value hierarchy.

*Fixed income fund:* the Fixed Plus Account credited interest option offers stability of principal and credits interest on amounts allocated to this option. Amounts invested in the Fixed Plus Account are held in the Plan's general account that supports insurance and annuity obligations. Interests in the Fixed Plus Account have not been registered with the US Securities and Exchange Commission (SEC) in reliance on exemptions under the Securities Act of 1933, as amended. The safety of the interest rate guarantees under the Fixed Plus contract is dependent upon the Plan's claims-paying ability. The guarantees do not apply to the investment return or principal under the mutual funds. The investment is classified as Level 2 of the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. CERTIFICATION OF FINANCIAL INFORMATION**

The financial data included in the accompanying financial statements as of and for the years ended June 30, 2024 and 2023 and supplemental schedule of assets (held at end of year) as of June 30, 2024, has been certified as complete and accurate by Voya, a qualified institution. The following certified information was obtained by management and agreed to or derived from information certified as complete and accurate; and has not been audited by the independent auditors for the Plan: investments at fair value, notes receivable from participants, net appreciation (depreciation) in fair value of investments, interest and dividends, other income, and interest on notes receivable from participants.

**5. PLAN TERMINATION**

Although it has not expressed any intent to do so, Lincoln Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as Lincoln Center may determine.

**6. TAX STATUS**

The volume submitter plan sponsor has obtained an opinion letter dated March 31, 2017, in which the IRS stated that the restated volume submitter plan document was in compliance with applicable requirements of the IRC. The Plan has not received a determination letter specific to the Plan itself and has been amended since the date of the opinion letter; however, the plan administrator believes that the Plan was designed, and is being operated, in compliance with the applicable requirements of the IRC.

US GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by Voya, the Plan's custodian; therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative expenses were paid by the Plan or the Plan Sponsor. The Plan issues loans to participants, which are secured by the vested balance in the participants' accounts. These transactions qualify as party-in-interest. Employees of the Lincoln Center provide administrative services to the Plan for which no fees are charged.

In addition, the Plan Sponsor receives revenue sharing amounts from the custodian pursuant to an agreement. Total amounts received from the custodian and used to offset expenses during the years ended June 30, 2024 and 2023 were \$23,551 and \$0, respectively. Total amounts remaining at June 30, 2024 and 2023 were \$8,438 and \$10,667, respectively, to be used in the future.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**9. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through May 5, 2025, which was the date that these financial statements were available for issuance and determined that there were no significant nonrecognized subsequent events through that date.
